**6. PUBLIC ENTERTAINMENT LICENCE HOLDER - PAPER 'C'**

The Committee considered a Public Entertainment Licence where the holder had recently been convicted of an offence.

**Resolved:** That a Severe Warning be issued to the holders of the Public Entertainment Licence.

**7. THE HALFWAY HOUSE, ST ANNES ROAD - APPLICATION FOR GRANT OF PUBLIC ENTERTAINMENT LICENCE**

The Sub-Committee considered an application for a Public Entertainments Licence in respect of the Halfway House, St Annes Road.

It was reported that the applicant had amended the application so that the terminal hour was now 11pm rather than 12Midnight on Thursday to Sunday. It was noted that in light of this amendment the objection had been withdrawn.

**Resolved:** That the application for a Public Entertainment Licence in respect of the Halfway House, St Annes Road be granted for the hours of Monday to Saturday 11.00am to 11.00pm and Sundays 12.30pm to 11.00pm.
