Asset Based Community Development - uniquely linked with Area Forums?

What makes Area Forums meetings different from local PACT groups or Neighbourhood Watch gatherings?

Being involved in all three of these community organisations I have often found it hard to distinguish between them - and other public assemblies of a similar nature. However my eyes were opened at our January 2015 Gateway Area Forum when the invited guest from the Council's Public Health department(Liz Petch) demonstrated the undeniable link between good mental and physical wellbeing and community engagement of a sort offered by our Forums.

People whether unemployed retired of even homeless *reference the Bridge project can help themselves and their community to become a better place. Area Forum Community Representatives Consultation meeting regarding the 2015/2016 Budget proposals

Mr Mark Towers, Director of Governance and Regulatory Services explained that the purpose of the consultation meeting was to receive feedback from the Area Forum Community Representatives on behalf of their respective Area Forums. He reminded the Representatives that it in order to meet Blackpool Council's required budget savings of £25 million during the financial year 1 April 2015 to 31 March 2016, it had been proposed to cease the Area Forum budgets from 1 April 2015, amounting to approximately £150,000.

Mr Towers reported that feedback from a number of consultation meetings would be considered by the Executive, including the comments from this meeting and the statement made by a number of Community Representatives following their meeting on 12 January 2015. The Executive would then make its recommendations to Council at its meeting on 23 February and the budget for 2015/2016 would then be agreed at the Budget Council meeting on Friday 27 February 2015.

Mr Towers explained to the Community Representatives that the proposal was for the cessation of the Area Forum budget and not the Area Forum meetings.

Mr Towers read the statement, referred to earlier in the meeting that had been signed by some Community Representatives from various Forums.

Therefore we respectfully request the assistance of Blackpool Council in seeking out and applying for Community Grant Funding on our behalf. So that we can continue to put 'people first' in Blackpool.

Finally, we would have a preference for a substantial reduction in our funding in the first year rather than a complete cessation of it. However, we again recognise the painful and difficult decisions facing the Councillors and Council Officers, and we desire to work together to with them keep the Forums alive and contributing towards the greater good of Blackpool".

The meeting supported the statement and the proposal to reduce the Forum funding as opposed to the complete cessation and suggested an amount of between £30,000 and £50,000. It was put forward by one of the community representatives that the funding could be shared between the seven Forums and used to match fund projects with a limit of £500 per applicant.

The Representatives felt that the cessation of the funding in its entirety would negatively affect enthusiasm within the voluntary community, at a time when there should be support and encouragement for community engagement. It was believed that the involvement in community projects had a positive impact on individuals' physical and mental health.

In response to a question, Mr Towers confirmed that a decision had not been taken nor a proposal made regarding the outstanding funds following the last cycle of Area Forum. He added that it was unlikely that a decision would be taken prior to April 2015.

A Revoe Community Representative reported that without the support from Area Forum funding it would not have been possible to establish the local Choir, which now had 40 members and was self-sufficient.

It was explained that if the decision was taken to reduce the Forum funding (rather than cease completely) then the difference would still need to found elsewhere from the Council's budget to meet the required level of savings.

A member of the Group asked if funding for other voluntary groups supported by the Council would cease. Mr Towers explained that grants to voluntary organisations had ceased following previous year's budget savings, he added that the majority of the associated cost for supporting the Area Forums related to staffing costs and this next year had resulted in two redundancies from the Community Engagement Team and Democratic Governance.

In response to several questions regarding the consultation exercise, Mr Towers explained that the Community Representatives had been informed as soon as the proposal was within the public domain and prior to the last cycle of Forum meetings. He added that he had tried to be as inclusive and proportionate to the level of savings and the impact. It was suggested that a spokesperson from the Community Representatives could attend the Executive meeting on 23 February to present the Area Forums viewpoint and suggest the alternative proposal.

Mr Towers advised the Group that there were Local Elections on 7 May and the structure of the Council would be agreed at the Annual Council meeting on 22 May, at which stage the Committee, Partnerships and Forums structure etc. would be agreed. He explained that both Democratic Governance and Community Engagement would support the Council's wishes in relation to the Area Forums, but he could not make any commitments for the future, until the outcome of the elections and the wishes of the Council were known.

In response to a question, Mr Towers confirmed that the Councillors ward budget had been reduced in previous years from £25,000 per ward in 2010 and it was proposed to retain the budgets at £15,000 per ward for 2015/ 2016.

The statement, mentioned earlier in the meeting was circulated to allow other Community Representatives the opportunity to show their support by signing the document.

It was proposed, seconded and unanimously agreed by the Area Forum Community Representatives present that Mr Dave Blacker MBE, would be the spokesman for the Area Forums and he would submit an application to speak at the Executive meeting on 23 February 2015.

The meeting closed at 6.20pm

1 Executive Summary

- There were 143 responses received to the Blackpool Council budget consultation between 9 January and 8 February 2015
- A range of services were identified as areas where savings could be made, either through ceasing or reducing the service. The most common service cited is the free breakfast scheme in schools.
- Respondents suggested a number of efficiencies that could be made in the delivery of services across the Council, including reducing duplication and prioritising getting things right first time.
- There is a sense from some respondents that the Council is wasting money on unnecessary projects and developments in Blackpool, particularly around the Promenade area.
- Some comments indicated opportunities for the Council to generate income in order to reduce the required level of savings. This included charging for services such as meeting spaces and the illuminations, as well as selling unused properties and land like car parks.
- A range of suggestions were received in relation to the way the organisation is run. This includes salary levels, staffing and councillor structures, employee terms and conditions and expenses.
- A host of other comments and suggestions were received, the most notable being making best use of the voluntary sector and communities to deliver services and taking a stronger stance on benefit fraud and the enforcement of fines.

2 Approach

A public consultation in early 2015 gave residents and stakeholders of Blackpool the opportunity to suggest how the Council could make savings. As this was an open-access consultation Council employees were also able to submit a response.

It allowed respondents to comment on how the Council might be able to reduce spending or increase income over the coming years. The purpose of the consultation is to help the Council make decisions when the budget is set at the end of February 2015.

An online survey was available on the Council's website and was promoted via the Council's Facebook and Twitter accounts. Paper copies were distributed to all libraries and children's centres in the Borough and promoted within. The survey asked for the respondent's top three savings suggestions, followed by a final opportunity to provide any other ideas or comments.

The consultation ran from Friday 9 January 2015 to Sunday 8 February 2015. A total of **143 responses** were received, 71 online and 72 paper returns.

This report attempts to summarise some of the main comments and suggestions received in the consultation, with any example comments reported verbatim. The full set of responses can be found in the Appendix in alphabetical order.

3 Findings

A wide range of comments and suggestions were provided in the consultation. Figure 2.1 below groups together the main topic areas that these comments covered. The chart is based on the actual number of comments received, not percentages, given the size of the sample. Also it is to be noted that one respondent often provided more than one suggestion, therefore the total number of suggestions within the chart exceeds the sample base of 143 responses.

3.1 Service suggestions

Suggestions relating to service reductions or the redesign of services were the most common grouping within the consultation. Some offered suggestions relating to specific services whereas others were more general statements about the reduction of service across the Council. Service-specific suggestions included:

- "School crossing patrols and road safety advice are absolutely non-essential functions"
- "Libraries close small branches amalgamate them into 2 big libraries Palatine and Central - look at making smaller libraries into community libraries"
- "Scrap all area forums"

The most common service identified as a potential saving within the consultation is the free breakfast scheme in schools. 20 of the 143 survey responses suggested this scheme be ceased or reduced:

- "Stop wasting money in providing children breakfast at school"
- "Free breakfast and lunch for school children. Stop giving them out. Children should be fed at home, it's a parents responsibility"

Several respondents used the opportunity to highlight services they find valuable and would like to see protected from any savings. In particular the Connexions service was highlighted by some as an important service to the Borough:

- "Without [the Connexions] service, I would have had nowhere to go and both my sons would be unemployed in this deprived resort"
- "Blackpool has some of the most vulnerable and disadvantaged youth people in the country and yet they are set to lose yet another valuable, well used and quality service"

40 of the 143 responses suggested ways in which existing services could be delivered more efficiently by the Council. A number of these comments referred generally to ensuring duplication is avoided and delivery is right first time:

- "Think there could be better co-ordination between services & it appears sometimes there is a "lot of duplication""
- "Spend money on quality products, e.g. road surfacing so they do not need replacing every couple of years."
- "Get planning decisions right first time then you don't have to make costly changes."

3.2 Projects and developments

38 respondents to the consultation suggested that the Council should stop investing money in projects and developments across the Borough or focus on different areas.

Several comments specifically referred to the Promenade area of the town:

- "Stop Focusing on the prom and focus on the side streets of Blackpool"
- "Stop spending on luxury items to look at like promenade balls etc."

Other wide ranging comments relating to projects and developments in Blackpool include:

- "The Council can stop wasting money on stupid projects like hiring bikes."
- "Stop wasting money making big changes to road junctions that turn out to be very dangerous. Statues that no-one cares about. Think things through."
- "Do not borrow money to build another hotel in an unsuitable area in the town"

A number of comments also referred to unnecessary statues and monuments in the Borough:

- "Stop making silly monuments e.g. Statues."
- "Stop spending money on pointless statues/eyesores on prom."

3.3 Income opportunities

26 suggestions were made about possible income opportunities for the Council. In the main these related to charging for services and maximising the potential of existing facilities and services:

- "Sell off the car park on Devonshire Road for housing / business"
- "Charge businesses for the Illuminations"
- "Consolidate office space in the new offices and perhaps look at renting out unused space"
- "Stop paying somebody to take away hard core from rubbish tips. You can sell it"

3.4 Organisational suggestions

A range of suggestions were received relating to a host of organisational issues.

21 comments indicated that the level of expenses available to officers and councillors should be looked at. Specific suggestions included:

- "Stop Town Hall expenses put limit on it"
- "Stop all biscuits, coffees and such for all council "meetings""
- "Too many receipts and expenses being claimed back"

A number of suggestions were made around reducing staffing levels and senior management salaries at the Council:

- "Re-assess management structure throughout council especially in leisure services"
- "The higher earners should take a substantial pay cut"
- "Reduce middle management. Far too many"

Additionally some suggested that employee terms and conditions should be reviewed, specifically:

- "Another couple of days unpaid leave"
- "Cut to a 35 hour week"
- "Robust attendance policy to reduce sick pay"

Moreover, some comments identified the number of councillors within Blackpool as an opportunity to make some savings for the Council:

- "Reduce Councillors from the 2 per ward to 1 per ward make savings that way on allowances"
- "I don't think Blackpool needs a Mayor! The cost of Mayor's functions and a car seem to be extravagant is a time of cuts and closures"
- "One councillor per ward."

3.5 Other suggestions

Numerous other suggestions were given as to how the Council can make savings in the coming years. This includes making better use of and empowering communities, rationalising Council properties across Blackpool and taking a stronger stance on benefit fraud and the enforcement of fines. Comments include:

- "More use made of the volountary organisations & churches. Development of a "skilled based community" so that when for example general maintenance / works is needed the community can fix it"
- "Try to encourage residents to take ownership of the area they live in and take responsibility for litter etc."
- "Cut back on building and buying into properties, keep offices to a minimum"
- "Actively pursue all monies owed to the council in arrears of payments due"
- "Enforce dog bye laws, with fines, in all parks where they apply"

4 Appendix - All Comments

4.1 Suggestion 1

A better balance of expenditure for tourists and Blackpool families.

A fair cut across services (so no one is losing out)

A more secure way of improving roads and pavements, using the money available to improve - better quality first time rather than going back over & over again

Accept more donations of books to libraries

Actually consult the consumers when deciding on: Mayor issues. ie:- multi million pound road/ tram/ Promenade schemes. As they are the people changes affect and this will too if it will work.

1. A time and motion study of ALL staff. Regular and routine checking, without notice. There are council staff who work incredibly hard for there money and deliver a service, not efficiently, under very difficult circumstances. There are staff however who earn an awful lot of money for not doing very much. When out on official business fitting in shopping and lunch with girls. 2. Delivering an effective and efficient service in the first place then individuals would not be taken up with redoing or going back over. 3. Blackpool Council has an appalling reputation amongst the local residents. It is a very unapproachable, uncaring, abrupt council which shows no understanding, no compassion and no heart. The letters that our sent out are always rude, offensive, curt and usually incorrect 4. By becoming people friendly the council would have the residents supporting them 5. Delivering high quality services in the first place. 6. Do an actual paying job of work instead of talking

A lot has money is wasted by people not doing jobs properly. For example the roads (including the Prom) where there are constant repairs.

Abolish 20mph zones and sell off all 20mph signs for scrap

All take pay cuts. Sack the staff who are not producing the goods. (I could give you a full list after my experience).

As you can probably tell, I am one of the unfortunate ones who have already been told they are to loose their job, and as I haven't worked for the council for 12 months, I am NOT entitled to any support, I won't get re deployed, and I won't get any redundancy pay. I have five children and am the main earner in my family, as a result of me loosing my job, we have no choice but to claim benefits, until I find another job with similar pay In the sector i am trained for. Ironically ...when you total up the amount of money the benefits will amount too, you will actually be worse off. And not just you but my family will be too. I will have no choice but to access free school meals, my rent is £200 per week, my council tax, oh and the school uniform voucher system for five children... Basically what i am saying is when you are laying people off to save money, maybe you should check that laying that person off will save£'s. [CONTACT DETAILS REMOVED]

Can I please point out that the council DO NOT currently have any youth workers or youth clubs. I have heard that you are now trying to 'get rid' of the Connexions Service. Is there going to be ANY service available to young people. Blackpool has some of the most vulnerable and disadvantaged youth people in the country and yet they are set to lose yet another valuable, well used and quality service. I have had personal experience of this service when my daughter needed advice and support on a range of her problems. She was unemployed misusing drugs and being an out of control teenager. We are supportive family who has never had to use 'services'. However after my daughter getting involved with a bad crowd she became a little out of control. She went to Connexions for advice on going to college. She was offered her own adviser who 'worked miracles'. Helping her over a few months and she is now working part time and is on a foundation degree. Thank you Connexions

Cemntralise services for councillor consultations with the public. Make it quicker easier to contact the council (eg promoto feedback boxes). Encourage community Pride and

involvement.

consider where 20 mph signs are placed a small road off paddock drive maybe 60metres long a 20mph sign erected ???

Cut all un-necessary spend, including travelling, refreshments, buffets, no free parking, garage mayors car.

Cut benefits helping working family's.

Cut travel expenses, cease all non-essential services (there are lots that people don't have the political will/balls to cut), cease area forums, reduce engagement budget (many events attract the same old faces and offer no value)

Deliver services differently. At the moment, the council has not not modernised and is still heavily people focused. Embrace and use technology.

dont. Blackpool needs money investing not cutting. The people (already doing the jobs of three people). Need pay rises. The coastal housing service needs money (experienced first hand the need for this). Stop wasting money on private tenants that make stupid complaints about cats and paying for sonic devices. Wasted money!!

Employ helpful people at Bristol Ave tip, actually allow people to tip their rubbish therefore reducing fly tipping - reducing the amount spent by the council collecting & cleaning up fly tips.

Everyday at Park school there are lots and lots of tyaxis dropping kids off and picking them up, our neighbour also has there disabled child collected and delivered every day ... most of these families especially the disabled ones have motability transport, why do they need extra ttransport at our cost! Look at cutting these costs yearly so save money.

From my simple viewpoint, it seems like this and previous council's borrowing has gone out of control. At some point all this money we've borrowed will have to be paid back. When interest rates rise again, which they will, I'm worried that with the level of borrowing continuing we could reach a stage when we can no longer pay it back.

Have greenhouses in all schools and hospitals to grow more of the food our community services need. Have poo powered buses. Allow start up companies to use council owned premises to start trading on a month by month basis with pro rata rates and incentives. These will then grow into bigger businesses to bring in revenue. Think of ways to bring back community pride this will lead to reduction in police costs for a start...

Have illuminations thursday to sunday instead of all week but extend through to christmas I do have a comment regarding planned savings in that the Connexions service seems to be abolished under current plans but is being hidden under the word "synergy". Would be nice for some honesty. Bloomfield resident

I have personally been a part of Blackpool council budget cuts and do recognize it is not easy when savings have to be made. I always felt when I was an employee that I could have made lots of savings and would have appreciated being not only asked but listened to. Ask your empolyees where saving s could be made. Even a few pounds for every little saving is a help.

I have used the Connections service, Market Street over the years for both my children and found I have always received exceptional service. Both of my children have left secondary education, not receiving any career guidance from either school and had no idea what they wanted to do. One went into 6th form and then left as it was the wrong course. My other son could have quite easily and was going down committing an offence, but due to the guidance, patience, 1:1 talks with my son, they put him on the right track and he is now in education again and staying out of trouble, I am pleased to say. Without this service, I would have had no where to go and both my sons would be unemployed in this deprived resort.

I offered central library about 50 books on Egyptian Archeology, but these were refused because some of them may have been out of print! What was wrong with them going into the reference section where they are not removed or loaned out. use your brains!

I think you need to concentrate on small business's make them successful, help the South shore area a better place, like at Christmas i have a hair salon by the the bridge no effort was made for this area but you put a tree in south shore Waterloo road what about by station road

some lights to make it a better AREA . I opened my salon 2 years ago at the age of 21 , i had no funding no help from the Government . i asked Blackpool for a starter booklet on business for health and safety spoke to senior managers of blackpool council to get the things i needed to HELP ME , No HELP was given , i no you have to make cuts but cutting staff , wages , is only making blackpool Go Down HILL , we need to stick together get the acomy moving Again , start thinking of local people's views instead of concentrating on the prom or town center.

If the government watch programmes like Benefits Britain and Poverty Through A Ten Year Old. They would realise the mistakes they are making to British people and the real needy immigrants that live in poverty in our country

If voluntary jobs are available and jobseekers are made to work, then this should be reflected in their jobseeker allowance or the places should give a wage subsidised by the government.

1 CHAIRMAN

It was noted that the Chairman of the Finance and Audit Committee, Councillor Callow would preside over the meeting.

2 DECLARATIONS OF INTEREST

There were no declarations of interest on this occasion.

3 GENERAL FUND REVENUE BUDGET 2015/2016 CONSULTATION WITH TRADE UNIONS

Mr Thompson, Director of Resources, commenced his presentation of the budget by advising that some of the suggestions made by the Trade Unions through a series of meetings held throughout the year had been taken on board.

The extent of the required budget savings over the previous four years was reported as £68m with a requirement for further savings of £58m over the next three years. Mr Thompson explained the extent of the challenges faced in meeting the budget savings since 2010 and that these savings had equated to approximately four times the staffing costs for all back office services.

Mr Thompson reported that a Medium Term Financial Strategy for the next three years had been approved by Executive at its meeting on 19th January 2015. He outlined the key principles of the Strategy which included resourcing of services in line with Council priorities, achieving value for money and efficiency savings and the principle of keeping Council Tax levels as low as possible. The success in securing a significant amount of income through grants was reported. Another key principle of the Strategy was ensuring that risks were identified and mitigated, for example in ensuring sufficient financial reserves, and maximising prudential borrowing. Mr Thompson emphasised the Council's statutory obligation to set a balanced budget.

Mr Thompson went on to report on the increased demand on local services, particularly in relation to Children's and Adult Services. He also explained that the key drivers for the budget were the level of Government funding and the localisation of Business Rates. In relation to Business Rates, he explained that the Council would benefit from large developments such as the Central Business District and The Harbour. There were however concerns regarding the potential level and impact of successful appeals currently being determined by the Valuation Office as the Council would be responsible for contributing 49% towards the settlements.

Mr Thompson reported on other sources of funding which included the Council Tax Freeze Grant. He also advised on the impact of the redevelopment of the social housing provision on New Homes Bonus.

The pressures on the budget in relation to Children's Services and Adult Services were reported. Mr Thompson advised on a review of parking services currently taking place in an attempt to balance accessibility and value for tourists and residents whilst optimising yield for the Council.

Mr Thompson went on to report on the significant reduction in Council staff in the last few years and the increasing difficulty to deliver services as a result. A further reduction of approximately 300 posts was expected in the financial year 2015/2016 and a further estimated reduction of 300 posts in the subsequent two years. He explained the amount of earmarked reserves required year-on-year to meet redundancy payments and associated pension strain and the potential for other options to be considered beyond the financial year 2015/2016. This included the option of applying for a Capitalisation Directive for future staff termination costs which, although not a prudent solution, would be unavoidable in the event of insufficient resources available to meet the costs. Mr Thompson gave assurances that compulsory redundancies would continue to be avoided where possible, however, the enhanced voluntary redundancy payment offered to staff as an incentive to leave voluntarily had been reduced from £5,000 to £3,000 this year due to affordability.

Mr Thompson advised on the key assumptions in the budget which included the national pay award, the continuation of the voluntary five days unpaid leave and non-pay inflation rates. The budget also assumed known changes to the Settlement Funding Assessment and a freeze on Council Tax. The positive impact of low interest rates and the benefits of

short-term borrowing were outlined.

The budget gap for 2015/2016 was £25.2m and although the estimated budget gaps for the two subsequent financial years had been set, there was a risk that these figures could change significantly due to the uncertainty of the level of Government funding for the next two years. The reasons for the budget gap for 2015/16 were provided and these included the increased pressures on both Children's Social Care and Adults Services, the latter which had been impacted by an ageing population, above inflation increases and the cost of domiciliary care staff travel time.

Mr Thompson reported on the savings plan adopted as a result of the expected financial challenges. Priority Led Budgeting would continue, with every service expected to deliver some efficiency savings.

There was a recommendation to maintain the level of working balances at £6m. There was currently a net overspend as at month 9 of approximately £700,000 but it was expected that this figure would reduce further by the end of the financial year. The month-on-month improvement to reduce overspends was reported and although there was an expectation that there would be overspends at year end, it was expected that this would be at an acceptable tolerance level in relation to the gross budget of c. £500m and that working balances would be close to the target of £6m.

Mr Thompson went on to report the components of the Council's spending power, not all of which it had influence over.

The final Local Government Finance Settlement figure for 2015/2016 had been announced in early February and the amount was unchanged from the Provisional Settlement other than £360,000 being provided to maintain the Local Welfare provision following consultation.

Mr Thompson advised that the General Fund Revenue Budget had been considered by Executive at its meeting on 9th February 2015.

Mr Thompson concluded his presentation by referring to the Appendices attached to the report which provided further detail on the budget, the proposed savings, an equality analysis and the assessment of significant risks for the Council and reflected the requirement for the working balances to remain at £6m.

The Chairman invited the Trade Union Representatives to ask questions and respond to the budget presentation.

Unison asked for the reduction in the pay bill as a result of the year-on-year redundancies to be taken into account in the budget. It was acknowledged that this had been and would be the case.

In response to a question from Unison regarding the spending of the New Homes Bonus Grant, Mr Thompson confirmed that initially the Grant had been earmarked for new

homes but out of necessity the funding had subsequently been moved to support the revenue budget. He confirmed that the funding formula was based on the national Council Tax level and confirmed the expectation that, should the funding continue, there could be an increase in the grant following the Queens Park redevelopment and Foxhall project although this was not guaranteed.

Responding to questions regarding the ringfencing of the Public Health Grant, Mr Jack confirmed the expectation that it would continue to be ringfenced in the future but this would be determined by the Department of Health.

Unison questioned the pay rise level of 2.2% and the funding to support this and Mr Thompson confirmed that this reflected the pay rise for a two-year period and had been factored into the Medium Term Financial Plan. Mr Redmond reported that the 2.2% level equated to £1.7m.

Unison asked that their concerns be noted in regard to the enhanced voluntary redundancies only being offered to at risk staff and Mrs McKeogh confirmed that note had previously been taken of Unison's concerns and that further work would be undertaken with the Trade Unions in relation to the scope of voluntary redundancies. Unison requested a breakdown of the number and cost of voluntary redundancies for the previous year.

In relation to questions from Unison regarding the measures taken in relation to the economic downturn, the ongoing work with Lancashire County Council regarding debt restructuring was outlined as were the plans to continue to minimise long-term borrowing.

Responding to questions from Unison regarding the option of applying for a Capitalisation Directive for future staff termination costs, Mr Jack confirmed that the preferred and most viable option would be to build up reserves to meet the redundancy costs.

Unison asked for the plans to achieve the working balance target of £6m to be outlined and Mr Thompson reported that continuing progress was being made in this regard and that it was expected that by the end of the financial year the working balances would be close to the target. Unison questioned the need for high levels of working balances taking into account the reduction in the Council's services and Mr Jack confirmed that it was ever more important that there were sufficient reserves with the challenges ahead and stated that future reductions in the gross budget would be taken into account.

Unison expressed concerns at the lack of specific information on the equality analysis within the budget and Mr Thompson confirmed that each service area would have a specific equality impact assessment.

Mr Thompson agreed to provide information on the organisations that had benefited from voluntary sector grants.

Unison asked about plans for the costs associated with the Assessment and Rehabilitation Centre's staff terms and conditions as they understood that as part of the consultation period this proposal was going to be removed and replaced with an alternative Adult Social Care saving.

Unison raised concerns regarding the impact of Academies and it was confirmed that savings would have to be made due to the significant reduction in school funding received as a result of the conversions to Academies. It was confirmed that specific figures relating to the reduction in funding could be provided if required.

In response to a question regarding outstanding Business Rate appeals, it was confirmed that the Valuation Office currently had approximately £50m of appeals and that the Valuation Office had a target for resolving 95% of appeals by the end of July.

Unison requested further clarity on the Statutory Intervention in Schools and it was confirmed that this was under review and that more information could be provided if required.

Unison questioned the nursery provision provided by the Council and it was confirmed that a review would be undertaken which would consider all options in relation to nursery provision.

Unison requested a further breakdown in the budget gap for 2015/16 as detailed in paragraph 7.1 of the report.

Unison requested the opportunity to provide further written questions on the budget at a later date.

The Chairman thanked the representatives for attending the meeting and provided assurances that their comments would be passed to the Executive for consideration.

The Committee agreed:

- 1. To note the outcome of the consultation with representatives of the Trade Unions.
- 2. To request that the observations from this meeting be forwarded to the Executive for consideration at its meeting on 23rd February 2015.

It was noted that the Chairman of the Finance and Audit Committee, Councillor Callow would preside over the meeting.

2 DECLARATIONS OF INTEREST

There were no declarations of interest on this occasion.

3 GENERAL FUND REVENUE BUDGET 2015/2016 CONSULTATION WITH NON-DOMESTIC RATEPAYERS

Mr Thompson, Director of Resources, commenced his presentation of the budget by reporting on the extent of the required budget savings. The savings required over the previous four years had been £68m with a further requirement for savings of £58m over the next three years. He reported on the significant challenges that the Council had faced as a result of the continued cuts in the Council's budget.

The steps that had been taken to mitigate against the year-on-year reductions in the budget included the adoption of different methods of service provision and the sharing of services with other local authorities. The extent of the reduction in staffing of back office services was reported. Mr Thompson advised of the increasing difficulties in the Council's ability to continue to deliver services in light of the continuing budget cuts and the potential for more radical changes to service provision in the future.

Mr Thompson reported on the localisation of business rates initiative that had been introduced by Central Government with the aim of encouraging economic development. He explained how the changes in the way that the rates were now collected impacted on the budget. He reported on the positive impact on the budget from the new developments such as the Central Business District, Sainsburys and The Harbour. However, the Council's liability in funding 49% of successful business rate appeals determined by the Valuation Office placed a significant pressure on the budget and a requirement for earmarked reserves. The full actual cost would not be known until all appeals had been processed.

Mr Thompson reported on the disproportionate funding cuts for the Council compared with other local authorities in England. He advised that the budget gap for the financial year 2015/2016 was £25.2m and that bridging this gap was a statutory requirement. It was expected that the levels of budget gap for the subsequent two financial years would be approximately £20m and £13m respectively. The latest forecast overspend for the current financial year was approximately £700,000 which was considered to be an acceptable tolerance level within the context of the gross budget of c. £500m. It was expected that the overspends would further reduce by the end of the year which would result in the working balances being closer to the target of £6m.

A reduction in income from car parking, despite the increase in tourism, was reported. This was mainly attributed to the loss of car park sites and increased competition. A review of parking services was underway with the aim of improving accessibility to car parks to attract visitors to the town and promote local businesses, whilst at the same time optimising income for the Council.

Mr Thompson concluded his presentation by providing assurances that one of the Council's key aims was to promote economic development in the town.

The Chairman invited the Representatives from the Non-Domestic Ratepayers to ask questions and respond to the budget presentation.

In response to concerns relating to the impact on the Private Sector from the reduction in Council's budget and staff redundancies, the numerous interventions to mitigate the impact and reduce risk to businesses were reported. These included investment in the transport network, development of the illuminations, investment in tourist attractions and extending the holiday season.

Responding to a question from the Committee, it was confirmed that the small business rate relief had been extended to the financial year 2015/2016 but there were no guarantees that the Government would continue this in the future.

The Chairman thanked the representatives for attending the meeting and provided assurances that their comments would be passed to the Executive for consideration.

The Committee agreed:

- 1. To note the outcome of the consultation with representatives of the Non-Domestic Ratepayers.
- 2. To request that the observations from this meeting be forwarded to the Executive for consideration at its meeting on 23rd February 2015.
