March 2008

Officer Jacqui Harrison visits and finds the business being operated by Emmanuel Luigi Hadi Zerra and further finds issues requiring the service of six improvement notices for poor management of Asbestos, poor management of chemicals, poor management of electrics, poor management of gas systems and equipment and poor maintenance of floors and traffic routes.

September 2010

Officer Jacqui Harrison visits and finds the business being operated by Emmanuel Luigi Hadi Zerra and further finds issues requiring the service of five improvement notices for broken hand rail, poor maintenance of gas systems and equipment, poor maintenance of electrical systems and equipment

and poor management of asbestos.

August 2011

Officer Jacqui Harrison visits and finds the business being operated by Emmanuel Luigi Hadi Zerra and further finds no ventilation operating whilst gas equipment is in use. A written warning is issued.

June 2014

Officer Keith Marsden Visits and finds the business being operated by Emmanuel Luigi Hadi Zerra and finds issue requiring the service of three notices for poor management of gas, electrical systems and equipment.

February 2015

Electricity Northwest visit and disconnect for interference with the meter a case is opened for theft with Scottish Power.

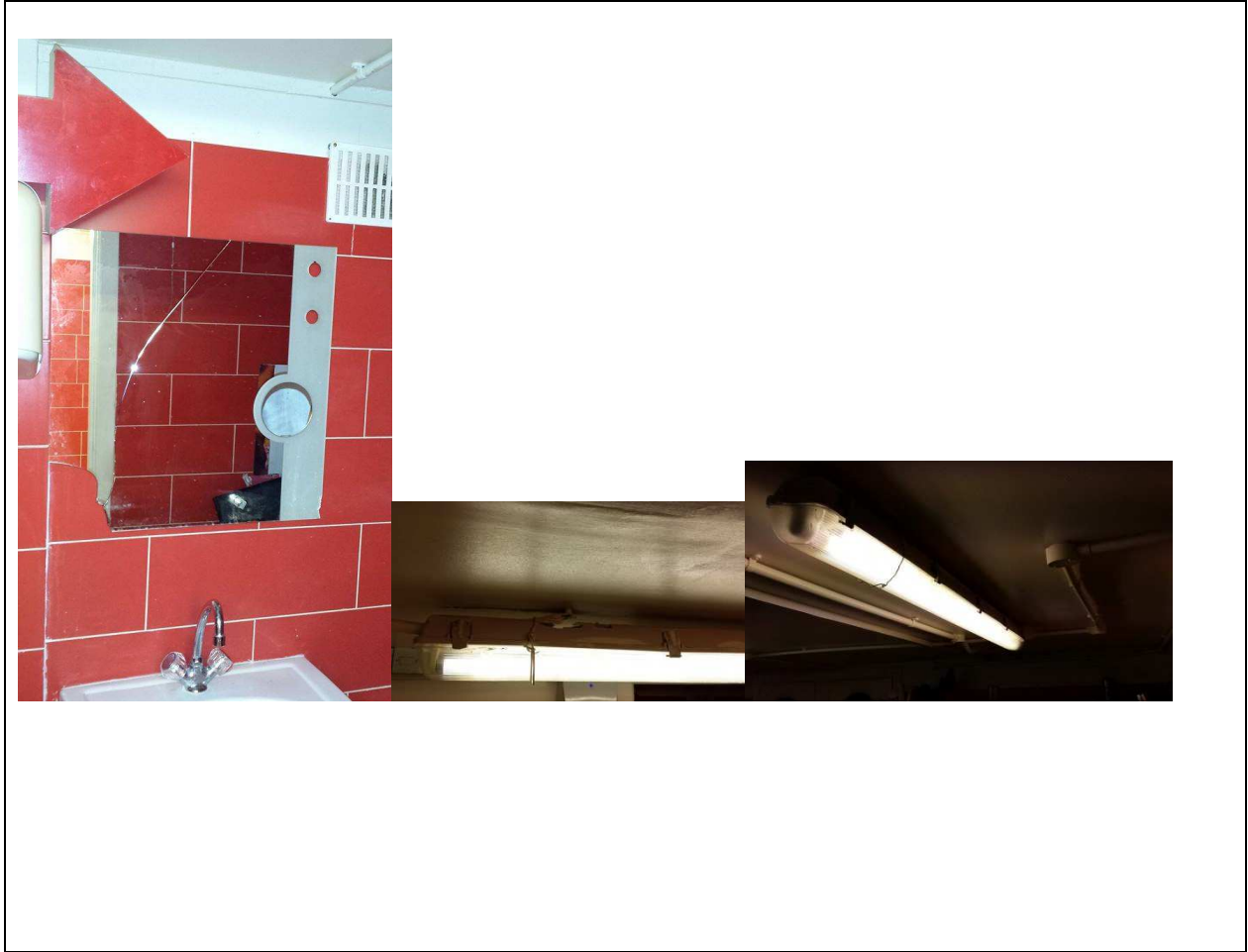
March 2015
