APPLICATION TO REVIEW A LICENCE – MARTON INSTITUTE

1.0 Purpose of the report:

- 1.1 Marton Institute, Oxford Square, Blackpool has the benefit of a Premises Licence permitting the sale of alcohol and provision of regulated entertainment. Alcohol may be sold 11.00 until 02.00. Regulated entertainment is permitted indoors and outdoors 11.00 01.00. The licence holder is Kerry Anne Boyd. The designated premises supervisor is Lynda Newton.
- 1.2 On 30th September 2014, the licensing service received an application to review the licence on the grounds of public nuisance.
- 1.3 The review application was submitted by the Licensing Authority. Representations in support of the licence holder have been received.

4.0 **Background Information**

4.1 Annex 1 - Mandatory conditions

Alcohol

- 1 No supply of alcohol may be made under the premises licence
 - a) At a time when there is no designated premises supervisor in respect of the premises licence,

or

- b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2 Every supply of alcohol under the premise licence must be made or authorised by a person who holds a personal licence.
- The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -

- a. Games or other activities which require or encourage, or are designed to require or encourage individuals to -
 - i. Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii.Drink as much alcohol as possible (whether within a time limit or otherwise);
- Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined by section 159 of the Act);
- c. Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a

- period of 24 hours or less;
- d. Provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependant on
 - i. The outcome of a race, competition or other event or process, or
 - ii. The likelihood of anything occurring or not occurring;
- The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 year of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7 The responsible person shall ensure that
 - a. Where any of the following alcoholic drink is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - i. Beer or cider: ½ pint;
 - ii.Gin, rum, vodka or whisky: 25ml or 35ml; and
 - iii. Still wine in a glass: 125ml; and
 - b. Customers are made aware of the availability of these measures.

Exhibition of films

- 8 Where the film classification body is specified in the licence, unless the following applies, admission of children must be restricted in accordance with any recommendations made by that body
- 9 Where
 - a) The film classification body is not specified in the licence,

or

b) The relevant licensing authority has notified the holder of the licence that this condition is applied to the film in question,

Admission of children must be restricted in accordance with any recommendation made by that licensing authority.

4.2 Annex 2 - Conditions consistent with the Operating Schedule

- 1 No entertainment of an adult nature will take place on the premises.
- The premises operate as a private members club. Guests may attend the premises but must be signed in by a member and pay the entrance fee.
- Non members can attend the premises for open days, private functions and entertainment taking place in the concert room. On these occasions non-members must sign in and pay the entrance fee.
- 4 On New Year's Eve alcohol may be supplied from the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day.
- In the lounge bar children under 16 must be supervised at all times and are only permitted until 20.00 hours. Young people aged 16-17 can remain in the lounge bar after 20.00 hours if they are accompanied by a responsible adult.
- 6 Children under 16 are not permitted in the first floor bar at any time. Young people aged 16-17 can use this room to play snooker as long as they are supervised by a responsible adult.
- Notices will be displayed in prominent positions reminding members and guests to keep noise levels to a minimum when entering and leaving the premises.
- 8 Doors and windows will be kept closed when live bands are performing at the premises to control the escape of noise.
- A door person will be on duty at peak times to check persons entering the premises. Entry will not be permitted to anyone who appears aggressive or drunk. On occasions when no door person is on duty, the committee and staff can view the entrance on CCTV monitors located in the office and behind the bar. Only members can gain entry with their membership card. There is a buzzer at the entrance which allows patrons to talk to and be seen (on CCTV) by the office and bar staff who then decide whether to allow entry to non

members.

- 10 Empty glasses and bottles will be frequently collected from the premises.
- 11 The premises has a health and safety policy that is reviewed regularly.
- Regular checks will be made of the fire alarm system and the electrical equipment in the premises.
- 13 CCTV, which complies with the following criteria, will be installed both inside and outside at the premises:
 - a. The CCTV system shall be installed, maintained and operated to the reasonable satisfaction of Lancashire Constabulary.
 - b. The system shall display on any recording the correct time and date of the recording;
 - c. The system shall be recording during all hours the premises are open to the public;
 - d. VCR tapes or digital recording shall be held for a minimum of 31 days and 21 days respectively, after the recording is made and will be made available to the Police or any authorised persons acting for a Responsible Authority for inspection upon request.
 - e. The system shall, as a minimum, record images of the head and shoulders of all persons entering the premises.
 - f. A staff member who is conversant with the operation of the CCTV system will be on the premises at all times that the premises are open to the public. This staff member will be able to show police, or any officer acting for a Responsible Authority, recent data or footage with the absolute minimum of delay when requested.
- The licence holder shall notify the Police Licensing Unit on any occasion when the CCTV is to be inoperative for a period in excess of one working day and shall provide a certificate from a competent person stating the reason for the system being inoperative and the measures which have been taken to satisfy the licence conditions.
- At least one personal licence holder (whose identity will be known to all other staff engaged in the sale or supply of alcohol) will be available whilst the sale or supply of alcohol is being undertaken, except in the case of emergency.
- 16 The premises will operate a zero tolerance drugs policy.
- Any drugs found shall be confiscated, stored, disposed of or transferred in accordance with procedures agreed with the Lancashire Constabulary.

- 18 Records of incidents involving the use and/or detection of drugs shall be maintained and those records shall be made available to the Police for inspection upon request.
- 19 Security arrangements will be sufficient to discourage the sale and consumption of drugs: such arrangements to include regular checks of toilet areas.
- An authorisation of sales, signed and dated by the DPS, shall be kept at the premises showing all persons authorised by them to make sales of alcohol at the premises. All staff involved in sales will be at least 18 years of age and will receive training to promote the licensing objectives. All training to be documented and records made available on request to Lancashire Police or any authorised officer.
- There will be a "Challenge 25" scheme in operation at the premises, requiring any individual who appears to be under the age of 25 to provide identification to prove that they are over the age of eighteen. In the event that the individual is unable to provide said identification, then the sale of alcohol will be refused. The only forms of identification which will be accepted as proof of age are:
 - a valid UK Passport;
 - a valid UK photocard driving licence;
 - A PASS card; and / or,
 - any other form of identification previously agreed with representatives from the Blackpool Police Licensing Unit.
 - any other nationally or locally approved form of identification which may be introduced in the future

Signs promoting this policy shall be prominently displayed at public entrances and alcohol sales areas.

- All staff to have received suitable training in relation to the Proof of Age Scheme to be applied upon the premises. Records to evidence this will be made available to an authorised officer upon request.
- 23 An incident book will be maintained, in which shall be recorded:
 - (a) All incidents of crime and disorder
 - (b) Refused sales to suspected under age / drunken persons
 - (c) A record of any person refused admission or asked to leave the premises
 - (d) Details of occasions upon which the Police are called to the premises
 - (e) The use or discovery of drugs

That book shall be available for inspection by a Police Officer or authorised person.

During the weekend of the 22nd to the 24th August 2014 the premises held an event which was authorised in part by the official granting of a Tempory Event Notice.

Complaints were received over the entirety of the weekend and without doubt the interference of residents rights to enjoy quiet possession of their homes was obvious.

To date 4 official complaints have been received with at least a further 2 to be obtained.

A representative of the Council ,namely Mark Marshall was called out to attend the area on both Friday 22rd August, Saturday 23rd August and Sunday 23rd August 2014.

The circumstances of the call out on Friday were in response to a call from Tim Coglan, service manager who had received complaints regarding loud noise believed to be emanating from Marton Mere caravan park.

At 21.50hrs on the 22nd August I attended the vicinity of Marton Mere, at the junction of Kipling Drive and Lawnswood Crescent, music could be heard but it was definitely not coming from Marton Mere, I drove onto the site moments later to confirm this and it was silent around all the entertainment complexes on the site.

I then established that the noise I heard at Lawnswood Crescent was coming from Marton Institue, this location is about 1.5 miles away but as I approached the Marton Institue nothing could be heard until I was 500 metres, clearly the wind direction was playing a part in pushing and dispersing the noise in different direction.

At or about this time I also received a call from Karl Bishoff, a college who lives in the vicinity of the Marton Institute, he disclosed his anger with the situation and explained that he had contacted the Institute and was largely ignored by the staff and his complaint fell on deaf ears.

At approximately 23.00hrs I contacted the Licence Holder Kerry Boyd and left a message, I explained the problems I had witnessed and the complaints received and asked to be contacted the following morning.

At 10.15 on the 23rd August 2014 I spoke to Kerry Boyd and explained what I had had witnessed with the noise the night previously and how far it was emanating from the premises, I suggested that if the nuisance was repeated on Saturday I would seek assistance from the police to explore

the possibility of a Section 161 Closure (Licensing Act2003) on the grounds of Public Nuisance.

Kerry was very co –operative and undertook to do her very best to monitor the situation and minimise disruption to residents in the vicinity.

I checked the area on Saturday evening, the entertainment could be heard but did not appear as bad as the night before.

On Sunday 24th August 2014 I was contacted by Norman Cowell, the call was made at approximately 14.30hrs, I said I would attend as soon as I could, I arrived at this address which is approximately 30 metres away from the Marton Institute. From within his lounge with the kitchen door closed the base beat reverberated through the whole of the house, watching TV would have been impossible, indeed just sitting in this room was verging on unbearable. I was satisfied without doubt that Mr Cowell would be incapable of putting up with the level of disturbance coming from the Marton Institute.

I approached the premises and spoke with Kerry Boyd, again she was cooperative and the volume levels were adjusted to the satisfaction of the complainant.

I returned back to the complainants address where his neighbour Teresa Cresswell had joined who also expressed her anger of the weekends noise disturbance.

A week or so after the event I was contacted by Cllr Haynes who said she had been inundated with complaints at her surgery and provided a series of names and addresses of her constituents who wished to complain.

To date the following statements have been obtained and make part of this application to demonstrate the Public Nuisance over the weekend of the 22nd-24th August 2014.

Other addresses were passed but we were either unable to make contact or the complainants were unwilling to provide formal complaints.

The clear message from the complainants is that outdoor entertainment such as amplified music should not be permitted at any time, this Authority seeks this requirement and requests that the prohibition of all types of amplified music and live bands should not be permitted in any outdoor location around this premises.

I am Amanda Jones and I make this statement and complaint about the Marton Institute at Oxford Square, Blackpool. The complaint is about the noise from the Marton Institute Pub Beer Festival on Friday 22nd and Saturday 23rd August 2014. On both nights I heard the music around 7.30 pm and it ended around 11.00pm. On the Friday evening I drove round to the Oxford Square area at 8.00 pm and confirmed that the music was coming from the entertainment at the beer festival at the Marton Institute. The music was so loud that even with all the windows and doors closed in my home I could feel the beat of the music and it was so intrusive that I wore my headphones to watch the Television on both evenings.

The level of noise was ridiculous and the music should not have been so loud that it could affect me in my own home and my enjoyment of my own home.

I am employed by Blackpool Borough Council as a Public Protection Officer in the Trading Standards Enforcement Section based at Bickerstaffe House, Talbot Road, Blackpool.

On Friday 22nd August 2014, I had reason to contact the Marton Institute, Oxford Square, Blackpool via telephone with regards to amplified noise that I believed to be coming from the venue.

In addition to this, not only was the music clearly audible within my home with all windows closed, but the base from the music could be felt in the vibration of my house.

Making a telephone call to the institute on or around 21:45hrs, a female answered the phone however failed to provide her name.

Raising my concerns, I explained that I welcomed the venue holding such a beer festival and other events and that I am not the type of person that would complain unnecessary, however I felt that the level of amplified music was unacceptable.

I further raised the fact that my property was not in close vicinity and in fact approximately 500 metres away in a westerly direction to the venue.

I further added that I had even observed other neighbours of mine in the street, attempting to

work out where the music was coming from.

At that same time, the current noise nuisance was also trending on the social internet site

Facebook, were people were commenting that the level of noise was a disgrace.

It was at this point that the female who remains unknown appeared to speak to a male about

my complaint. I could hear this conversation down the phone.

I not recall the conversation verbatim, however I do clearly remember the unknown male

saying, "We have a licence until 11, for all weekend so tough"

Overhearing this comment, I explained that they may well have such a licence, however this

does not mean that they can cause such a statutory nuisance to the neighbourhood.

I further offered for someone to visit my street if required to help appreciate my concerns,

however I was told that my complaint would be passed on. I never received any return call.

I made great effort to encourage the venue to address this issue as a member of the public

with at no point explaining that I was an officer of Trading Standards Enforcement (Weights

and Measures) and a former officer of Environmental Protection and its noise nuisance

abatement team.

Due to my concerns that this issue would persist over the weekend, I decided to call a

colleague of mine, Mark Marshall on or around 22:15hrs.

The purpose of this call was to ascertain if we was on duty and If so would and able to look

into the matter.

He informed me that he was aware of such noise nuisance in the area and that he had been

tasked to look into the disturbance.



I am Norman Cowell and currently reside on Vicarage Lane, Blackpool approximately 50 metres from the Marton Institute. I have lived here for 25 years and certainly in the last 5 years or so I have noticed the disturbance caused by the Marton and Institute and its customers.

Issues such as disturbance from customers as they leave the premises, car doors banging on the car park and loud music from the premises are my main concern.

I would describe myself as very tolerant and understand that customers who a touch rowdy when they leave the premises is not necessarily the Institutes fault, likewise they can't really be held responsible for irresponsible motorists who use excessive force to close their car doors but Manney N. B what I do take exception too is the many in which the entertainment noise spills out and causes an extreme nuisance. I am regularly disturbed, on average 2 or 3 times per week; often the noise disturbance starts at around 8pm and goes on through the evening.

The noise from the premises is from loud bands and DJ's, usually when I am disturbed I take a look out of my kitchen window and very often see the fire exit and the windows wide open on the West Elevation of the building, the connection with the noise nuisance and the windows being left open is clear, and things are definitely worse when the windows are open.

I have attached a photograph of the westerly elevation to demonstrate the location of the windows and doors and to exemplify the proximity of my house to the premises; this photo is exhibited as NCO1.

I have never complained to the management up until very recently, I am concerned I have to live in the area and don't want any bad feeling if that can be avoided, however recent events have caused me to formulize my concerns and I am now willing to support a formal complaint.

The incident which has forced to take action was the outside Beer Festival event that was held over the bank holiday weekend 22nd to the 24th August 2014. Large outside tents were erected on the car park along with large banners advertising the event.

My Concern was raised as I was walking back for a physiotherapy appointment on Whitegate Drive, my appointment was from 1.30pm to 2..30pm but I was delaying getting in as the therapist had over run with a patient, as a result I was back along Whitegate Drive at about 3.15pm. When I reached the Saddle Pub which is close to the junction with Preston Old Road and Whitegate Drive I could clearly hear the bands from the Institute carrying out sound tests etc.

I was unnerved hearing this as it was loud in the extreme and at that time I must have been

500 metres or so from the premises, bearing in mind my house is less than 50 metres from the

premises I began to fear the worst.

On my return home I phoned the main Council switch board number and asked if anything could

About 4 pm the same day I was re contacted by Mark Marshall, who gave an overview of the

event, stating that the music would finish by 11pm but that I should not put up with being

unreasonably disturbed, an example of turning the TV up full blast and still struggling to hear it

would be unreasonable disturbance.

I was also advised to go and introduce myself to the management and lodge my concerns with

them and perhaps obtain a contact number of someone I could speak to if things got out of

hand. I was given the name of Kerry Boyd as the point of contact.

I went round to the premises shortly after my conversation with Mr Marshall, and found Kerry

Boyd and explained that I had been advised to make contact with her, she was very pleasant but
