## **APPLICATION TO REVIEW A LICENCE – Spice Grill**

### **1.0 Purpose of the report:**

1.1 To consider an application by the Licensing Authority to review the licence issued in respect of Spice Grill, 49-51 Red Bank Road.

### **2.0 Recommendation(s):**

2.1 The panel is requested to determine the review application.

### **3.0 Reasons for recommendation(s):**

3.1 This application must be determined by the Licensing Panel.

None, once a review application is submitted it must be considered by the Licensing Panel.

### **4.0 Background Information**

4.1 Spice Grill, 49-51 Red Bank Road, Blackpool has the benefit of a premises licence authorising the supply of alcohol 11.00 to Midnight Monday-Saturday and 12.00 to 23.30 Sunday.

4.2 On 20 February 2018, an application was received from the Licensing Authority to review this licence on the grounds of the prevention of crime and disorder and public safety. A copy of the application is attached at Appendix 4a.

4.3 Representations in support of the review have been received from the Child Protection Licensing Officer attached at Appendix 4b.

4.4 The licence holder is currently Mr Nasir Uddin (who is also the Designated Premises Supervisor).

4.5 **Local policy considerations**

None.

4.6 **National policy considerations**

Section 11 reviews is relevant in particular:

11.20 – In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action should generally be directed at these causes and should always be no more than an appropriate and proportionate response.

If a suspension or revocation is being considered 11.23 should be taken into account “it will always be important that any detrimental financial impact that may result from a licensing authority’s decision is appropriate and proportionate to the promotion of the licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.”

The panel have the following powers:

1. Take no action
2. Modify the conditions of the licence (by adding removing or varying conditions)
3. Exclude a licensable activity from the licence
4. Suspend the licence for up to three months
5. Revoke the licence.

4.7 **Observations**

This licence has no other conditions endorsed upon it in addition to the following mandatory conditions:

**Annex 1 - Mandatory conditions**

- 1 Alcohol may be sold or supplied:
  - a) On weekdays, other than Christmas Day, Good Friday or New Year’s Eve from 11 a.m. to 12 midnight.

- b) On Sundays, other than Christmas Day, or New Year's Eve and Good Friday, from 12 noon to 11.30 p.m.
- c) On Christmas Day, 12 noon to 11.30 p.m.
- d) On New Year's Eve, except on a Sunday, 11 a.m. to 12 midnight;
- e) On New Year's Eve on a Sunday, 12 noon to 11.30 p.m.

On New Year's Eve, from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31<sup>st</sup> December).

2 The premises shall be used for the purpose of habitually providing the customary main meal at midday or in the evening, or both, for the accommodation of persons frequenting the premises.

3 Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there and for consumption by such a person as ancillary to his meal.

4 Suitable beverages other than intoxicating liquor (including drinking water) shall be equally available for consumption with or otherwise as an ancillary to meals served in the licensed premises.

5 No supply of alcohol may be made under the premises licence -

a) At a time when there is no designated premises supervisor in respect of the premises licence,

or

b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

6 Every supply of alcohol under the premise licence must be made or authorised by a person who holds a personal licence.

7 (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -
  - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

8 The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

9 (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either a holographic mark, or an ultraviolet feature.

10 The responsible person must ensure that -

- (a) where any of the following alcoholic drinks are sold or supplied for consumption

on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

11 (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

(2) In this condition:-

a. "permitted price" is the price found by applying the formula  $P = D + (D \times V)$ , where-

i. P is the permitted price,

ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

b. "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

c. "relevant person" means, in relation to premises in respect of which there is in force a premises licence-

i. the holder of the premises licence,

ii. the designated premises supervisor (if any) in respect of such a licence, or

iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;

d. "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

e. "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

(3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny.

(4) Where the permitted price on a day (“the first day”) would be different from the permitted price on the next day (“the second day”) as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

### Introduction

On the 30<sup>th</sup> September 2017 licensing Officer working in company with Home Office, Immigration Officers, lead officer Michelle Livesey and several other immigration officers.

The intention was to visit takeaways and medium size restaurants based around the town centre and outskirts of Blackpool. This was a national operation (operation wise) led by the Home Office in conjunction with Local Authorities targeting licensed takeaways and restaurants.

At approximately 18.00hrs officers entered the Spice Grill restaurant on Redbank Road, This Business has been the subject of three previous Home Office immigration visits in 2015, 2016 and the most recent visit 2017 when on each occasion one staff member had been found working without the right to work in the UK and arrested and a civil penalty issued to the owner of the business. Mr Summan Ahammad (2015, 2016) and Mr Nasir Uddin (2017)

At the time of the visit on 30<sup>th</sup> September 2017 the premises was open for business and at this time there were a large number of customers sitting at the tables eating food and drinking alcohol.

I introduced myself as a licensing officer for the Council and spoke to Mr Nasir Uddin the licence holder and explained our purpose for the visit.

Michelle Livesey then spoke to the licence holder Mr Uddin, who confirmed staff members stayed upstairs at the property. Immigration officers then moved to the kitchen at the rear of the premises to speak with and check kitchen staff.

Other officers went upstairs to search the bedrooms for any other staff members.

I was advised by Michelle Livesey that a male who had been working in the kitchen was to be further questioned as it had been established he did not have the right to work in the UK. The male was interviewed by Immigration Officers. I had no part in this process. After several hours I was informed by Michelle Livesey the male had been arrested and was transported to Bonny Street Police station for detention. During the search of the upstairs bedroom a knife was found secreted under the bed of the detained male who's identity was established as Rofiq Ahmed dob 07/10/1984. A fine was issued to Nasir Uddin the current licence holder for the premises for employing an illegal worker at the restaurant.

### Employment of illegal Workers

The latest revision of the Section 182 Guidance makes numerous references to the employment of illegal workers , the paragraphs below explain how the employment of illegal workers ties in with the Crime and Disorder Objective and also highlights it as an issue that Licensing Authorities should take very seriously;

LS/F/009/14/3

*The Immigration Act 2016 made the Secretary of State a responsible authority in respect of premises licensed to sell alcohol or late night refreshment with effect from 6 April 2017. In effect this conveys the role of responsible authority to Home Office Immigration Enforcement who exercises the powers on the Secretary of State's behalf. When Immigration Enforcement exercises its powers as a responsible authority it will do so in respect of the prevention of crime and disorder licensing objective because it is concerned with the prevention of illegal working or immigration offences more broadly.*

*However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement – either orally or in writing – that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate. Similarly, licensing authorities may take into account any civil immigration penalties which a licence holder has been required to pay for employing an illegal worker.*

*Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives and the prevention of illegal working in the interests of the wider community and not those of the individual licence holder*

*There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:*

- for the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime;*
- for the sale and distribution of illegal firearms;*
- for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;*
- for the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;*
- for prostitution or the sale of unlawful pornography;*
- by organised groups of paedophiles to groom children;*
- as the base for the organisation of criminal activity, particularly by gangs for the organisation of racist activity or the promotion of racist attacks;*
- for employing a person who is disqualified from that work by reason of their immigration status in the UK;*
- for unlawful gambling; and*
- for the sale or storage of smuggled tobacco and alcohol.*

*It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.*

**Conclusion.**

The employer should be obtaining and confirming that individuals have the right to work in the UK.

The employment of illegal workers opens all sorts other concerns from illegal human trafficking right through to labour exploration, tax avoidance and in the worst case organised crime. For Licensed Premises based in the town to be found in this position causes this Authority huge concern and I believe the premises have traded irresponsibly and in the view of the Authority making this application the licence should be revoked.

Please see Para 11.23 of the Section 182 Guidance;

11.23 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.



I am David Verity & I am currently employed as a Public Protection Officer within the Public Protection Division of Blackpool Council. As such I am duly authorised to enforce legislation in relation to the Licensing Act 2003.

On Saturday 30<sup>th</sup> September 2017 I was on duty working in company with a team of Home Office, Immigration officers led by Michelle Livesey.

This was part of a national operation (operation Weise) led by the home office working in conjunction with local authorities targeting licensed takeaways and restaurants checking on staff working at such premises ensuring staff have the right to work in the UK. I was informed by Michelle Livesey they were interested in a particular premises Spice Grill as there had been illegal workers discovered at this premises on previous immigration visits.

At approximately 18.00hrs we entered The Spice Grill a restaurant situated at 49 – 51 Red Bank Road, Blackpool. This premises benefits from a premises licence for the supply of alcohol on the premises PL0563. On entering the premises I observed approximately 20 customers sitting at various tables around the restaurant eating food and drinking alcohol I spoke to a male who was waiting on tables and identified myself as a licensing officer from the Council and asked to speak to the licence holder Mr Nasir Uddin I was shown to the bar where Mr Uddin was standing behind the bar. I again identified myself and explained that the immigration officers would be speaking to him Michelle Livesey explained our reason for entering the premises Michelle Livesey then requested


me to stay at the front of the premises for safety reasons, as other immigration officers made their way into the back to check the kitchen staff. During her conversation with Nasir Uddin it was disclosed that staff use the upstairs bedrooms the rooms upstairs were checked and confirmed persons had been sleeping in the bedrooms although nobody was present upstairs. I was then told by Michelle Livesey that one of the kitchen staff a male was being interviewed in relation to illegally working at the premises. This process took a considerable length of time and I was later told the male had been arrested removed from the premises and placed in the immigration secure vehicle and transported to Bonny Street police station. Nasir Uddin was issued with a fine for employing illegal workers. I then left the premises.

At a later date I received an email from my line manager Mark Marshall who had been in contact with Joseph Shirley, Chief Immigration Office who confirmed that the male arrested at Spice grill working illegally having no right to work in the U.K. was called Rofiq Ahmed date of Birth 07/10/1984 and at the time of the upstairs accommodation being searched a knife was found under the bed of Ahmed. A copy of the email dated 15<sup>th</sup> February 2018 is produced and shown for evidence as exhibit SG/01.

Further email requesting details of previous immigration visits to Spice Grill dated 17<sup>th</sup> February 2018 is presented and shown for evidence as SG/02. This shows that Spice grill has been visited by immigration three times over the last three years 2015, 2016 & 2017 and on each occasion one member of the staff have been arrested for illegally working and a civil penalty has been issued to the owner of the business.

I later made a statement to that effect.
