## IMPORTANT INFORMATION FROM BLACKPOOL COUNCIL

Dear Resident

### **Re: Parking Concerns – Mayor Avenue**

The Council has received complaints regarding parking on Mayor Avenue. There have been a number of requests for the introduction of Resident Parking and Limited Waiting to service the recreation ground.

We are seeking your views on the following options:

**Option One:** Implement Residents Parking on southeast side of Mayor Avenue and implement Limited Waiting on the northwest side to provide for visitors to the recreational ground. See the attached plan.

**Option Two:** Do not implement a scheme on Mayor Avenue. Maintain the status quo.

### **Key Points of the proposed Permit Parking Zone**

- Each property within the scheme would be entitled to one resident's permit and one visitor's permit only; each costing £12.50 per year to cover administration costs. Purchase of a permit would not guarantee any resident a parking space due to the fact that there are more properties than spaces available.
- There would be no dispensation for blue badges within the scheme.

The sole reason for introducing the permit parking scheme would be to manage and safeguard parking for residents. With this in mind, the Council would only formally propose to introduce the above scheme where at least 66% of those who respond are in favour of Residents Parking. The Council will assume those that don't or choose not to respond have no preference and therefore are happy to go with the majority.
