New cases

In total, 51 new cases were registered for investigation, compared to 51 received in August 2013.

Resolved cases

In August 2014, seven cases were resolved by negotiation without recourse to formal action, compared with twelve in August 2013.

Closed cases

In total, 24 cases were closed during the month (49 in August 2013). These cases include those where there was no breach of planning control found, no action was appropriate (e.g. due to more effective action by other agencies, such as the police) or where it was considered not expedient to take action, such as due to the insignificant nature of the breach.
