# PROVISION OF PERSONAL PROTECTIVE EQUIPMENT AND SAFETY FOOTWEAR

### 1.0 Purpose of the report:

1.1 To confirm the outcome of the recent tender exercise undertaken for the provision of personal protective equipment (lot 1) and safety footwear (lot 2).

# 2.0 Recommendation(s):

2.1 To approve the appointment of Key Engineering and Hygiene Supplies Ltd (Preston) for the provision of personal protective equipment and safety footwear.

## 3.0 Reasons for recommendation(s):

- 3.1 Key Engineering and Hygiene Supplies Ltd provided the most economically advantageous tender for both personal protective equipment and safety footwear and it is therefore our intention to enter into a formal agreement with them.

The option of undertaking a call-off from a national framework was considered, however, this would have excluded bids from local suppliers, so was not pursued.

#### 5.0 Background Information:

- 5.1 This is a recurrent procurement requirement. The contract will provide on-going provision of personal protective equipment and safety footwear.
- A formal tendering exercise was undertaken in two lots between August and October 2017, in order to select a supplier to undertake provision of personal protective equipment and safety footwear for 2 years, with the option to extend for a further 1 plus 1 year.
- 5.3 The Council conducted a 2 stage OJEU tender via the electronic tendering portal, The Chest. At stage one, 108 companies registered an interest with 27 submitting a response. After evaluation, 7 suppliers were shortlisted and invited to submit a tender for both lots.
