CONTRACT FOR THE PROVISION OF BACKGROUND CARE AND SUPPORT WITHIN EXTRA CARE HOUSING SCHEMES

1.0 Purpose of the report:

1.1 To approve the appointment of I Care (GB) Ltd as the contractor for the provision of background care and support within Elk and Tulloch extra care housing schemes, following completion of an OJEU (Official Journal of the European Union) tendering exercise.

2.0 Recommendation(s):

2.1 To approve the appointment of I Care (GB) Ltd of Kincraig Road, Blackpool, FY2 OPJ as the contractor for the provision of background care and support within extra care housing schemes. The contract is for a period of 2 years with the option to extend for a further 3 years subject to budget and satisfactory review.

5.0 Background Information

- 5.1 Blackpool Council works in partnership with Great Places Housing Association to provide two Extra Care Housing Schemes in Blackpool: Tulloch Court, Cherry Tree Road and Elk View Court, Ashfield Road. Great Places is the Landlord and Blackpool Council commissions the care provision within these schemes.
- 5.2 Both schemes have self-contained rental apartments and communal facilities. The contract with the current provider is coming to an end and we wish to appoint a care provider to provide 150 hours of care per week at each scheme and a nightly sleep in at each scheme.
- 5.3 Background care and support staff will be on site 24 hours a day, 7 days a week in case of an emergency and to supply ongoing background care such as welfare checks.
- 5.4 A 4-week enhanced service will also be delivered as part of background support for residents who require an enhanced level of support over the short-term e.g. returning to the scheme following a hospital admission.
- 5.5 A formal OJEU tendering exercise was undertaken during December 2017 to select a contractor to provide background care and support. The Council invited tenders through its e-tendering portal (The Chest), in a single stage process (Open Tender).
- 5.6 A total of 46 suppliers registered an interest and 7 submitted a tender response. After the evaluation I Care (GB) Ltd provided the best overall tender for the requirement and it is the Council's intention to enter into a formal agreement.
