FRAMEWORK AGREEMENT FOR THE TRANSPORTATION OF CHILDREN, YOUNG PEOPLE AND ADULTS

1.0 Purpose of the report:

To approve the appointment of a number of suppliers to join a framework agreement for the Transportation of Children, Young People and Adults, following an OJEU (Official Journal of the European Union) tendering exercise.

- 3.1 A formal OJEU tendering exercise was undertaken during April and May 2018, in order to select a number of contractors to join the framework agreement for the Transportation of Children, Young People and Adults. The Council invited tenders through its electronic portal (The Chest), by carrying out an open tender process.
 - 31 Suppliers registered an interest and 15 submitted a tender response. After the evaluation stage all 15 met the requirements of the evaluation criteria and it is the intention to enter into a formal agreement.

5.0 Background Information

- 5.1 The Authority's Integrated Transport Service co-ordinates a range of transport services for Children, Young People and Adults, (many of whom may have Special Educational Needs) along with our assigned Passenger Assistants to and from various educational establishments throughout the Borough and beyond.
- 5.2 Blackpool Council invited applications from suitably qualified providers interested in joining a framework agreement. The Framework will be used to call-off from time to time to provide services for the Transportation of Children, Young People and Adults.

- 5.3 All providers who meet and pass the exclusion and selection criteria will be awarded a Contract and admitted to the Framework.
- 5.4 It is anticipated that the framework will be valid for 4 years on a 2 plus 1 plus 1 year basis.
- 5.5 The Council makes no guarantee as to the number of Route Schedules that will be awarded to any Provider during the term of the Framework Agreement.
- 5.6 Following the establishment of the Framework the Route Schedules will be called-off either by direct award or via a mini-competition.
