# <u>APPLICATION FOR NEW PREMISES LICENCE AT 26 – 32 CHURCH STREET</u> <u>HEARING NOTE</u>

### INTRODUCTION

This is a relocation of a B&M store at Bank Hey Street, within the Talbot ward. The new store is 0.2m away from the old site, which is a 4-minute walk away.

The applicant believes that this is an exception to the Council's cumulative impact policy, which creates a rebuttable presumption of refusal for new off-licence premises within the saturation area.

In accordance with condition 4.8.2 of the Council's Licensing Policy, it is the applicant's view that a like for like swap is unlikely to add to the cumulative impact already being experienced in the area.

The application requests hours for the sale of alcohol from 07.00 to 22.00 every day of the week to allow for flexibility, particularly around Christmas time. As a general rule, the store will only be open between 08.30 and 20.00.

### B&M

The B&M store at Bank Hey Street, Blackpool has been trading in Blackpool for 10 years. A decision was taken earlier in the year to relocate this store to a vacant unit on Church Street (formerly BHS).

B&M believes that the BHS at Church Street was previously licensed to sell alcohol, so the surrender of that licence will have also reduced overall numbers of off-licensed premises in the saturation area.

Premises Licence 1872 for B&M Bank Hey Street was surrendered to Blackpool Council on 6<sup>th</sup> July 2018, due to the proposed relocation of the store to Church Street.

The surrendered Licence permitted off-sales of alcohol from 08.00 each day, with closing times varying throughout the year until as late as 21.00.

The Premises Licence was subject to a number of conditions, the most relevant ones in terms of public health being:

- No single can sales
- No beer/cider over 5.5% ABV
- No more than 5% of display area to be alcohol

B&M is not aware of any issues relating to street drinkers, police warnings etc at the Bank Hey store.

#### **NEW STORE**

Whilst it is accepted that the new B&M store is larger than the old one, alcohol is only a small part of the B&M offering. So for example, only 13 display bays will contain alcohol out of a total of 525 bays within the store (less than 2.5% of display bays).

Alcohol sales are ancillary to food and other goods purchases at B&M and are not the sole reason for visiting the store.

However, B&M acknowledges that high strength, low cost alcohol could be attractive to street drinkers and could affect public health generally. As such, it accepts that sales of high strength beer, lager and cider (particularly in single cans) could lead to street drinkers targeting the store to purchase alcohol. B&M does not want to encourage this type of custom. It is therefore happy to accept restrictions on super strength lager/beer and cider (e.g. white cider).

However, it must be noted that at other stores it does sells a range of "craft ales" (generally below 5%) in bottles and more recently in single cans and ideally would like to be able to do so at this store.

In light of concerns raised by the Area Manager about the location of the alcohol bays, a revised plan was lodged with the Council showing the alcohol bays relocated to a position adjacent to the tills to aid supervision of this area.

On 30th July 2018, the police agreed a condition with B&M to be imposed on this Licence:

• No single can sales of beer or cider over 5% will be permitted

#### **PROPOSAL**

A single objection to this application has been made by Blackpool Council Public Health department. As such the Council's cumulative impact policy is engaged, which creates a <u>rebuttable</u> presumption of refusal.

For the reasons outlined above, the applicant considers that the relocation allows the Committee to depart from its policy in these exceptional circumstances. B&M believes that the like for like relocation of one store with another, which is 4 minutes' walk away will not add to cumulative impact in the area.

Discussions have taken place with the Public Health department but proposals have not lead to any agreement.

The applicant would be prepared to be flexible in terms of permitted hours for off sales of alcohol and is also prepared to agree conditions (to match those on the surrendered licence if necessary).

B&M believes that a hearing is not necessary to resolve these issues and believes that negotiation could reach an acceptable compromise. However this has not been possible.

If a hearing proceeds, the Public Health department is requested to provide details of any specific issues that it has had with alcohol related crime/street drinking at the B&M store at Bank Hey Street.

## **The Premises Licence**

### This premises licence is valid until

- It is revoked
- If granted for a limited period, that period expires
- It is surrendered
- It lapses

A premises licence will lapse if the holder of the licence:

- Dies.
- Becomes mentally incapable (within meaning of Mental Capacity Act 2005),
- Becomes insolvent,
- Is dissolved, or
- In the case of a club, ceases to be a recognised club.
  - An individual becomes insolvent on approval of an individual voluntary arrangement, bankruptcy, having estate sequestrated, or entering deed of arrangement made for benefit of creditors or a trust to creditors.
  - > A company becomes insolvent on approval of a voluntary arrangement by its directors, appointment of administrator or administrative receiver in respect of the company, or liquidation.

## Duty to notify of change of name and address

The holder of a premises licence must notify the licensing authority as soon as reasonably practicable of any change in-

- 1. His name or address
- 2. The name and address of the designated premises supervisor (unless the designated premises supervisor has already notified the licensing authority)

The premises licence, or a statement why it cannot be produced must accompany this notification.

#### Duty to keep and produce licence

The licence or a certified copy of it must be kept at the premises in the custody, or under the control of –

- The licence holder
- A person who works at the premises, who has been nominated in writing

The summary, or certified copy must be prominently displayed at the premises, as must a notice specifying the position of the person nominated to keep the premises licence.

Please note the plan forms part of the premises licence and must not be removed.

A constable or authorised person may require the licence (or copy) to be produced for examination

#### **Annual Renewal Fees**

A Renewal Fee is due every year on the anniversary of the original grant of the licence.

Non-payment of the renewal fee will result in the suspension of the premises licence.

It is an offence not to comply with the above.

## Offences under the Licensing Act 2003

This leaflet only provides a general explanation of the offences that may be committed under the Licensing Act 2003. For the full list of offences and defences that are available, the Act itself should be referred to.

## 1. Sale and supply of alcohol to children

- a) It is an offence for a person to sell alcohol to an individual aged under 18. A club or a person may also commit an offence if they:
  - Supply alcohol to, or at the request a member of the club who is under 18, or
  - Supply alcohol at the request of a member of the club, to an individual who is under 18.
- b) It is an offence to knowingly allow the sale of alcohol to an individual aged under 18.
- c) It is an offence to sell liqueur confectionary to a child under 16 years of age.

#### Note

There is a statutory defence to the offence of selling alcohol to children if the retailer believed that the purchaser was over 18 years of age and had either taken all reasonable steps to determine the purchaser's age or that nobody could reasonably have suspected from the purchaser's appearance that he or she was under 18 years.

Attention is drawn to the Council's Proof of Age card scheme and other proof of age cards made available by national organisations.

- d) It is an offence to allow children unaccompanied by an adult to be present on premises used exclusively or primarily for the sale of alcohol.
- e) It is an offence to allow children unaccompanied by an adult to be present on premises where alcohol is sold between midnight and 5 am.
- f) A person who buys or attempts to buy alcohol for consumption by a child on licensed premises commits an offence and a vendor who could reasonably have identified such a purchase could also be charged under a) above.
- g) A person who acts as an agent for a child in purchasing or attempting to purchase alcohol (for example from an off licence) commits an offence and a vendor who could reasonably have recognised such an arrangement could also be charged with an offence.
- h) It is an offence to knowingly allow the consumption of alcohol by a child on licensed premises. The offence can be committed by any person who works on the premises in a capacity to prevent the consumption. This provision does not apply to 16 or 17 year olds who consume beer, wine or cider with a table meal when accompanied by an adult. Bar snacks do not amount to a table meal.
- i) It is an offence to knowingly deliver alcohol to a child. For example a child cannot collect or receive alcohol ordered by an adult by telephone.
- j) It is also an offence for an adult to send a child to collect alcohol from licensed premises. Persons at a licensed premises who permit such collection could be charged with aiding and abetting the offence.
- k) It is an offence to allow an individual under the age of 18 to sell or supply alcohol unless each such sale or supply has been specifically approved. The offence may be committed by a premise licence holder, designated premises supervisor or someone over 18 years of age authorised by them or in the case of a club, any responsible member or officer.


