**NOTES**

1. In cases where the fees are regulated by statute, it is recommended that the maximum amount chargeable be adopted, subject to a maximum in any one year not exceeding the fee for grant / renewal.
2. Zoo Licence - The first licence for a zoo issued under the Zoo Licensing Act 1981 is granted for a period of 4 years and any subsequent licence for 6 years.
3. Zoo Inspections - Informal inspections are normally carried out annually by a veterinary surgeon and the fee is determined on the basis of cost plus administration fee.
4. Licenses which are shown as being charged at cost will carry the appropriate direct cost plus their share of processing costs apportioned on a reasonable basis.
