Dear Resident

**Re: Parking Concerns – Osborne Road and Withnell Road, between Simpson Street and Station Terrace**

The Council has received several complaints about lack of parking for residents along Osborne Road and Withnell Road. The Council has investigated these concerns, and following discussions with your local Ward Councillors, we offer this consultation to seek your views on the option below that is currently being considered. This consultation is a revised consultation to the original consultation sent last year as the residents parking times were omitted. To avoid confusion this consultation is for a parking zone that will be in operation 24 hours a day 7 day a week.

**Permit Parking** along Osborne Road and Withnell Road to regulate the use of available parking, if there is sufficient support the Council will seek to implement a Permit Parking Zone which will not require bay markings and associated signage, instead the entry to the Permit Parking Zone will be signed; please see attached plan. Each self-contained residential property will be eligible to one visitor and one residents parking pass.

We will also be including Windsor Avenue and Brighton Avenue in this scheme. Their individual permit passes will be revoked, and new permit passes, one visitor and one residents parking pass, for the new scheme will be available to purchase.

The possession of a parking pass does not guarantee a parking space.

## In Summery

- The proposed scheme will include Brighton Avenue, Osborne Road, Windsor Avenue and Withnell Road; the full extent can be seen on the plan overleaf.
- The Resident parking zone will operate seven days a week, 24 hours a day.
- Each residential property (including hotels) will be able to apply for one residents and one visitors pass; the cost of each permit is £12.50pa
