RIDEABILITY FEES AND CHARGES 2020/21

1.0 Purpose of the report:

1.1 The proposed fees and charges for the Integrated Transport section, relating to the Rideability service for 2020/21

2.0 Recommendation(s):

To agree the proposed fees and charges for Integrated Transport section, relating to the Rideability service, which are detailed in Appendix 'A', with effect from 1 April 2020 to 31 March 2021.

3.0 Reasons for recommendation(s):

The proposed fees and charges are recommending to increase from £2.20 per single passenger trip to £2.25 per single passenger trip from 1 April 2020.

The service will continue serving the most vulnerable residents of Blackpool who are unable to access public transport, with the door to door service that is vital to some residents attending Doctors' appointments and undertaking everyday tasks such as shopping.

5.0 Background Information

- 5.1 The attached schedule proposes a change to the fees and charges for Rideability.
 Rideability has now been in the management of the Council since 2015 and has fully integrated into the transport service.
- 5.2 Rideability operates 6 days a week, Monday to Saturday providing transport to anyone who is unable to use a conventional bus. This may be because of a disability or health problem, or if the service user is elderly or frail.
- 5.3 Rideability receives income from two sources; the service user and the concessionary travel scheme administered by Lancashire County Council, but ultimately recharged back to Blackpool Council and paid from the Concessionary Travel budget. These make up the full fare taken by the service.
- The service does currently operate at a deficit, which is becoming more and more difficult to sustain in these financially challenging times. The proposal is to increase the fee from £2.20 per trip to £2.25 from 1 April 2020. This increase is intended to make the service more financially sustainable while minimising the impact on service users.
