APPOINTMENT OF CONSULTANTS TO DELIVER STUDIES FOR THE OUTLINE BUISNESS CASE FOR TWO COAST PROTECTION SCHEMES KNOWN AS, LITTLE BISPHAM TO BISPHAM AND THE BISPHAM CAPITAL MAINTENANCE SCHEME

1.0 Purpose of the report:

1.1 To agree to the proposal to appoint consultants from the Environment Agency's Consultancy Framework to prepare two studies for the outline business case for the coastal protection schemes known as Little Bispham to Bispham and Bispham Capital Maintenance, which are included in the Blackpool and Fylde Coast Protection Strategy 2012.

2.0 Recommendation(s):

2.1 To appoint the Environment Agency's framework of consultants to prepare studies for the outline business cases for the coastal protection schemes known as Little Bispham to Bispham and the Bispham Capital Maintenance scheme.

3.0 Reasons for recommendation(s):

3.1 The Blackpool and Fylde Coast Protection Strategy 2012 provides for the future Capital Projects at both Little Bispham to Bispham and the Bispham Capital Maintenance Scheme, to maintain the standard of protection to properties in those areas of Blackpool. The Environment Agency have provided accelerated funding (subject to approval of bids) to enable Blackpool Council to carry out a study for the outline business cases and establish the options and requirements for coast protection work in this area. Blackpool Council are in the process of formally applying for the accelerated funding in the Environment Agency's programme of works for 20/21. However to enable consultants to be provided in a timely manner, the Environment Agency have asked that Blackpool Council now need to confirm the use of the Environment Agency's framework of consultants to enable a suitable consultant to start works as soon as funding is formally approved.

5.0 Background Information

- 5.1 The Blackpool and Fylde Coast Protection Strategy 2012 identified that work would be required to replace the sea defence between Little Bispham and Bispham. The Environment Agency have included £300,000 of accelerated funding in their 2020/21 programme, to allow Blackpool to appoint consultants to provide a study for the outline business case and assess the options for the coast defence requirements in this area. A further £130,000 has been allocated to prepare a similar study for the business case for the scheme known as Bispham Capital Maintenance.
- 5.2 The Environment Agency have procured a framework of contractors that local authorities can use to assist in the preparation of the study for outline business case. The framework comprises specialist in this type of work.
- 5.3 Blackpool Council's Procurement Team have been consulted on the use of the Environment Agency's framework.
