STREET CAFÉ LICENCE FEES

1.0 Purpose of the report:

1.1 To consider whether to waive the Street Café Licence fees in 2020/21 and replace with a nominal £25 administration fee to support the local economy and businesses in these very difficult and financially challenging times.

2.0 Recommendation(s):

- To agree to waive the Street Café Licence fee in 2020/21 and replace with a nominal £25 administration fee for the period until 31 March 2021.
- 2.2 To refund any fees already paid for Street Café Licence in 2020/21 or to reapply the fees to other licence fees.

3.0 Reasons for recommendation(s):

- 3.1 To support Blackpool's economic recovery, which has been adversely affected by the Covid-19 pandemic, by waiving the Street Café Licence fee and by replacing with a £25 administration fee, which will help and support a number of, in particular, small businesses within Blackpool.
- 3.2 Is the recommendation contrary to a plan or strategy adopted or approved by the Council?
- 3.3 Is the recommendation in accordance with the Council's approved budget? Yes

- **4.0** Other alternative options to be considered:
- 4.1 A range of reduced fee options was considered rather than waiving the fee, but discarded as the Council is aware many of the businesses affected are struggling in the current climate.

The charging of an administration fee is however considered necessary to deter speculative applications and to ensure that applicants are serious about compliance with the undertakings required.

5.0 Council priority:

5.1 The relevant Council priority is: "The economy: Maximising growth and opportunity across Blackpool".

6.0 Background information

- 6.1 Street Café licences are issued and regulated under the Highways Act 1980, which effectively allows well managed and designed establishments to use the pavement to provide outdoor eating and drinking facilities.
- 6.2 Fees are based on a charge for each square metre or part thereof, which are used by the Council to cover the costs of providing the Licensing Service. The fees were set in February 2020 as part of the annual review of fees of Public Protection at that point the impact of Coronavirus was not anticipated.
- 6.3 In 2019/20 there were 51 street café licences issued and so far 30 in 2020/21. The total amount of fees received in 2019/20 was £24,684.
- 6.4 In light of the current economic position, the Council is aware that many of the small businesses that are currently trying to re-establish themselves and businesses are struggling financially to make ends meet. Therefore it is proposed that in order to support the local economy and the businesses impacted by the fee, that it is waived in 2020/21 and replaced by a nominal administration charge of £25. Those businesses that had already paid for this year's licence would receive a refund either directly or payment towards other licensing fees depending on their situation.
- 6.5 In relation to the loss of income, the Council will claim the monies back from the Government under the Local Government Income Compensation Scheme for lost sales, fees and charges with any residual falling on the service.

6.6 This amended fee would expire on 31 March 2021 before which time the Council will have undertaken a full review of all licensing fees taking into account the impact of Coronavirus. 6.7 Does the information submitted include any exempt information?
