- 6.2 Councillors Cain and Hobson of Bloomfield Ward have requested £140 as part funding to the Illuminations Department to supply lighting for the permanent Christmas Tree outside Revoe Library together with Tyldesley and Victoria Wards.
- 6.3 Councillors Brookes and Critchley of Hawes Side Ward have requested £420 as funding to the Illuminations Department to supply lighting for the permanent Christmas Tree at Crossland Road Park.
- 6.4 Councillors Benson and Mitchell of Layton Ward have requested:  
(i)£1,399.99 as funding to the Friends of the Kingscote Park for the purchase and installation of 2 park benches in the park.  
(ii)£420 funding to the Illuminations Department to supply lighting for the permanent Christmas Tree in Layton Ward.
- 6.5 Councillors Campbell and Kirkland of Park have requested £420 as funding to the Illuminations Department to supply lighting for the permanent Christmas Tree outside The Grange.
- 6.6 Councillors Collett and Matthews of Tyldesley Ward have requested £140 as part funding to the Illuminations Department to supply lighting for the permanent Christmas Tree outside Revoe Library together with Bloomfield and Victoria Wards.
- 6.7 Councillors Jackson and Owen of Victoria Ward have requested £140 as part funding to the Illuminations Department to supply lighting for the permanent Christmas Tree outside Revoe Library together with Bloomfield and Tyldesley Wards.
- 6.8 Councillors O'Hara and Robertson of Waterloo Ward have requested £3,000 as funding to Watson Park Bowling Club towards the refurbishment of the club house and various repairs to the green.
