NORTH PROMENADE CONSERVATION AREA MANAGEMENT PLAN

- 6.1 The North Promenade Conservation Area was designated in 2019. Subsequently a Conservation Area Management Plan was recently prepared and, in line with the requirements of the relevant legislation, a public consultation on the Management Plan was carried out from 4 January to 29 February 2024. The draft Management Plan was published on the Council website, and paper copies were made available in Central Library, Queen Street and at the Customer First desk, Municipal Buildings. A public meeting was held at the Cliffs Hotel on 25 January 2024 so that members of the public could ask questions about the proposed Management Plan.
- 6.2 No representations were received. Blackpool Civic Trust and the North Blackpool Regeneration, Growth and Prosperity Group support the objectives of the Conservation Area Management Plan.
- 6.3 The aim of the document is to complement existing national and local policies by providing further advice on the management of the North Promenade Conservation Area. The guidance contained within the Management Plan is intended to ensure that the character and appearance of the conservation area is preserved and enhanced.
- 6.4 The Management Plan is not meant to be overly prescriptive, or place a heavy financial burden on homeowners, but it is intended to guide and manage change when it is proposed in order to ensure that change is undertaken sensitively by paying due regard to the area's special interest.
