15/0583	Land adjacent 39 School Road, Blackpool	<p>The daughter of the owner of 39 School Road has asked that members of the Committee be aware of the attached photograph of the site.</p> <p>A revised site plan has been requested as it appears that the cabin is further from the site entrance and nearer the eastern boundary of the site than shown on the submitted plan. The cabin is therefore further from School Road than quoted in the Committee report (9 metres rather than 6.5 metres) and further from the front and rear garden of 39 School Road (24 metres rather than 21 metres). It is not considered that the revised plan affects the issues in the Committee report and does not affect the recommendation.</p>
