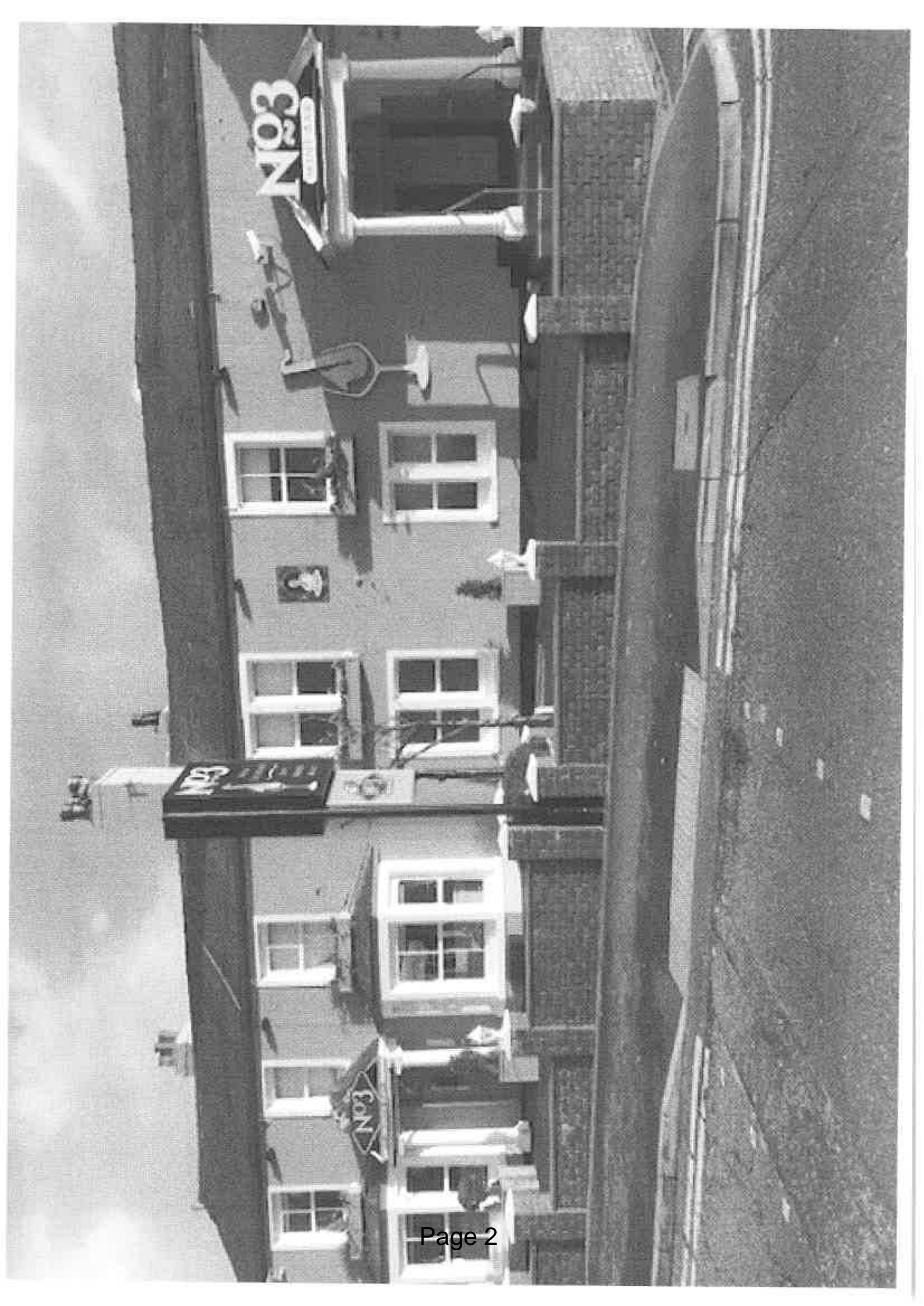

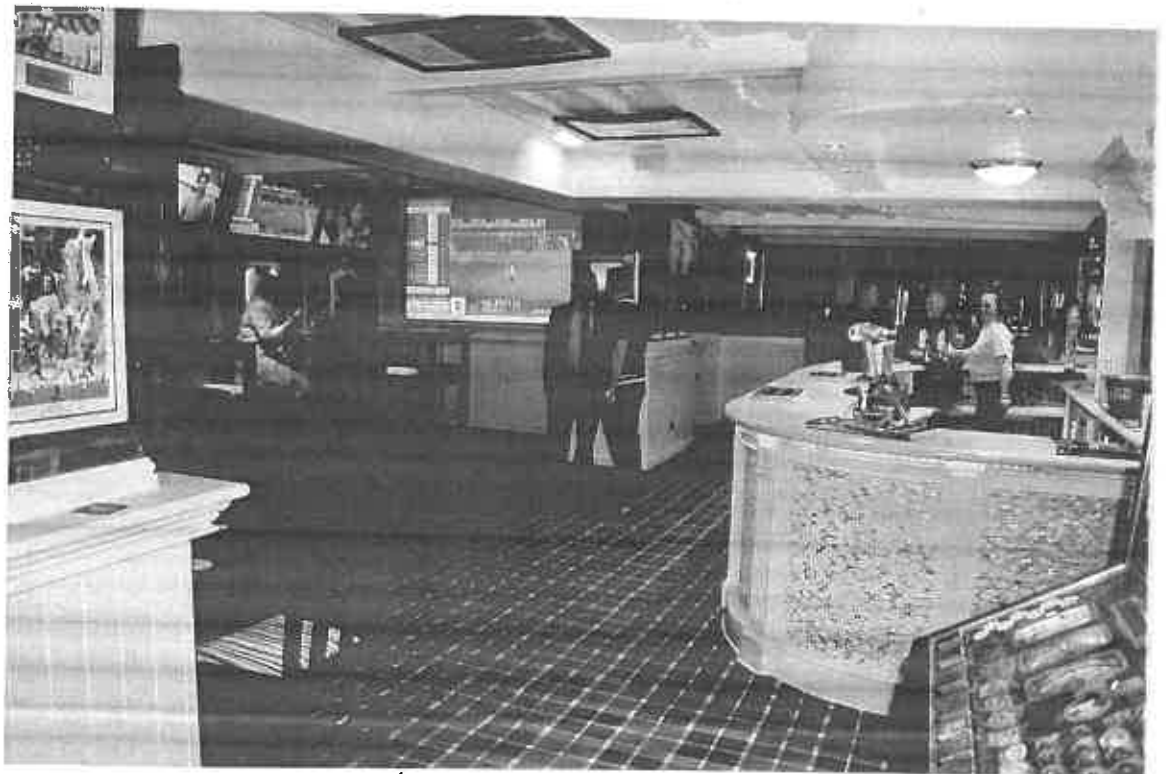

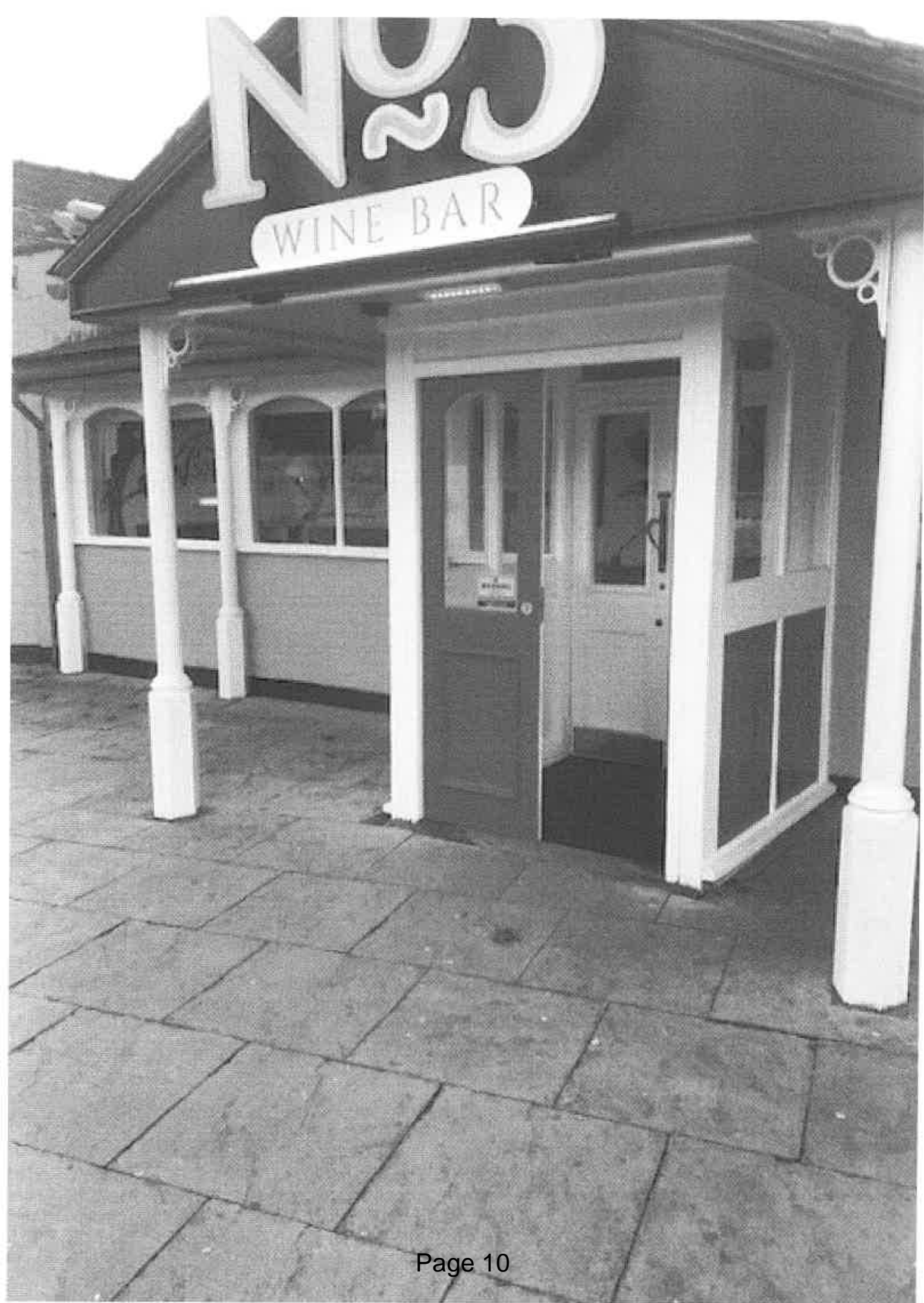






















The No3 Chip Shop
