- 5.1 On the 5<sup>th</sup> August 2014, Paul Savage made a request to licence a Cinderella Horse-Drawn Hackney Carriage.
- 5.2 The Sub-Committee decided at its meeting on the 23<sup>rd</sup> September 2010 to permit any style carriage however any carriages that were not of the traditional style were required to be produced before the Sub-Committee for approval.
- 5.3 At its meeting on 21<sup>st</sup> October 2010, the Public Protection Sub-Committee resolved that a licence in respect of the third Cinderella carriage be granted.
- 5.4 At its meeting on 10<sup>th</sup> March 2013, the Public Protection Sub-Committee resolved that a licence in respect of a fourth Cinderella carriage be granted.
- 5.5 At its meeting on 10<sup>th</sup> April 2014, the Public Protection Sub-Committee resolved that a licence in respect of a fifth Cinderella carriage be granted.
- 5.6 At its meeting on 8<sup>th</sup> May 2014, the Public Protection Sub-Committee resolved that a licence in respect of a sixth Cinderella carriage be granted.
- 5.7 At its meeting on 29<sup>th</sup> July 2014, the Public Protection Sub-Committee resolved that a licence in respect of a seventh Cinderella carriage be granted.
- 5.8 At its meeting on 2<sup>nd</sup> September 2014, the Public Protection Sub-Committee resolved that a licence in respect of a eighth Cinderella carriage be granted.
- 5.9 The Carriage has not yet been inspected by the Council's carriage inspector. The inspection is due to be arranged pending the decision of the Public Protection Sub-Committee.
- 5.10 The applicant has been invited to attend the meeting and bring the carriage for inspection by the Sub-Committee
