4 HORSE DRAWN HACKNEY CARRIAGE DRIVERS LICENCE

Prior to the consideration of the cases of the Horse-Drawn Hackney Carriage Drivers Licences that had been referred to the Sub-Committee, Members agreed to consider a verbal update from Mr Marshall, Licensing Health and Safety Enforcement Officer, on the current situation in relation to Horse-Drawn Hackney Carriages.

Mr Marshall reported on a number of serious concerns that had been brought to the attention of the Licensing Service in relation to Horse-Drawn Hackney Carriages following the changes to the road layout on the Promenade. He suggested that a detailed report be brought to the Sub-Committee at its next meeting. He also asked the Sub-Committee to consider deferring consideration of the cases in relation to Hackney Carriage Driver's Licences until after Members had recentage Propert to enable them to be considered

within the wider context of the current issues.

During a general discussion, Members generally considered that it would be advantageous to receive a report on the current issues in relation to Horse-Drawn Hackney Carriages at the Sub-Committee's next meeting. However, concerns were raised at the potential impact of any delay in consideration of the specific cases currently before the Sub-Committee.

The Sub-Committee was therefore informed of three Horse-Drawn Hackney Carriages that had given sufficient cause for concern as to be referred to the Sub-Committee for consideration.

KC, PS and CJWS were in attendance at the meeting.

Resolved:

- 1. To receive a detailed report on the current situation with regard to Horse-Drawn Hackney Carriages at its meeting on 16th December 2014.
- 2. To consider the specific cases relating to Horse-Drawn Hackney Carriage Driver's Licence that had been referred for consideration at this meeting.
- 3. That in the case of KC, a severe warning letter be issued regarding future conduct as the Sub-Committee was satisfied that on the balance of probability the incident had occurred resulting in significant public safety concerns and the conduct was far below the standard expected of a licensed driver.
- 4. That in the case of PS, a severe warning letter be issued regarding future conduct as the Sub-Committee was satisfied that on the balance of probability the incident had occurred resulting in significant public safety concerns and the conduct was far below the standard expected of a licensed driver.
- 5. That in the case of CJWS, a warning letter be issued regarding future conduct as the incident that had occurred had resulted in public safety concerns and was below the standard expected of a licensed driver.

5 PRIVATE HIRE VEHICLE DRIVERS LICENCE

The Sub-Committee was informed of four new applications for a Private Hire Vehicle Driver's Licence that had given sufficient cause for concern as to be referred to the Sub-Committee for consideration.

DKA, NC, NLD, supported by a Director of Blacktax Radio Taxis Ltd and DU were in attendance at the meeting.

Resolved:

- 1. That in the case of DA, no action be taken to prosecute for failure to declare a previous conviction.
- 2. That in the case of DA, the application for a Private Hire Vehicle Driver's Licence be granted.

- 3. - 4. That in the case of NLD, the application for a Private Hire Vehicle Driver's Licence be granted, subject to a warning letter being issued regarding future conduct.
- 5. That in the case of DU, the application for a Private Hire Vehicle Driver's Licence be refused on the grounds that he is not a fit and proper person due to the significant number of previous convictions and the pattern and frequency of those convictions.

HORSE-DRAWN HACKNEY CARRIAGE REPORT

1.0 Purpose of the report:

1.1 To consider a report from the licensing service about complaints received and incidents investigated relating to Horse-Drawn Hackney Carriages in 2014.

2.1 The Sub-Committee is asked to consider referring the issues relating to Horse-Drawn Hackney Carriages on the Promenade to the Scrutiny Committee for investigation.

Officers feel that whilst the Scrutiny Committee did consider the issue of Horse-Drawn Hackney Carriage licensing in 2007, the layout of the Promenade has changed significantly since that time therefore it may be appropriate for the issue to be considered in detail once more.

5.0 Background Information

- 5.1 Horse-Drawn Hackney Carriages, often referred to as Landaus are licensed to ply for hire all year round although in practice the majority of carriages only work between Easter and the Illumination switch off.
- 5.2 Whilst these vehicles are licensed as Hackney Carriages and therefore can ply for hire anywhere within the borough, they tend to restrict themselves to the Promenade and are a popular attraction for visitors.
- Over the last 12 months there has been an increase in the number of complaints about the amount of horse droppings on the Promenade and about carriage drivers driving down the middle of the road and going through red lights. There has also been an increase in the number of queries concerning the welfare of the horses whilst on the Promenade.
- 5.4 In October 2014, a serious incident took place where a horse was startled and bolted down the Promenade. The carriage in question collided with members of the public on the Promenade and a six year old boy had his collar bone broken as a result.
- 5.5 Officers will provide the Sub-Committee with a full report detailing all of these issues at the meeting.
