APPLICATION TO REVIEW A LICENCE – TANGERINE TAVERN

1.0 Purpose of the report:

- 1.1 Tangerine Tavern, 3-5 St Annes Road, Blackpool has the benefit of a premises licence permitting the sale of alcohol and provision of regulated entertainment. Alcohol may be sold until 00.00 Sunday-Thursday and until 01.00 on Friday and Saturday. The designated premises supervisor was Peter Thomas Flynn.
- 1.2 On 22nd September 2014, the licensing service received an application to review the licence on the grounds of prevention of crime and disorder and public safety.
- 1.3 The review application was submitted by Lancashire Constabulary. No representations have been received.

2.0 Recommendation(s):

2.1 The panel is requested to determine the review application.

3.0 Reasons for recommendation(s):

- 3.1 This application must be determined by a panel.

The panel have the following powers:

- 1. Take no action
- 2. Modify the conditions of the licence (by adding removing or varying conditions)
- 3. Exclude a licensable activity from the licence
- 4. Remove the DPS
- 5. Suspend the licence for up to three months
- 6. Revoke the licence.

4.3 **Observations**

The licence has the following conditions endorsed on the licence:

Annex 1 - Mandatory conditions

- 1 No supply of alcohol may be made under the premises licence
 - a) At a time when there is no designated premises supervisor in respect of the premises licence,
 - or

b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

- 2 Every supply of alcohol under the premise licence must be made or authorised by a person who holds a personal licence.
- 3 The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a

significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -

- a. Games or other activities which require or encourage, or are designed to require or encourage individuals to
 - i. Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. Drink as much alcohol as possible (whether within a time limit or otherwise);
- Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined by section 159 of the Act);
- c. Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- d. Provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on
 - i. The outcome of a race, competition or other event or process, or
 - ii. The likelihood of anything occurring or not occurring;
- 4 The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5 The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6 The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 year of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7 The responsible person shall ensure that
 - a. Where any of the following alcoholic drink is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - i. Beer or cider: ½ pint;
 - ii. Gin, rum, vodka or whisky: 25ml or 35ml; and
 - iii. Still wine in a glass: 125ml; and
 - b. Customers are made aware of the availability of these measures.

Annex 2 - Conditions consistent with the Operating Schedule

CCTV will be installed internally and externally at the premises. Said CCTV system shall comply with the following criteria:

 (a) The CCTV system shall be installed, maintained and operated to the reasonable satisfaction of Lancashire Constabulary. All public areas of the premises, with the exception of the toilets, shall be covered by the system;
 (b) The system shall display on any recording the correct time and date of the recording;
 (c) The system shall be recording during all hours the premises is open to the public;
 (d) VCR tapes or digital recording shall be held for a minimum of 30 days after the recording is made and will be made available to the Police for inspection upon request;

(e) The system shall, as a minimum, record images of the head and shoulders of all persons entering the premises.

- 2 A staff member who is conversant with the operation of the CCTV system will be on the premises at all times the premises are open to the public. This staff member will be able to show police recent data or footage with the absolute minimum of delay when requested.
- 3 An A4 advisory sign indicating that CCTV is in operation at the premises should be displayed on the outside of the building, at the main entrance and inside the premises.
- 4 The Police Licensing Unit shall be notified on any occasion when the CCTV system is to be inoperative for a period in excess of one working day and shall provide a certificate from a competent person stating the reason for the system being inoperative and the measures which have been taken to satisfy the licence conditions.
- 5 At least one personal licence holder (whose identity will be known to all other staff engaged in the sale or supply of alcohol) will be available whilst the sale or supply of alcohol is being undertaken, except in the case of emergency.
- 6 A drugs prevention strategy for the venue shall be developed, applied and documented. This strategy shall include arrangements for the location of posters and the distribution of other information relating to drugs risks, the dangers associated with drugs and the legal provisions relating to drug use.
- 7 Clearly visible notices shall be displayed advising those entering the premises that it is a condition of entry that customers agree to be searched and that Police will be informed if anybody is found to be in possession of controlled substances or weapons.
- 8 Any drugs found shall be confiscated, stored, disposed of or transferred in

accordance with procedures agreed with the Lancashire Constabulary.

- 9 Records of incidents involving the use and/or detection of drugs shall be maintained and those records shall be made available to the Police for inspection upon request.
- 10 Security arrangements will be sufficient to discourage the sale and consumption of drugs: such arrangements to include regular documented checks of toilet areas.
- 11 The premises shall be a member of the local Pubwatch scheme and the local Pubwatch protocols shall be adhered to. Entry will be refused to any persons who can be identified as currently under Pubwatch ban.
- 12 An authorisation of sales, signed and dated by the DPS, shall be kept at the premises showing all persons authorised by them to make sales of alcohol at the premises. All staff involved in sales will be at least 18 years of age and will receive training to promote the licensing objectives. All training to be documented and records made available on request to Lancashire Police or any authorised officer.
- 13 All staff to have received suitable training in relation to the Proof of Age Scheme to be applied upon the premises. Records to evidence this will be made available to an authorised officer upon request.
- 14 An incident book will be maintained, in which shall be recorded:

(a)All incidents of crime and disorder

- (b) Refused sales to suspected under age / drunken persons
- (c) A record of any person refused admission or asked to leave the premises
- (d) Details of occasions upon which the Police are called to the premises
- (e) The use or discovery of drugs

That book shall be available for inspection by a Police Officer or authorised person.

- 15 An adequate number of licensed door supervisors will be on duty as appropriate to any risk assessment at the premises.
- 16 A record shall be kept on the premises of every person employed at the premises as a door supervisor. The record shall contain the following details:
 - (a) name and address;
 - (b) date of birth;
 - (c) SIA licence number;
 - (d) time duty commenced and time duty terminated.

Said records shall be made available for inspection upon demand by the Police.

17 Frequent collection of glasses and bottles will be undertaken to ensure that empty containers do not accumulate in or around the licensed premises.

- 18 No entertainment of an adult or sexual nature will take place upon the licensed premises.
- 19 Any person under the age of 16 must be accompanied by a responsible adult and remains the responsibility of the accompanying adult at all times when using the premises. Members of staff are not allowed to be in sole supervision of children.
- 20 Persons under the age of 16 are not allowed to remain on the premises after 21.00 hours unless they are attending a pre-arranged function. If attending a pre-arranged private function children under 18 should be off the premises by 11pm.
- Functions which specifically target young people aged 17-18 years (for example 18th birthday parties) will not be allowed to take place on the premises.
- 22 The licence holder will give 5 working days' notice to the police of any occasion when a private function is to be held at the premises. On occasions when this provision has not been complied with, the licence holder must inform the police of all private functions and the police have the power of veto in relation to any functions in which the police are given less than 5 working days' notice. Risk assessments will be produced in relation to such functions, with a minimum of one SIA registered doorperson to be employed for functions of 30 or more adults.
- 23 All door staff employed at the entrance / exit of the licensed premises will wear a reflective jacket / tabard of a design approved by the Lancashire Constabulary.
- 24 The licence holder and the Designated Premises Supervisor shall nominate another person, who will deputise for the Designated Premises Supervisor in the DPS's absence, and shall ensure that the identity of the deputy is known by all other staff when such absence occurs.
- 25 Alcohol will only be purchased from a VAT and HMRC registered bone fide wholesaler. Written invoices will be obtained for all alcohol purchases and will be made available to trading standards officers and the police on request.



The application is brought on behalf of the Chief Constable of Lancashire Constabulary. The issues include suspected breaches of the Licensing Act 2003 and operational practices that would appear to undermine the Prevention of Crime and Disorder and Public Safety.

The issues of concern are as follows:-

- 1. Serving alcohol after licensed hours.
- 2. Events resulting in crime and disorder.
- 3. Lack of cooperation with the police.

Friday 25th July 2014

On Friday 25th July 2014 PC4107 Pritchard contacted Peter Flynn who is the Premises Licence Holder of The Waterloo Hotel and Bowling Club, Waterloo Rd, Blackpool due to him planning to hold a boxing event on Sunday 27th July 2014.flynn was advised that he would be committing a licensing offence if he let this go ahead.

Sunday 27th July 2014

On Sunday 27th July 2014 at 15.30 PC 3459 McVeigh will state he attended the Waterloo Club and witnessed a boxing match take place on the outdoor bowling green where a boxing ring had been set up.

Monday 28th July 2014.

On Monday 28th July 2014 at 01.33 the Police received a report from a member of the public that 20 persons were fighting outside Tangerine Tavern, St Annes Road, Blackpool. At 01.35 PC 3224 Hill arrived at the scene to find approximately 25 persons in the street with many pushing, shoving and shouting at each other with several drinking alcohol from glasses. Whilst trying to deal with this incident PC Hill states that the level of intoxication of all parties involved was extreme.

A conversation then took place between PC Hill and Peter Flynn which FLYNN told lies about his licensing hours and serving after hours. PC Hill believed Flynn had sold alcohol and his statement will evidence this.

PC HILL had to go back outside the premises as PC Gorst had called for officer assistance due to further fighting outside the club. During this incident six people were arrested and PC 425 Watson was assaulted.

Overview.


Peter Flynn has previously been convicted of the same offence under Section 136 of the licensing act on 06/12/13. PC 4107 Pritchard has completed a report for summons file and a request has been made to revoke his licence. Peter Flynn is not fit to run a licence premises and shows a complete disregard for the authorities. It is not acceptable that public safety is put at risk and officers injured due to serving alcohol after hours to the point people are incapable of walking and committing serious disorder in the street. This premises was reviewed in April 2013 due to poor management this causes the Police serious concern and we see no alternative than revocation of licence.

I am PC 3459 McVEIGH of the Lancashire Constabulary currently attached to Blackpool Central Police Office on immediate response duties.

At 15:30 hours on Sunday 27th of July 2014 I was on duty in full uniform in company with PC 3286 MALLIBAND using call sign WA44. At this time we attended the WATERLOO pub on WATERLOO ROAD in BLACKPOOL in order to conduct a licensing visit following information received relating to an unlicensed boxing event taking place at the location.

On arrival at the pub I immediately became aware of loud music being played from the rear. This music was clearly audible from outside the venue. I proceeded to enter the rear beer garden area of the pub and observed a boxing ring which had been set up in the centre of, what was the bowling green and two members of security staff restricting access to the public.

I made contact with security who advised me the organiser for the event was a John McNEILL, 20/08/1951. I then contacted McNEILL who advised me that the event had been organised in conjunction with the pubs licensee and that it was an amateur boxing event which was fully regulated. McNEILL also advised me that the event had been approved by the council, with the ambulance service and fire marshals being in attendance. McNEILL stated that the event would be finished at around 18:00 hours. Whilst speaking with McNEILL I observed two young males approximately 16 years of age boxing in the ring, they were wearing protective head gear and boxing gloves.

Following this I made contact with the WATERLOO pubs licensee who advised me that he was closing the venue at 19:00 hours and was serving all drinks in plastic cups. He stated that all fighters were wearing head guards apart from the later fights, with fighters fighting without head gear but where still using the same 6-10oz gloves.

I then resumed mobile patrol taking no further part in the matter.

This is my account of the arrest of John McNEIL and Ryan SKIVINGTON for being drunk and disorderly after a public order incident at THE TANGERINE TAVERN, ST.ANNES ROAD, BLACKPOOL in the early hours of MONDAY 28th JULY 2014.

During the evening of SUNDAY 27th JULY 2014 I started my tour of duty in a secure marked police van, call sign WA49. I was in full high visibility uniform. I was due to finish my shift at 07:00hrs the following day.

At 01:33hrs I was asked to attend THE TANGERINE TAVERN after a report from a member of the public of 20 people fighting outside THE TANGERINE TAVERN. I began to attend in an emergency response, as did several other police patrols in different police vehicles. As I was driving there I was updated that the fight was at the side of club on GLADSTONE STREET.

I arrived at 01:35hrs and as I was pulling up the club appeared closed as the front doors were closed. I pulled up on GLADSTONE STREET to be met by a group of around 25 people in the street with many pushing and shoving each other and shouting at each other with several people drinking alcohol from glasses. I advised the communications room that there was a group still in the street but there wasn't fighting and it was clear something had gone on. I noticed that people were going in and out of THE TANGERINE TAVERN by the side fire door. PC 230 SHANE and PC 3387 GORST arrived at this point.

I got out of my police van and could immediately sense the volatile situation. There were a mixed group of both men and women, with the majority shouting and swearing at each other, squaring up to each other, with some pushing and shoving each other. I saw McNEIL trying to get at another man shouting and screaming at him but was being held back by other people in the group. We intervened as best we could splitting up parties involved and eventually the incident seemed to be calming. I noticed that the level of drunkeness of all parties was extreme. They were staggering around unsteady on their feet, slurring as they were shouting and some were nearly falling over.

I decided to check inside the club to make sure nothing was going inside. I entered via the open fire door and saw about 6 people in the club and saw 4 people drinking alcohol in the club. I saw that 3 of the 4 people had drinks that were nearly full or 3/4s full. As I entered one male who was extremely drunk was coming out. He was so drunk he had snot all down his face, was sweating, could barely walk and was retching as if was going to be sick. He shot out the club by the fire door and I could hear him retching. I presume he was being sick. I saw lots of empty glasses stacked around on tables.

At this point I spoke with the man whom I know to be the licensee, Peter FLYNN. The time at this point was 01:45hrs. He was stood at the end of the bar smiling which I found quite disturbing. I asked him what had gone on and he just shrugged his shoulders. I asked him what his licensing hours were and why was the fire door open. He told me he was licensed to serve alcohol until 2am. I then asked to see his licence. There was a bar man still behind the bar at this point and he passed me the licence. I looked at the licence and saw that the licensing hours in which he was allowed the serve alcohol were in fact 00:30hrs. I again asked FLYNN what his licensing hours were and again he said 2am. I said to him that he musn't know his licensing hours as the licence clearly states half 12. He didn't reply. I then asked him why people were still drinking and why alcohol still being served. At this point FLYNN stated to me that they wasn't serving alcohol and they were drinking up. FLYNN was clearly lying as at first tried to tell me they were drinking legally as he was licensed until 2am and then when I discovered the true licensing hours he said they were drinking up. I pointed out to him the time was now 01:45hrs, which is passed drinking up time. Whilst I was doing this two females had been at the fire door coming and going drinking what I believe to be some sort of spirit and coke. FLYNN had no control over this incident.

At this point I heard PC GORST shout over the radio for assistance as it was kicking off again at the front of the club. I ran outside and saw two women pulling each others hair, with a group around them either trying to split it up or shouting and goading others. One women had blonde hair and a light top, the other was in black with dark hair. I saw two men pushing and shoving each other with their chests pumped up. One of these men was MCNEIL and he was swearing in the street shouting, had his arms raised with fists clenched, chest pumped up and was being held back from another man in a black t-shirt. I ran over and took hold of McNEIL by the arms taking him away from the situation. I was followed by a group from within who were trying to pull me off him and shouting and swearing in my face. I took McNEIL to my police van and stood him by it at which point he suddenly tensed up and tried to escape my grip to get at another man from within the group whilst shouting. I felt McNEIL' muscles tense up so I pulled him back against my police van shouting at him to stop it. He continued so I arrested him for being drunk and disorderly and handcuffed him. As I was doing this I was surrounded by about 10 people, some were shouting abuse at me and some were trying to pull me off him. PC SHANE was trying to protect me by creating a sterile area as I tried to secure McNEIL. I eventually managed to get him into the rear of my secure police van. McNEIL was very drunk. He was unsteady on his feet, slurring his words and smelled strongly of alcohol. The time at this point was 01:45hrs

I was aware other patrols were arriving at this point. I tried to persuade the group to calm down and disperse to go home but they continued shouting at me and each other, squaring upto each other. One female imparticular stood out. She was continually shouting abuse at

me and trying to barge passed me to open the police van doors shouting "YOU CANT FUCKING ARREST HIM. LET ME SEE HIM, FUCK YOU." She had a black top on, dark hair and had piercings in her nose.

At this point I looked and saw a male in a black vest and light shorts with his fists clenched trying to get at another man aggressively but being held back by about 3 people. He was pushing the three people to try and get passed them to get at another man in a black top who was shouting at him. I ran over to this group, who were just on ST.ANNES ROAD by GLADSTONE STREET, about 15 meters away from me. I took hold of the male in the black vest, whom I now know to be Ryan SKIVINGTON. As I took hold of him to prevent a breach of the peace he tried pulling away from me shouting "GET THE FUCK OFF ME" as well as shouting a lot of abuse at me. He also shouted numerous times at me "COME ON THEN, COME ON THEN" which I took as aggressive comment wishing to fight with me. He was very drunk, unsteady on his feet and I noticed his eyes were red and glazed. Again persons within the group tried to get me off him but PC SHANE and PC 5476 TURNER assisted me and I arrested him for being drunk and disorderly. I didn't caution him due to the situation I was in at the time. PC TURNER handcuffed him and we placed him into the rear of PC SHANES secure police van. The time at this point was 01:50hrs.

As the doors were closed on the police van I saw a group of about 10 at the junction of ST.ANNES ROAD and WATERLOO ROAD with police officers. I could hear lots of shouting and swearing coming from that direction and the aggressors were female voices. I couldn't see what was going on though as I was about 40 meters away from them. I turned the other way, south on ST.ANNES ROAD, and saw PC 8743 EDWARDS on the floor trying to arrest a male in a grey top. The male with the grey top was on his side struggling with PC EDWARDS trying to get up off the floor and was kicking out with his legs. PC EDWARDS was stood over him but bent down trying to control him. I was about 15 meters away from PC EDWARDS so ran over to him with PC TURNER. I took hold of the male in the grey tops arm and held him in the ground pin position whilst shouting "STOP STRUGGLING" with my knee resting on the right side of his back. This allowed handcuffs to be placed on the male. I do not know who handcuffed him. PC ROYLE then brought his police van to this male and he was placed in the rear of the secure police van. I noticed when he was being placed into the police van he had a small cut on the side of his head, but I can't recall which side.

I then went to speak with the licensee, Mr FLYNN. I knocked loudly on the fire door several times which was now locked closed. I could see the lights were on but no one answered. I could still hear shouting and screaming of female voices coming from the group at the junction of ST.ANNES ROAD and WATERLOO ROAD so went over to them to see if they required any assistance. I saw a girl with blonde hair on the floor with PC 4076 TAYLOR speaking with her. I thought she had been arrested. I also saw other females trying to get passed officers to get to the girl. The girls trying to get to her were being aggressive and continually tried to get passed the officers to get to the girls. In this situation my role is to protect the officers who were on the floor trying to speak with the blonde haired girl to create a sterile area to prevent the officers being injured or them interfering with the arrest.

One girl was continually shouting at me telling me "FUCK YOU" and kept trying to get passed me by barging into mer continually had to take hold of her arms and lead her away

and told her several times to go home and to stay back. She refused and each time came back more aggressively barging into me shouting and flapping her arms around aggressively. She was wearing to the best of my recollection a dark blue outfit with gold bits in the clothing and she had a bag with her. She had light brown hair. I pushed her back several times each time shouting "GET BACK." This female was eventually arrested by another officer and I assisted him as when she was being arrested she struggled and resisted shouting "FUCK OFF."

I then started walking back to THE TANGERINE TAVERN and saw Mr FLYNN who was at the front door of the club smoking. I started walking towards him and as I got about 20 meters to him he thrown his cigarette on the floor and went inside, closing the door behind him. I knocked on the front door loudly several times but Mr FLYNN didn't come to the door. The door was locked from the outside. I believe he was avoiding me.

I then transported McNEIL to BLACKPOOL CUSTODY where his detention was authorised.

I later read the incident log in relation to the incident and noted that the informant had stated upon calling the police that the group in question had been arguing amongst each other at the TANGERINE TAVERN and coming and going from the fire door since about 22:00hrs, which again concerns me with regards FLYNN` running of the club as to why he didn't ask the group to leave or call police for assistance at any time.

When booking SKIVINGTON into BLACKPOOL CUSTODY he seemed aggrieved with Peter FLYNN. He stated that at one point FLYNN said no more drinks were being served so he (SKIVINGTON)put £500 behind the bar and FLYNN continued serving. SKIVINGTON was saying he wanted his money back.

I had nothing further to do with this incident.

I am the above named person and am a police officer based at BLACKPOOL CENTRAL POLICE STATION.

In the early hours on MONDAY the 28th of JULY 2014 I was on duty in uniform and under call sign WA52 when at approx. 01:30hrs I heard via my personal radio communications ask for patrols to attend the TANGERINE TAVERN, ST ANNES ROAD, BLACKPOOL following a disturbance.

As I was already attending another incident I did not make initially but heard other patrols acknowledge the incident and start making. After about 10 minutes however I heard patrols at the TANGERINE TAVERN ask for more patrols to attend.

I started to make to the location in order to assist and also heard several other officers answer the call for assistance and say over the radio they were attending. Whilst on route I heard a patrol at the scene ask for the patrols grade one. I could hear in the background of this officer's transmission a large disturbance with what sounded like numerous people shouting.

As such I made grade on to the location and whilst still making I heard another patrol again request more patrols to the TANGERINE TAVERN.


I arrived on scene moments later and whilst driving up could see a large scale disturbance out in the street outside the club. Approx. 20 people were surrounding several officers at scene who were struggling with other people who appeared to be resisting.

I exited my vehicle and made over to these officers who were struggling and together with other officer who were now at scene I tried to control the crowd, keeping them back from officers who were dealing with people in an attempt to keep these officers safe from possible assault by the crowd around them.

For the next few minutes I, along with several other officers attempted to control, and disperse the crowd of people which were a mix of males and females all in their late teens to Signature. $\frac{28}{7}$

early 20's.

During this time we struggled to disperse the crowd and had several people run in behind us and make to police vans pulling the doors open in an attempt to access the people inside who had been arrested.

The crowd were volatile and aggressive squaring up to me and the other officers, swearing, and telling me and other officers to fuck off and refusing to move away. Most of the group appeared drunk with glazed eyes, slurred speech and smelling of intoxicants.

As such I had to resort to taking hold of several people and escorting them away in order to try and prevent offences being committed and disperse them.

On more than one occasion I saw in particular a female with long blonde hair, wearing a white top and black leggings approach officers I an aggressive manor and shout in their face before being pulled away by others in the group.

I, along with several officers managed to move the group across the road away from the TANGERINE TAVERN, and towards the east side of ST ANNES ROAD and the junction with WATERLOO ROAD.

Once there the female in the white top who later identified herself to me only as CHELSEA again emerged from the crowd of approx. 15 people and stood in front of SGT 1056 WHYATT shouting. I could see from where I was stood right next to SGT WHYATT that CHELSEA was drunk, her eyes were glazed, her speech was slurred and she was very unsteady on her feet.


As she stood there a female with blonde hair wearing a pink top came from the crowd, took hold of CHELSEA and tried to pull her away from the situation telling her "YOU WILL GET LOCKED UP". As this female tried to pull her away CHELSEA turned towards her, told her to "GET THE FUCK OFF ME" and pusher her hard in the chest causing her to stumble backwards.

The female in the pink top then lunged forward back towards CHELSEA and the pair began to struggle with each other pulling and pushing each other.

Due to this I stepped in to try and separate the two females before anyone got injured and with the intention of arresting CHELSEA on suspicion of being drunk and disorderly. I stepped in, took hold of CHELSEA and pulled her off the female in pink. I then tried to turn CHELSEA around in order to apply handcuffs due to her violent outburst but she resisted, would not turn away from me and instead turned towards me and tried to break free of my grip whist saying "GET THE FUCK OFF OF ME".

By this time I was in the middle of the crowd of people struggling with CHELSEA and as I tried to control her and push her out of the crowd so as not to be surrounded by the group I accidently stood on her foot causing her to stumble backwards falling to the floor within the crowd. I could not see, because of the crowd how CHEALSEA landed but almost instantly she sprang to her feet and swung a kick towards my groin as hard as she could. I reacted moving back partially out of the way of this kick which resulted in CHEALSEA kicking me on

the inside of my left thigh.

CHELSEA swung this kick with such force that she slipped and fell backwards once more into the crowd.

Again I could not see how she landed because of the crowd who gathered round her.

Following this I knelt down and attempted, along with PC 4076 TAYLOR to turn CHELSEA on to her front in order to handcuff her to the rear. As CHELSEA was turned onto her front she began to scream "MY ARM, YOU BROKE MY FUCKING ARM". I then pulled CHELSEA'S arms behind her back and applied handcuffs with the assistance of PC TAYLOR. At the same time, at 01:45hrs I told CHELSEA that she was under arrest on suspicion of being drunk and disorderly and assaulting a police officer. As I did this I saw that the left wrist of CHELSEA appeared to be miss shaped. As such I told PC TAYLOR that the wrist looked broken and removed the handcuffs in order to prevent any further injury being caused to the arm.

I did not caution CHELSEA at the time or outline the necessity for arrest, which was to prevent injury to others and protect public decency due to the more pressing need to deal with her injury and the fact I believed that she was too drunk to understand.

Following the removal of the cuffs I requested an ambulance to the location to treat CHELSEA'S injury before trying to calm her down. As other officers continued to disperse the crowd and move them away from me.

After several minutes I was informed by communications that the was no ETA for the ambulance due to demand so I made the decision that transporting CHELSEA up to the hospital in a police van would be more appropriate.

As such PC 4512 PRITCHARD and PC 5746 TURNER brought CHELSEA to her feet and placed her in a marked police van before PC 3819 GOSS transported her to BLACKPOOL VICTORIA HOSPITAL.

I am Police Constable 4107 Pritchard of the Lancashire Constabulary, currently Stationed at Blackpool Central Police Station on the Licensing Department. Part of my job role involves me visiting Licensed Premises to ensure they are operating in accordance with their Licence conditions.

I was made aware by a member of the public that a boxing event had been advertised and was to be held at The WATERLOO HOTEL AND BOWLING CLUB on Sunday 27th July 2014. THE WATERLOO HOTEL. WATERLOO ROAD, BLACKPOOL is not licensed to hold boxing entertainment and there was no Temporary Event Notice in place for this event. At 12:20hrs on Friday 25th July I contacted the Premises Licence Holder Peter FLYNN and he confirmed that this boxing event was taking place on Sunday between 2:30pm and 6pm in the out door bowling green and that 400 tickets had been sold out of a potential of 500 tickets to be sold. He told me that the event organiser was John McNeil and that he had organised 6 members of door staff, paramedics, fire marshals and that alcohol would be served by waiter/ waitress service in polycarbonate glasses to people sat outside watching the boxing. I asked if he had a Temporary Event Notice in place for this and FLYNN said "NO", I asked why not and he said "BECAUSE WE DIDN'T KNOW AT FIRST THAT WE NEEDED ONE AND THE DPS DIDN'T DO IT IN TIME." I then told him that last week I told THE HALWAY HOUSE PUB that they needed a TEN to hold an outdoor boxing match and as a result they had to postpone the event by a week and they had submitted a TEN. I asked FLYNN if he would be able to get hold of the people that had purchased the tickets and he said "NOT REALLY NO" and I told him that if he went ahead with the event that he would be committing an offence as he was not licensed. FLYNN said he had been told by someone from Signature

Blackpool Council that they wouldn't be prosecuting him for this and I told him that as I knew about this event I could not say he could break the law and also that despite what he may have been told by the Council I could not say he wouldn't be getting prosecuted should this event go ahead. I asked if FLYNN would be at the premises on Sunday and he said he would and told me that the joint Licence Holder Nick LOWE was on holiday in Crete. I asked FLYNN for the organiser John McNeils contact number and FLYNN said he would call me back with this information but he did not. I requested that a patrol attended THE WATERLOO HOTEL on Sunday to check if licensable activity was taking place. PC 3459 Michael McVeigh attended the premises at 15:30hrs on Sunday 27th July and stated that he spoke to the event organiser John McNeil and he observed two males fighting in a boxing ring located on the outdoor bowling green at the rear of the premises.

On Tuesday 29th July I listened to my work answer phone messages and discovered I had a message from Peter FLYNN received at 6:38pm on Sunday from 01253 319362 which stated "HELLO EMMA IT'S PETER FLYNN FROM THE WATERLOO PUB JUST TO LET YOU KNOW I HAD A VISIT FROM TWO OF YOUR UNIFORMED OFFICERS TODAY, THEY HAD A LOOK, RISK ASSESSMENT WAS ALL DONE, THE DOOR MAN WERE THERE, THE FIRE OFFICERS WERE THERE, THE MARSHALLS WERE THERE, ST JOHNS AMBULANCE WERE THERE, EVERYTHING WAS SPOT ON, IT'S NOW FINISHED EVERYONE IS NOW PACKING UP AND GOING HOME WITHOUT INCIDENT, IT WAS WELL POLICED AND ORGANISED, IT WAS A VERY GOOD DAY, JUST KEEPING YOU INFORMED, GOODBYE." I also saw that the boxing event organiser John McNEIL was one of six people that were arrested in the early hours of Monday at The TANGERINE TAVERN, ST ANNES ROAD of which Peter FLYNN is the Designated Premises Supervisor and director of Tangerine Tavern Ltd which is the Premises Licence Holder. Due to Officers not being able to get copies of the CCTV footage the CCTV hard drive from the TANGERINE TAVERN was seized on Monday 28th July, however the power cable was not seized so I contacted Peter FLYNN on Tuesday 29th July and arranged to meet him at The TANGERINE TAVERN AT 14:30hrs. I arrived at The TANGERINE TAVERN in company with PC 3127 REYNOLDS at approximately 14:15hrs and entered the TANGERINE TAVERN through the side Fire Door and saw Peter FLYNN who I have met on several occasions due to my previous dealings with both the TANGERINE TAVERN and the WATERLOO HOTEL. FLYNN gave me the power cable and I asked if we could discuss what at happened at the premises which led to six people being arrested at approximately 01:45hrs on Monday morning. FLYNN said that it was mainly pushing and shoving and verbal arguments and that some were arguing with John Signature FRitchard

McNeil over the boxing matches not being 'well matched' and fights not lasting long enough. I asked why people from the boxing were at the TANGERINE TAVERN and FLYNN said "BECAUSE THE WATERLOO WAS CLOSING SO THEY ALL CAME HERE ABOUT 11:45PM BECAUSE I THOUGHT WE WERE LICENSED UNTIL 1AM BUT WE'RE ONLY LICENSED UNTIL 12:30AM" I then informed him that he is actually only licensed to serve alcohol until midnight on a Sunday. I asked him why he had told PC Chris HILL he was licensed until 2am and he said no Officer actually came inside and spoke to him, FLYNN then asked a barman 'DAVE' regarding this and he said yes an Officer spoke to both himself and FLYNN at the bar and I asked if it was himself that was asked to show the Officer the premises licence and he said it was. FLYNN then seemed to have a vague recollection of this. I then asked why he did not answer the door to Police when they wanted to get CCTV footage at the time and he said he did not hear anyone knocking. FLYNN said that the boxing event itself went without any problems and I asked if Callum HOLMES (who is currently barred from Pubwatch premises) attended the event and FLYNN confirmed he was there. PC REYNOLDS has since been told by an anonymous source that Joey HOBAN who is also on Pubwatch attended the Boxing Event at the WATERLOO HOTEL, this is in breach of the licence conditions and a warning letter will be sent regarding this breach. At 14:25hrs on Tuesday 29th July I reported Peter FLYNN (dob 08/02/72) address of 118 PRESTON NEW ROAD, BLACKPOOL for summons for carrying on a licensable activity namely the sale by retail of alcohol from approximately 00:00hrs-01:45hrs on 28th July at The TANGERINE TAVERN contrary to section 136 of The Licensing Act 2003 and cautioned him to which he replied "IT'S MY FAULT I'LL THROW MYSELF AT THE MERCY". I then reported FLYNN for summons for having a boxing entertainment event at the WATERLOO HOTEL at 15:30hrs on Sunday 27th July without a licence contrary to section 136 of the Licensing Act 2003 and cautioned him to which FLYNN replied "WHY AM I BEING DONE FOR THAT NOT THE DPS". I explained that as the Licence Holder he was responsible. I then left the premises.

On Friday 1st August 2014 I was able to burn CCTV footage from the TANGERINE TAVERN which had to be burnt onto discs in 7 minute stints due to the type of CCTV hard drive. I exhibit these CD's as follows: 00:23-00:30hrs: ELP/4107/01, 00:33-00:40hrs: ELP/4107/02, 01:25-01:32hrs: ELP/4107/03, 01:32-01:39hrs: ELP/4107/04 and 01:39hrs-01:46hrs: ELP/4107/05. Also of note is the CCTV is 8 minutes ahead of real time. I have watched this CCTV footage and witnessed the barman David SIMPSON appear to 'cash up' at 00:15hrs (real time) and then Peter FLYNN enters the TANGERINE TAVERN with approximately 20 people and he speaks to SIMPSON for a while Signature f_{1} is the CCTV in the state of the speake to SIMPSON for a while signature f_{2} is the CCTV in the state of the speake to SIMPSON for a speake to simple speake to speake to SIMPSON for a speake to speake to


