## **APPLICATION TO REVIEW A LICENCE – STALL 13 ABINGDON STREET MARKET.**

### **1.0 Purpose of the report:**

1.1 Stall 13 Abingdon Street Market, Blackpool has the benefit of a premises licence permitting the sale of alcohol for consumption off the premises Monday-Saturday 09.00 – 17.00, Sunday 10.00 – 16.00. The licence holder and DPS is Kailasben Gandhi

1.2 On 4<sup>th</sup> February 2015, the licensing service received an application to review the licence on the grounds of prevention of crime and disorder and public safety.

1.3 The review application was submitted by Weights and Measures. Representations have been received from the Licensing Authority, Health and Safety and a member of the public.

### **2.0 Recommendation(s):**

2.1 The Panel is requested to determine the review application.

### **3.0 Reasons for recommendation(s):**

4.0 **Background Information**

4.2 **National policy considerations**

Section 11 reviews is relevant in particular:

11.20 – In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action should generally be directed at these causes and should always be no more than an appropriate and proportionate response.

- 4.3 If a suspension or revocation is being considered 11.23 should be taken into account “it will always be important that any detrimental financial impact that may result from a licensing authority’s decision is appropriate and proportionate to the promotion of the licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.”

The panel have the following powers:

1. Take no action
2. Modify the conditions of the licence (by adding removing or varying conditions)
3. Exclude a licensable activity from the licence
4. Remove the DPS
5. Suspend the licence for up to three months
6. Revoke the licence.

4.4 **Observations**

The licence has the following conditions endorsed on the licence:

**Annex 1 - Mandatory conditions**

- 1 No supply of alcohol may be made under the premises licence -
  - a) At a time when there is no designated premises supervisor in respect of the premises licence,

*or*

b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

2 Every supply of alcohol under the premise licence must be made or authorised by a person who holds a personal licence.

3 The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 year of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

## **Annex 2 - Conditions consistent with the Operating Schedule**

1 No entertainment of an adult nature will take place on the premises.

2 Alcohol is to be sold only in sealed containers.

3 The Licence holder is to support and rigorously enforce the Challenge 21 proof of age policy.

Any person who looks or appears to be under the age of 21 shall be asked to provide identification that they are over the age of 18. The following are the only forms of identification acceptable:

- i. UK photo driving licence
- ii. Passport
- iii. Proof of Age Standards Scheme Card

OR any other nationally or locally approved form of identification which may be introduced in the future. If no suitable identification is provided, sale of alcohol will be refused.

4 A refusals book will be kept at the premises.

5 All staff to have received suitable training in relation to the proof of age scheme to be applied upon the premises. Records to evidence this will be made available to an authorised officer upon request.

- 6 The premises licence holder, Kailasben Gandhi, and her husband will undertake the personal licence holder's course run by Blackpool Council. Such course to be completed by 30<sup>th</sup> April 2013.
- 7 The licence holder will exclude all persons properly notified to them by the police or other responsible authorities. Exclusions will include the refusal of all alcoholic drinks. Notifications will be given in writing with photographs and will be implemented on service until further notification from the servicing authority.
- 8 CCTV will be installed internally at the premises and will comply with the following:
- a) The CCTV system shall be installed, maintained and operated to the reasonable satisfaction of Lancashire Constabulary. The entrance, the till and alcohol fridge areas are to be covered by the system. The system will incorporate a camera covering each of the entrance doors and will be capable of providing an image which is regarded as identification standard.
  - b) The system will display on any recording the correct time and date of the recording.
  - c) The system will make recordings during all hours the premises are open to the public.
  - d) VCR tapes or digital recording shall be held for a minimum of 31 days and 21 days respectively, after the recording is made and will be made available to the Police or any authorised persons acting for Responsible Authority for inspection upon request.
  - e) The system will, as a minimum, record images of the head and shoulders of all persons entering the premises.
- 9 A staff member who is conversant with the operation of the CCTV system will be on the premises at all times that the premises is open to the public. This staff member will be able to show police recent data or footage with the absolute minimum of delay when requested. This data or footage reproduction should be almost instantaneous.
- 10 Appropriate signage alerting customers to CCTV recording shall be displayed in conspicuous positions on the premises.

**Please state the ground(s) for review (please read guidance note 1 before completing)**

The review is brought on behalf of the Licensing Authority following concerns that the Licensing Objectives are not being properly promoted when the premises are selling alcohol.

The circumstances leading to this review are that on the 12<sup>th</sup> January 2015 the premises were visited by Trading Standards, Health and Safety and the Police as part of a series of routine inspections of off licences. An inspection behind the counter revealed what appeared to be counterfeit bottles of Glen’s Vodka that were exposed for sale alongside bottles of genuine alcohol. These bottles, 6 in total, were subsequently seized and sent for examination by the Quality Manager of the Loch Lomand Group, which produces Glen’s Vodka. In due course it was confirmed that the seized vodka was counterfeit.

This raises concerns on many levels. Firstly, the position in society held by an operator of an off licence is a trusted one. The selling of counterfeit vodka to the unsuspecting public is a breach of that position of trust. It is safe to say that whoever produces the vodka has little regard for quality control procedures and most people, under the impression that they were buying genuine Glen’s vodka, at the genuine price, would not voluntarily drink it. In this respect the activity constitutes a breach of the licensing objective relating to public safety.

In respect of the licensing objective relating to the prevention of crime and disorder, the selling of counterfeit vodka is a clear offence under the Trade Marks Act 1994 and the Food Safety Act 1990. The Home Office published “Amended Guidance Issued under Section 182 of the Licensing Act 2003” dated June 2013, discusses in part 11, Reviews arising in connection with crime. Paragraph 11.27 outlines certain criminal activity that may arise in in connection with licenced premises which should be treated particularly seriously. Eleven examples are given of criminal activity. The last one states, “ For the sale of smuggled alcohol or tobacco.” It is accepted that the vodka in issue is not smuggled, but if we apply a more liberal interpretation of the guidance, it is within the spirit of the guidance that the sale of counterfeit alcohol should also be treated particularly seriously.

In support of this application I include evidence from Public Protection Officer Steven Ash, the Officer involved in the investigation into the counterfeit vodka. I include his statement as Document 1 and supporting evidence referred to in his statement as Documents 2 - 6 respectively. I also

include a photograph of the counterfeit vodka as document 7. At the time of this application the interview referred to has not yet taken place.


I am the above named and am employed as a Public Protection Officer within the Trading Standards (Enforcement) Section of the Public Protection Division. In this role I am authorised to enforce the provisions of the Trade Marks Act 1994. On the 12<sup>th</sup> January 2015 I was part of a multi-agency operation with Blackpool's Health and Safety Section and the Police. We were visiting a series of Off Licences to offer advice and inspect their premises as appropriate. At 13:40 we entered Abingdon News, Unit 13, Abingdon Street Market, Abingdon Street, Blackpool. The only person in attendance was the husband of premise licence holder Arvind Gandhi. I introduced myself and asked to go behind the counter. I identified the Glen's Vodka and visually inspected it for signs of authenticity. There were a few visual clues that suggested the vodka was counterfeit. I expressed my concerns to Mr Gandhi and informed him that I would be seizing the bottles. As I was in conversation with Mr Gandhi, the premise licence holder, Kailashen Gandhi entered the premise. I advised her of my suspicions and handed a Code B notice of Powers to Mr Gandhi. I seized the bottles, six in total, and left the premises. The bottles were immediately transferred to secure storage and an exhibit to be sent to the producer for an opinion was selected and sealed with Tag: 00539228. I produce a copy of the Code B Notice of Powers as exhibit SJA/AN/1. On the 13<sup>th</sup> January 2015 I sent a letter and receipt to Mrs Gandhi, copies of which I produce as exhibits SJA/AN/2 – 3. On the 14<sup>th</sup> January 2015 I sent an exhibit of the seized Glen's Vodka to Tom Taylor, Quality Manager of the Loch Lomand Group, which produces Glen's Vodka. On the 21<sup>st</sup> January 2015 I

emailed Tom Taylor to confirm that he had received the exhibit. He confirmed he had and that the sample was counterfeit. I produce this email was exhibit SJA/AN/4. Later that day I hand delivered a letter to Abingdon News, where Mr Gandhi was in attendance. I explained that the vodka was counterfeit and that Mrs Gandhi was invited to attend a formal interview. I produce a copy of this letter as exhibit SJA/AN/5.

#### POWER TO ENTER PREMISES AND INSPECT GOODS OR EQUIPMENT

A duly authorised officer may at all reasonable times and on production if so requested of his credentials enter any premises, other than premises used solely as a dwelling and inspect goods. Officers authorised under the Weights and Measures Act 1985 may inspect and test any weighing or measuring equipment used for trade. They may weigh or otherwise measure or count goods.

If an officer has reasonable grounds to suspect an offence has been committed he may at all reasonable times and on production if so requested of his credentials enter any premises to determine whether an offence had been committed

In exercising his right to seize property, the officer may require any person having authority to do so, to break open any container and if that request is not complied with the officer may do it himself.

An officer may seize and detain any records which he has reason to believe may be required as evidence and where records are kept on computer, may require the production of the records in a form in which they may be taken away

The purpose of this letter is to invite you to attend a formal, tape recorded, interview. The interview will be conducted under caution in accordance with the Police and Criminal Evidence Act and will take place at the Municipal Buildings, Corporation Street, FY1 1NF at 11:00 AM, Friday, 30<sup>th</sup> January 2015.

The purpose of the interview is to give you a chance to explain your actions and to put forward any defences that you feel may be relevant. I strongly advise you to bring any paperwork that you wish to rely on (invoices etc). Please be aware that any comments you make in response to this letter, in writing or otherwise, will be made under caution. The caution reads -

***You do not have to say anything, but it may harm your defence if you do not mention when questioned something which you later rely on in Court. Anything you do say may be given in evidence.***

It may be advisable for you to seek independent legal advice whether or not you decide to respond to this letter. If you fail to respond to this letter or you fail to attend for interview, a report will be submitted to the Public Protection Manager for consideration of legal proceedings.

I would also draw your attention to the provisions of Section 34 of the Criminal Justice and Public Order Act 1994, which, under certain circumstances, enables a Court to draw inference from an accused person's failure to mention facts when questioned about a criminal offence.

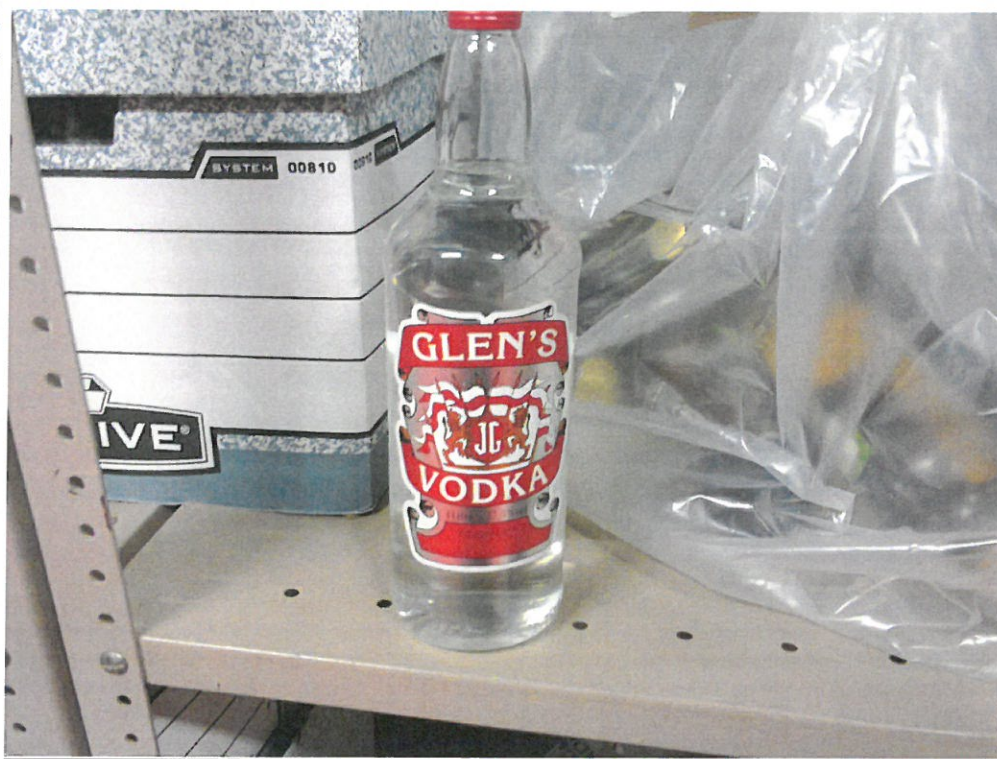

**REPORTING OFFICER'S COMMENTS**

The defendant was unable to offer any convincing defence for her actions other than the somewhat contrived defence that she bought the vodka off a man who came into her shop, who had no identification, and who handed her a very generic invoice.

Mrs (and Mr) Gandhi have operated Abingdon News for 4 years and previously ran a hotel for 10 years according to Mrs Gandhi. It is inconceivable that she is so naïve as to not realise the risks involved in this sort of transaction.

The selling of counterfeit alcohol alongside genuine alcohol suggests that it is being sold to unsuspecting members of the public as genuine. This is a serious breach of trust on the part of a premise licence holder, a position of responsibility.

Given the deceptive quality of the offence, and the lack of credible excuse, or defence, and given the potential harm to the public, I am recommending a prosecution.

In this role I am authorised to enforce the provisions of the Trade Marks Act 1994. On the 12<sup>th</sup> January 2015 I was part of a multi-agency operation with Blackpool's Health and Safety Section and the Police. We were visiting a series of Off Licences to offer advice and inspect their premises as appropriate. At 13:40 we entered Abingdon News, Unit 13, Abingdon Street Market, Abingdon Street, Blackpool. The only person in attendance was the husband of premise licence holder, Arvind Gandhi. I introduced myself and asked to go behind the counter. I identified the Glen's Vodka and visually inspected it for signs of authenticity. There were a few visual clues that suggested the vodka was counterfeit. I expressed my concerns to Mr Gandhi and informed him that I would be seizing the bottles. As I was in conversation with Mr Gandhi, the premise licence holder, Kailashen Gandhi entered the premise. I advised her of my suspicions and handed a Code B notice of Powers to Mr Gandhi. I seized the bottles, six in total, and left the premises. The bottles were immediately transferred to secure storage and an exhibit to be sent to the producer for an opinion was selected and sealed with Tag: 00539228. I produce a copy of the Code B Notice of Powers as exhibit SJA/AN/1. On the 13<sup>th</sup> January 2015 I sent a letter and receipt to Mrs Gandhi, copies of which I produce as exhibits SJA/AN/2 – 3. On the 14<sup>th</sup> January 2015 I sent an exhibit of the seized Glen's Vodka to Tom Taylor, Quality Manager of the Loch Lomond Group, which produces Glen's Vodka. On the 21<sup>st</sup> January 2015 I

emailed Tom Taylor to confirm that he had received the exhibit. He confirmed he had and that the sample was counterfeit. I produce this email was exhibit SJA/AN/4. Later that day I hand delivered a letter to Abingdon News, where Mr Gandhi was in attendance. I explained that the vodka was counterfeit and that Mrs Gandhi was invited to attend a formal interview. I produce a copy of this letter as exhibit SJA/AN/5. On the 26<sup>th</sup> January 2015 I received a 'phone call from Mr Gandhi wanting to rearrange the interview. The interview was subsequently arranged for 10:30 AM Thursday 29<sup>th</sup> January 2015. On the 28<sup>th</sup> January 2015 a man called on behalf of Mr Gandhi. I could hear Mr Gandhi in the background; this man explained that Mr Gandhi wanted the opportunity to seek legal advice. I agreed and gave Mr Gandhi 7 days in which to make further contact with me. On the 2<sup>nd</sup> February 2015 Mr Gandhi telephoned me and an interview was subsequently arranged for the Wednesday, 4<sup>th</sup> February 2015 at 12:00. At the appointed time Mrs Gandhi turned up to be interviewed. During the course of the interview she gave me an invoice that she claimed had been given to her by a man who called into her shop in December 2014, just before Christmas, and sold her 8 bottles of Glen's vodka for £12 each. I referred to this invoice in the interview, and produce this invoice as exhibit SJA/Invoice/1. I sealed a copy of the interview tape and this was transferred to our secure tape library. Later that day I hand delivered the working copy of the interview tape to the person who transcribes our tapes. On the 5<sup>th</sup> February 2015 I received the bottle of Glen's vodka that I had sealed with Tag: 00539228 and that was now sealed with Tag: CBWT004978 from Tom Taylor of Loch Lomond Group. 3. If you wish you or your representative will be allowed supervised access to your property so that you can examine it or have it photographed or copied.

Alternatively you may be provided with a photograph or copy. In either case you are responsible for the costs. Access etc will not be allowed if the officer in charge of the investigation believes that this would prejudice the investigation of an offence or any criminal proceedings. (Taken from Para 6.9 of Code B of the Codes of Practice)

### Search Warrant

4. A warrant authorises an entry on one occasion only. (Taken from Para 5.3 of Code B of the Codes of Practice)
5. A copy of the warrant should, if practicable, be given to the occupier before the search begins. (Taken from Para 5.8 of Code B of the Codes of Practice)

### Search with Consent

10. Where consent is withdrawn before the search is completed, the search must stop. (Taken from Para 4.3 of Code B of the Codes of Practice)
11. If you reside in a lodging house or similar accommodation your landlord can consent to your room or rooms being searched if you are unavailable at the time and the matter is urgent. (Taken from Note of Guidance 4A to Code B of the Codes of Practice)

12. In appropriate cases, compensation may be payable for damage caused in entering and searching premises and any application should be directed to:-







I would recommend that you send bottles to your Public Analyst for analysis to make sure that the contents are not detrimental to health.

We can carry out basic analysis in our Lab for strength, colour and other quality parameters etc. but we don't have the specialised equipment required for analysing counterfeit product for methanol, and other harmful chemicals that may be present.

The interview will be conducted under caution in accordance with the Police and Criminal Evidence Act and will take place at the Municipal Buildings, Corporation Street, FY1 1NF at 11:00 AM, Friday, 30<sup>th</sup> January 2015.

The purpose of the interview is to give you a chance to explain your actions and to put forward any defences that you feel may be relevant. I strongly advise you to bring any paperwork that you wish to rely on (invoices etc). Please be aware that any comments you make in response to this letter, in writing or otherwise, will be made under caution. The caution reads -

***You do not have to say anything, but it may harm your defence if you do not mention when questioned something which you later rely on in Court. Anything you do say may be given in evidence.***

It may be advisable for you to seek independent legal advice whether or not you decide to respond to this letter. If you fail to respond to this letter or you fail to attend for interview, a report will be submitted to the Public Protection Manager for consideration of legal proceedings.

I would also draw your attention to the provisions of Section 34 of the Criminal Justice and Public Order Act 1994, which, under certain circumstances, enables a Court to draw inference from an accused person's failure to mention facts when questioned about a criminal offence.







S Ash                      Okay, the circumstances are, the reason you are here is because it is alleged that you, on the 12<sup>th</sup> January 2015 had in your possession, exposed for sale 6 bottles of Vodka, which were identical to Glen's Vodka and which bore the registered trade mark of Glen's Vodka and as such is contrary to section 92(1)(c) of the Trade Marks Act of 1994.

At this point I am going to have to caution you.

You do not have to say anything but it may harm your defence if you do not mention, when questioned, something which you later rely on in court, anything you do say may be given in evidence.

You are not under arrest and you may seek legal advice. You can also leave at any time. Do you understand the caution and what I have said to you?

K Gandhi Yes

S Ash You do, okay, so I will ask you some questions now, I know its not very pleasant but we will just try and be honest. There are no trick questions, okay?

Are you the premise licence holder of Abingdon Street News?

K Gandhi Yes.

S Ash And what is the full address of Abingdon News please?

K Gandhi Abingdon News Street Market, Stall 13, 16/20 Abingdon Street.

S Ash Are you a sole proprietor, is it a partnership with your husband or...?

K Gandhi Yes, me and my husband, yes.

S Ash Does your husband's name appear on any official documentation or is it... I realise its your husband and you have not brought him with you, but is he officially involved with the licence premise?

K Gandhi No, just me.

S Ash Just you, okay, its not a limited company or anything like that is it?

K Gandhi No

S Ash Okay. On the 12<sup>th</sup> of January 2015 I visited your premises in Abingdon Street Market to carry out a multi-agency inspection with Health and Safety and the Police, your husband was present, you arrived a short time later. Do you recall the visit? Do you remember when I came?

K Gandhi Yes

S Ash When I was inspecting your premises I examined six bottles of Vodka that appeared to be genuine Glen's vodka, but appeared counterfeit. I seized these bottles and it has been confirmed that they are counterfeit. Can you tell me how they came to be behind the counter for sale with other genuine bottled spirits, so how did

they arrive there? The bottles that I seized how did they end up behind the counter?

K Gandhi Before the Christmas someone came to my hotel and tried to sell me, ---came, I know him, then someone else came, I got another bottle again and then it was Christmas, before the Christmas and I had no time to go to cash and carry so I took from him, they looked the same and then sell in good faith-----

S Ash So, just to clarify for the tape machine, just before Christmas, the cash and carry was closed so...

K Gandhi I hadn't time...

S Ash You hadn't time...

K Gandhi Because my husband's sister had pneumonia and I wasn't able to go there so we didn't have time to go to cash and carry...

S Ash So, due to personal circumstances neither you or your husband had time to go to the cash and carry so someone turned up at your hotel, your home address?

K Gandhi No the shop address

S Ash The shop address sorry and they sold you, it looks like according to the receipts... for the tape Mrs Gandhi is handing me an invoice 37655 and it says cash, invoice to follow December 2014 and on the receipt is detailed a quantity of eight Glen's Vodka £12 each, paid and then a scribbled signature, total £96. Okay who made the transaction, who bought the Vodka?

K Gandhi I was there.

S Ash You were there, was your husband there as well?

K Gandhi No

S Ash Just you in the shop, can you describe this person?

K Gandhi He is like -Five and a half to six foot, English guy.

S Ash English, okay.

K Gandhi And he got a blue jacket on...

S Ash Blue jacket.

K Gandhi I can't remember his face but he had a blue jacket on...

S Ash                    Okay, did his jacket have any kind of logo?

K Gandhi                I checked the -----Uk made in the back...

S Ash                    It said UK made at the back of the Vodka?

K Gandhi                Yes I think so, yes.

S Ash                    Did he have any other paperwork?

K Gandhi                Just this one.

S Ash                    Did he have any ID with him, this guy?

K Gandhi                No he says he will send me the other invoice.

S Ash                    Have you dealt with him before?

K Gandhi                No

S Ash                    So you have never seen him before, he walked in your shop... did he have a bag of Vodka or did he have it in a box?

K Gandhi                One box and then some loose as well.

S Ash                    Some loose, do you still have the box?

K Gandhi                No

S Ash                    And you paid him cash?

K Gandhi                Yes

S Ash                    I took six bottles out so it looks like you sold two bottles of Glen's Vodka?

K Gandhi                Yes

S Ash                    Can I keep this invoice or take a copy?

K Gandhi                Yes

S Ash                    Ok, where do you normally get your spirits from?

K Gandhi                Sometime Morrisons, sometime, what is it called? Bookers? And Aldi's sometimes, I was going to sell it over Christmas that is why I took it but I couldn't sell it.

S Ash                    Who is normally responsible for buying spirits, is it you or is it your husband?

K Gandhi My husband usually, its me made the mistake -----kind of mistake

S Ash So was it your husband who did the deal or was it you?

K Gandhi I was there.

S Ash You were there. Day to day, who runs the business? Is it you or your husband or both?

K Gandhi We both...

S Ash You both do it. Who would you say has control of the business, who is the controlling mind? Who makes the decisions?

K Gandhi Both of us do.

S Ash Both of you. Do you employ, do you have any members of staff?

K Gandhi No, can't afford.

S Ash No, I understand. Do you ever ask anybody to run the stall for you as a favour?

K Gandhi Pardon?

S Ash Do you ask anyone to look after the stall?

K Gandhi No, we don't go anywhere, because of this.

S Ash Okay, so going back to this invoice... I take it the invoice that was promised never followed?

K Gandhi No

S Ash You never got anything else, have you seen this guy ever again?

K Gandhi No

S Ash Did you notice what sort of vehicle he was driving?

K Gandhi No, I didn't see outside.

- K Gandhi            Similar
- S Ash                £12, okay. Is there anything else you want to add?
- K Gandhi            This is all my bills, yes and ----look at this, this one (Mrs Gandhi starts producing paperwork relating to proof of age traing etc)
- S Ash                That is mine (invoice).
- K Gandhi            No, this is yours its like either one litre-like -----very careful with the licence because look at this Aldi...
- S Ash                Let's look at the paperwork. For the benefit of the tape Mrs Gandhil would probably want to prove that she is responsible...
- K Gandhi            If anyone looks 20 not 20 we look 25 instead of ID.
- S Ash                I take your point, I see you have got a few documents here, however in respect of this offence, this isn't really relevant, so yes...
- K Gandhi            Not look 25 if no ID he looks anyway.
- S Ash                Okay. Mrs Gandhi wants to establish, on tape, that at this point she takes the Challenge 25 policy very seriously. I appreciate that, that will be argued as a separate issue if it comes to it. We are here just to discuss... we need to ask you questions about the Vodka, okay? Is there anything in there that is relevant to that?
- K Gandhi            And then he want to sell it now, because -----  
enough now
- S Ash                Shaun is there anything you want to ask?
- S McKinney         Do you have CCTV?



K Gandhi Yes

S McKinney Its part of your licensing condition isn't it?

K Gandhi Yes

S McKinney How far does that go back?

K Gandhi I think its 28 days or something.

S McKinney 28 days so when we came, when my colleague came in on the 12<sup>th</sup> was it, 12<sup>th</sup> January, would it have been in the last 28 days prior to that that this young man has been in with your...?

K Gandhi No its -----28 from now isn't it?

S McKinney No, I understand that, but when he came in on the 12<sup>th</sup>?

K Gandhi I don't know.

S McKinney What I am saying to you is that when he came in on the 12<sup>th</sup> of January this year and took that Vodka from you, theoretically, this man that sold you the Vodka, came in that period 28 days prior to the 12<sup>th</sup> January this year you would have been able to show us the footage of that wouldn't you?

K Gandhi Ok

S McKinney All I am saying to you is that if you were trying to reason this away why you have got it, you could have done that by producing the CCTV footage and you have not so did you know this man, are you sure you didn't know this man?

I am Thomas Keith Taylor and I have been employed by Glen Catrine Bonded Warehouse Ltd, 7 Laigh Road, Catrine, Ayrshire, KA5 6SQ as Quality Manager for twenty two years. In March 2014 the company changed ownership and now trades as Loch Lomond Group at the same address. I am employed as Quality Manager for the new company. In this capacity, I am familiar with the design, appearance, composition and quality of all genuine Loch Lomond Group products and I am authorised to speak on behalf of the company in relation to such matters. I can confirm that Glen's Vodka is a vodka brand for which Loch Lomond Group owns the Trade Mark Number EU003231107 and the brand was introduced in April 2003. I produce a copy of the Trademark Certificate and identify it as TKT/1. No other person, other than an agent authorised by our company, has permission to manufacture, produce or distribute any items bearing our trademark. On 16<sup>th</sup> January 2015 I received from Steven Ash, Public Protection Officer with Blackpool Council Trading Standards Enforcement, a plastic bag sealed with seal number 00539228. The bag contained a 1 Litre bottle that was labelled 'Glen's Vodka' and also had a self-adhesive label applied to it identifying it as exhibit SJA/AN/1. An accompanying letter from Steven Ash stated that the bottle was seized from a stall in Abingdon Street Market called Abingdon News, Unit 13, Abingdon Street, Blackpool, and requested that I examine it to establish if the product was genuine or counterfeit. I placed the sealed bag in secure storage and removed the bottle from it prior to examination. On examination, I came to the conclusion that

the bottle was counterfeit. My reasons for determining that it was not a genuine 1 Litre bottle of Glen's Vodka were as follows; The front and back labels on the counterfeit bottle appeared to be self-adhesive as there was no visible glue pattern. Genuine Glen's Vodka 1 Litre labels are applied by a Kosme Rotary Labelling Machine using a wet adhesive which produces a distinctive glue pattern on the back of the label (horizontal lines approximately 2mm apart). The print font used for the counterfeit cap was different from that on a genuine cap and the red colour and print were much duller. Genuine bottles of Glen's Vodka have a production lot code applied by laser or ink-jet at the time of filling to allow each bottle to be traced. There was no lot code on the counterfeit bottle. The spirit in the counterfeit bottle was tested in our Laboratory and was found to be organoleptically different from genuine Glen's Vodka and had an unpleasant odour. The alcoholic strength of the contents of the bottle was tested and found to be 33.3% vol. instead of 37.5% +/- 0.3% vol. for genuine Glen's Vodka. After examination of the counterfeit bottle, I placed it back in the plastic bag along with the original seal and sealed the bag with seal number CBWT 004978. The sealed bag was placed in suitable packaging and returned by courier to Steven Ash at Blackpool Council Trading Standards Enforcement. I can confirm that Abingdon News, Unit 13, Abingdon Street, Blackpool, is not an agent authorised by our company and has not been granted any licence or authority to use our trademarks. Counterfeiting of Glen's Vodka, or indeed any other brand, misleads consumers into purchasing poor quality products which do not meet our high quality and food safety standards or the expectations of the consumer. As the deception is often not obvious to the consumer, their quality perception of the product they have purchased will be attributed to the Glen's Vodka brand which is extremely detrimental to our company's reputation and brand equity.



**Officers observations/recommendations**

Clearly such a purchase was irresponsible, bearing in mind the widely reported problems with counterfeit and illicit spirits. The fact that the bottles had had the rear label removed and consequently were without a duty stamp as well as the fact that the seals were broken should have raised suspicion.

The mobile telephone number is still live but I am unable to trace it as we do not currently have access to the NAFN system.

Both Mr and Mrs Gandhi are partners in the business but Mrs Gandhi is the DPS. She admitted during interview to purchasing the vodka.

In view of the small number of bottles concerned (there were only two in the premises when Steve Ash visited) I would recommend that a simple caution be administered to Mrs Gandhi

Mr Bambrook emailed me two images of the bottle of vodka and I produce these images as exhibit **SJA/1**. On the 27<sup>th</sup> June 2011 I was passing the market and visited Abingdon News & Booze. I introduced myself and asked to see a bottle of Nicolaij vodka. There appeared to be two bottles on a shelf behind the counter. I viewed one bottle. The label on the rear of the bottle appeared to have been removed leaving a sticky residue of adhesive on the bottle and a visual check of the seal appeared to be broken. I asked the male behind the counter where the vodka was from. He seemed to indicate that that it had been left by the previous owner of the shop. I requested the male's consent to take the bottle and this was given. I left my business card at the shop. On my return to the Trading Standards Office I discussed the matter with PPO Stuart Killip. On the 29<sup>th</sup> June 2011 I accompanied PPO S Killip on an inspection of Abingdon News & Booze. On our arrival it became apparent that the remaining bottle of Nicolaij vodka had been removed



The premises were Reviewed in early 2013 for concerning practice in connection with failing to follow simple instruction properly given, the instruction were not to serve less than 10 individual problem street drinkers who were regularly causing Public Nuisance in and around the market.

The Licensing Committee and the responsible authorities approached the hearing in a very pragmatic way deciding that the imposition of conditions COULD be appropriate depending on the implementation and maintenance of such conditions, a judgement call was made to give the benefit of the doubt to the licence holders that they would rectify the concerns that were identified in the application and comply fully with the conditions imposed.

A copy of the text from the Decision Notice is found below;

The Blackpool Council being the licensing authority on the 30<sup>th</sup> November 2012 submitted an application to review the premises licence issued in respect of Stall 13, Abingdon Street Market, Blackpool FY1 1DE

The Council have determined to deal with the review to reflect the agreement between the parties by issuing a warning to the Premises Licence Holder and adding conditions to the licence.

#### Decision

Having taken into account the papers in this case and the agreement reached between the parties the panel have decided to issue a warning to the premises licence holder. Whilst the panel cannot bind a future panel, an indication is given that should this licence be reviewed in the future, as a minimum, the likely sanction will be a suspension.

The panel also add the following conditions to the licence:

1. The premises licence holder and her husband will undertake the personal licence holder's course run by Blackpool Council. Such course to be completed by 30<sup>th</sup> April 2013.
2. The licence holder will exclude all persons properly notified to them by the police or other responsible authorities. Exclusions will include the refusal of all alcoholic drinks. Notifications will be given in writing with photographs and will be implemented on service until further notification from the servicing authority.
3. CCTV will be installed internally at the premises and will comply with the following:
  - a) The CCTV system shall be installed, maintained and operated to the reasonable satisfaction of Lancashire Constabulary. The entrance, the till and alcohol fridge areas are to be covered by the system. The system will incorporate a camera covering each of the entrance doors and will be capable of providing an image which is regarded as identification standard.
  - b) The system will display on any recording the correct time and date of the recording.
  - c) The system will make recordings during all hours the premises are open to the public.
  - d) VCR tapes or digital recording shall be held for a minimum of 31 days and 21 days respectively, after the recording is made and will be made available to the Police or any authorised persons acting for Responsible Authority for inspection upon request.
  - e) The system will, as a minimum, record images of the head and shoulders of all persons entering the premises.
4. A staff member who is conversant with the operation of the CCTV system will be on the premises at all times that the premises is open to the public. This staff member will be able to show police recent data or footage with the absolute minimum of delay when requested. This data or footage reproduction should be almost instantaneous.
5. Appropriate signage alerting customers to CCTV recording shall be displayed in conspicuous positions on the premises.

A review of the licence has been sought by Weights and Measures following the discovery of counterfeit vodka which took place on the 12<sup>th</sup> January 2015

On the 26<sup>th</sup> February 2015 Mark Marshall and Gareth Shaw visited the premises, the market manager was spoken to and questioned as to whether he had further problems with the store, he confirmed that he didn't but added that the market has been very quiet for the last 18 months.

At 10.35 we entered the stall to find Mr Ghandi serving behind the counter, an explanation of the visit was given, which was to establish compliance with the conditions of the licence and to examine the Health and Safety position at the stall.

With regards to licensing compliance, this was disappointing, the CCTV equipment looked poorly maintained with intermittent faults appearing on the monitor, when asked to recall images from yesterday, Mrs Ghandi attempted unsuccessfully for 5-10 minutes to retrieve data, conceding eventually that her husband knew how to do it but was up at the hospital.

With regards to the staff training, no written staff training was in place with Mrs Ghandi pointing out that her and her husband had attended the personal licence course.

This is a small family operation with no employees, just MR and Mrs Ghandi, it does seem a very easy step to have a simple instruction in place to cover this Licensing Condition but a step the licence holder has omitted along with the CCTV requirement, which is to have someone competent to operate the CCTV equipment on site at all times.

The organisation of the stall was poor, again what does become very apparent is the management and maintenance of such a modest establishment should be straight forward but the conditions that prevailed give rise for concern as it was very dirty and disorganised.

The CCTV and the staff training requirements were conditions imposed after the review in 2013 so again I would question the ability and attitude of the licence holder as these simple matters have been overlooked.

The initial Offence of selling counterfeit goods was detected on the 12<sup>th</sup> January 2015, Mrs Ghandi was notified of the concerns at the time of the inspection, again a prudent operator would at least have thought to obtain the CCTV images of the supplier to assist Authorities in the detection of the offender.

However when interviewed on the 4<sup>th</sup> February Mrs Ghandi seemed to rely on the fact that too much time had elapsed since the supply and the images were no longer available.

The condition of the licence requires 31 days of images to be held, the receipt produced is not dated, it just say December 2014 and the description provided is unhelpful in the extreme. Mrs Ghandi described the male as, "White, between 5ft 6 and 6ft wearing a blue jacket."

The whole account is vague beyond belief, no date for the invoice, no name of the supplier, no meaningful description and no cctv images of the supplier despite him attended the stall.

The submission would be that the Licensing Authority can have little or no confidence in such an operator and bearing in mind they operate within a saturated ward, confidence in the operator is of the utmost importance.
