# APPLICATION TO REVIEW A LICENCE – North Parade Guest House trading as Casey's Bar

## **1.0** Purpose of the report:

1.1 To consider an application from the Licensing Authority to review the licence issued in respect of the North Parade Guest House, 68-70 Dickson Road.

## 2.0 Recommendation(s):

2.1 The panel is requested to determine the review application.

## 3.0 Reasons for recommendation(s):

- 3.1 This application must be determined by a panel.
- 3.2a Is the recommendation contrary to a plan or strategy adopted or No approved by the Council?
- 3.2b Is the recommendation in accordance with the Council's approved Yes budget?
- 3.3 Other alternative options to be considered:

None, once a review application is submitted it must be considered by a Licensing Panel.

### 4.0 Background Information

4.1 The North Parade Guest House, 68-70 Dickson Road, has the benefit of a Premises Licence authorising live music, recorded music, and the sale of alcohol for consumption on the premises to residents 24 hours a day. Alcohol may also be sold to non-residents 11.00 – 23.00 Monday-Thursday, 11.00 – 01.00 Friday – Saturday, 11.00 – 00.00 Sunday.

- 4.2 On 8 August 2016 the Licensing Service received an application from the Licensing Authority to review this licence on the grounds of the prevention of crime and disorder, the prevention of public nuisance and protection of children from harm. A copy of the application is attached at Appendix 4a.
- 4.3 Representations have been received from Lancashire Constabulary and the Child Protection Licensing Officer. Copies of the representations are attached at Appendices 4b and 4c.
- 4.4 The licence holder is Casey's Carvery Limited and the designated premises supervisor is Patrick William Buckley.

## 4.6 **National policy considerations**

Section 11 reviews is relevant in particular:

11.20 – In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action should generally be directed at these causes and should always be no more than an appropriate and proportionate response.

If a suspension or revocation is being considered 11.23 should be taken into account "it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence."

The panel have the following powers:

- 1. Take no action
- 2. Modify the conditions of the licence (by adding removing or varying conditions)
- 3. Exclude a licensable activity from the licence
- 4. Remove the DPS
- 5. Suspend the licence for up to three months
- 6. Revoke the licence.

## 4.7 **Observations**

Since the review was submitted discussions have been taking place between the licence holder and the Responsible Authorities. As a result of these discussions the panel will be asked to consider the following conditions:

- Any person under the age of 18 must be accompanied by a responsible adult and remains the responsibility of the accompanying adult at all times when using the premises. Members of staff are not allowed to be in sole supervision of children,
- There shall be no persons under 18 on the premises from 21.30 other than residents. Residents who are under 18 are not permitted in the licensed area or in the beer garden after 21.30 unless in the case of emergency or for access reasons only,
- All members of staff shall receive suitable training with regard to serving drunks and are to receive regular refresher training at intervals of a maximum of six months. Records to evidence this shall be made available to an authorised officer upon request,
- Any person who appears to be intoxicated or who is behaving in a disorderly manner shall not be allowed entry to the venue. Any person within the premises who appears to be intoxicated or who is behaving in a disorderly manner shall be given care and consideration in leaving the venue,
- From 20.00 on Friday and Saturday evenings there will be one SIA registered door supervisor employed until all non-residential customers have left the premises,
- Whenever regulated entertainment is taking place after 21.00 all windows and doors will be kept closed except for access and egress,
- Condition 11 in Annexe 2 shall be amended to read "whenever regulated entertainment is taking place, regular assessments taken by a competent member of staff shall be made of any noise emanating from the premises. Wherever said assessments indicate that noise is likely to cause nuisance to any residents or businesses in the vicinity, steps will be taken to reduce the level of noise".

The Licensing Authority, Police and Child Protection Licensing Officer all agree with the proposed conditions although the licence holder will be asked to volunteer to attend the Child Sexual Exploitation Awareness Session to be held on 11 November 2016.

This licence currently has the following conditions endorsed upon it:

## Annex 1 - Mandatory conditions

1 No supply of alcohol may be made under the premises licence -

a) At a time when there is no designated premises supervisor in respect of the premises licence,

or

- b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2 Every supply of alcohol under the premise licence must be made or authorised by a person who holds a personal licence.
- 3 The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -

- a. Games or other activities which require or encourage, or are designed to require or encourage individuals to
  - i. Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - ii. Drink as much alcohol as possible (whether within a time limit or otherwise);
- b. Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined by section 159 of the Act);
- c. Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- d. Provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on
  - i. The outcome of a race, competition or other event or process, or
  - ii. The likelihood of anything occurring or not occurring;

- 4 The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5 The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6 The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 year of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7 The responsible person shall ensure that
  - a. Where any of the following alcoholic drink is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
    - i. Beer or cider: ½ pint;
    - ii. Gin, rum, vodka or whisky: 25ml or 35ml; and
    - iii. Still wine in a glass: 125ml; and
  - b. Customers are made aware of the availability of these measures.

## Annex 2 - Conditions consistent with the Operating Schedule

- 1 Permitted hours for live music, recorded music, any other entertainment of a similar description and late night refreshment shall be extended to 01.00 on Christmas Eve, Christmas Day, Boxing Day, New Year's Eve, New Year's Day and on the Friday, Saturday, Sunday and Monday of Bank Holiday weekends.
- Alcohol shall not be sold to non-residents of the premises other than between the following hours:
  11:00 and 23:00 on a Monday, Tuesday, Wednesday or Thursday;
  11:00 and 01:00 on a Friday or a Saturday;
  11:00 and 00:00 on a Sunday.
  Irrespective of the week day, alcohol may be sold to non-residents between 11:00 and 01:00 on Christmas Eve, Christmas Day, Boxing Day, New Year's Eve, New Year's Day and on the Fridays, Saturdays, Sundays and Mondays of Bank Holiday Weekends.

- 3 All staff who are involved in the sale of alcohol will be trained in relation to the licensing objectives so as to reduce crime and disorder, promote public safety, prevent public nuisance and promote the protection of children from harm. Said training will be documented and will be made available to an authorised officer upon request.
- 4 All staff involved in sales shall be at least 18 years of age.
- 5 A comprehensive CCTV system shall be installed at the premises and will meet the following criteria:
  - The system will display on any recording the time and date of said recording;
  - The system will be recording whenever the premises is open to the public;
  - Any recordings will be retained for a minimum of 30 days after they are made and will be produced to an authorised officer upon request;
  - As a minimum, the system will capture images of the head and shoulders of any person entering the premises through the main public entrance.
- 6 The management of the premises will notify the Police Licensing Unit on any occasion that the CCTV will be inoperative for a period greater than one working day, and shall provide a certificate from a competent person stating the reasons for the system being inoperative and the measures which have been taken to satisfy the licence conditions.
- 7 Appropriate signage alerting customers to the use of CCTV shall be displayed in a conspicuous position at the premises.
- 8 An authorisation of sales, signed and dated by the DPS, shall be kept at the premises showing all persons authorised by them to make sales of alcohol at the premises.
- 9 The premises shall operate a zero tolerance drugs policy.
- 10 The capacity of the premises will be 80 people and as a minimum, seating shall be provided for 60 people.
- 11 Whenever regulated entertainment is taking place, regular assessments shall be made of any noise emanating from the premises. Wherever said assessments indicate that noise is likely to cause nuisance to any residents or businesses in the vicinity, steps will be taken to reduce the level of noise.

- 12 A clear, legible and conspicuous notice shall be displayed at each public exit requesting patrons to avoid causing noise, nuisance or disturbance upon leaving the premises.
- 13 A "Challenge 25" Policy shall be adopted and enforced at the premises whereby any person who appears to be under the age of 25 shall be required to provide identification to prove that they are over the age of 18 before they are permitted to purchase alcohol. The only forms of acceptable identification will be:
  - A Passport;
  - A UK Photocard Driving Licence;
  - Official ID card issued by HM Forces or EU bearing a photograph and the date of birth of the holder;
  - Any other form of identification agreed with a representative of the Police Licensing Unit.
- 14 All staff who are involved in the sale of alcohol will be trained in relation to the "Challenge 25" policy upon the commencement of their employment, following which they will undertake refresher training at suitable intervals. Said training will be documented and will be made available to an authorised officer upon request.

One particular complaint of concern was received from Helen Hamilton- Southward, a youth worker from Aspire Academy sent on the 5<sup>th</sup> February 2015 .( Document 1)

## 12<sup>th</sup> February 2015

Mark Marshall visited the premises and spoke with the owner, Patrick Buckley to put him on notice of the concerns raised by Miss Hamilton Southward, Mr Buckley intimated that the girls mentioned were not really cared for at home so well and he was offering them some sanctuary. Advice was given regarding the fact that all children must be accompanied by a supervising adult and in light of the concerns raised they should not be encouraged to come to the premises.

## 14<sup>th</sup> February 2015

Mark Marshall re visited the premises to ensure that the advice had been acted upon, the visit occurred at 21.40hrs, XXXX, aged 17 was on the premises with her friend who was also apparently 17, neither were drinking alcohol so on the face of things there were no concerns disclosed.

These visits were followed up in writing on the 19th February 2015 ( Document 2 )

## Public Nuisance

Noise from the premises has been noted on numerous occasions over the last 2 years,

Recorded visits where the issue of noise prevention have been discussed include;

**22<sup>nd</sup> February 2014-** Informal advice was given to Arron Buckley to monitor the noise levels and be mindful of neighbouring premises

7<sup>th</sup> June 2014- a visit was conducted by Mark Marshall and no concerns were raised.

**21<sup>st</sup> June 2014**- The noise from Casey's could be heard from 50-60 metres away, the time of this observation was 23.25hrs. Both the front doors to the premises were propped open with chairs so Arron Buckley was advised to deal with noise escape. He closed both doors immediately on request.

12<sup>th</sup> September 2014 – Observations were conducted and no concerns re noise were apparent.

**27<sup>th</sup> June 2016-**Complaint from the neighbouring premises received by the Licensing Authority that the noise and disorder from Casey's is getting worse, complaint text below;

PL1988 - North Parade Guest House (aka Caseys)

Complaint from Craig Coleman at Peek-A-Booze about nuisance and crime and disorder at Caseys getting worse and spilling over into his beer garden.

He says fights have started spilling over into his beer garden, alleging the manager of Caseys punched one of his own customers in the Peek-A-Booze beer garden. He says it is so bad he is having to use security and they are having to keep watch for the trouble at Caseys.

He says there is also noise nuisance.

He has been given the number for the Police licensing dept, EP Manager Jennifer Clayton and also Mark Marshall (Enforcement Manager).

2<sup>nd</sup> July 2016- Contact details for Mark Marshall were left at the complainants premises

**20<sup>th</sup> July 2016-** Statement of complaint obtained from the neighbour Craig Coleman which described substantial impact from the noise and disorder

**23<sup>rd</sup> July 2016**-Area visited to substantiate the noise complaints at 22.20hrs, both doors to the front of the premises and loud music was emanating from the premises, a 30 second video clip was obtained from the east side of Dickson Road. Also noted was the fact that no door supervisors were on duty.

## Prevention of Crime and Disorder

**20<sup>th</sup> July 2016-** The statement of complaint is comprehensive and has been supported by incident logs from Peek a booze, further consultation with Lancashire Constabulary has been conducted and again the logs support the allegations made in the statement of complaint. A summarised version of the police incidents is found below;

A brief summary of incidents:

WA1610762, WA1610716: Burglary, watch and money from jeans pocket stolen from hotel room. Offender arrested and charged.

LC-20160627-0040: Casey's staff called police stating a male was kicking off o/s Peekabooze, male was arrested for drunk & disorderly due to his aggressive behaviour.

LC-20160225-1426: Male assaulted in bar by a glass being thrown at him then he was punched, a table was smashed in the disturbance. Male needed stiches The victim was very drunk and drinking beer all day. CCTV was provided and stills circulated but offender unknown.

LC-20160201-1487: Male had £400 worth of camera equipment stolen from bar, CCTV provided but offender unidentified.

LC-20160101-0852: 6 people o/s Casey's fighting at 06:45hrs. Informant states they have gone into Casey's but when police attend it was all quiet and in darkness.

LC-20151107-0044: 00:34hrs initially reported as a domestic but was changed to a lawful ejection and police watched CCTV at the time and reported no crime.

LC-20151025-1179: Female been grabbed round the throat by male in the bar at 17:30hrs (not domestic related) victim since failed to co-operate with police and has a previous record for making false allegations.

LC-20150727-0966: Officer found male at 17:37hrs unconscious outside the bar on his face, had too much to drink and collapsed. Ambulance took male to hospital.

LC-20150425-1102: 18:01hrs 2 women causing problems, informant doesn't want to get involved but female jumped behind the bar and assaulted one of the staff. Police attend 2 females were arrested and charged with assault; they threw drinks at the barman and punched him and grabbed him round the throat.

In addition to the matters listed above PC Ian Ashton was verbally abused and aggressively physically treated and set on by a customer from Casey's, this occurred in September 2015 and is mentioned in the statement of Craig Coleman. Again no door supervision was in place at Casey's to intervene

I have personally spoke to PC Ashton who confirmed his version of events and he confirmed the incident was captured on his body camera.

## Protection from Children from Harm

**12<sup>th</sup> February 2015** –Discussions took place with Patrick Buckley about vulnerable children frequenting the premises, mentioned in more detail in the Introduction to this application.

**20<sup>th</sup> July 2016-** The statement of Craig Coleman describes many issues with children being both unruly and at risk from the disorder as very often they are left unsupervised till beyond midnight.

## Conclusion

The premises licence has limited conditions and intervention and encouragement has been made over the last 2 years to really focus on the Licensing Objectives, one of the barriers for achieving improvements is the lack of meaningful conditions.

The proposal would be for the Committee to consider the imposition of conditions to control the problems disclosed.

Door staff- Fridays and Saturdays seem to be the worse according to the complainant so targeting the hours of 8pm till close on a Friday and from 6pm on a Saturday till close may go some way to limiting the issues.

Doors and windows to be closed during the hours of regulated entertainment.

A noise assessment to be carried out by a competent person and the audio equipment to set and fixed at a volume that corresponds with the recommendations of that assessment. A copy of the noise assessment to be lodged with Licensing Authority.

Children and young people (as defined by the Licensing Act 2003) should be prohibited from entering the premises.

There is little doubt that the complainant is suffering the impact of miss management at the premises and evidence of crime and noise nuisance has been obtained independently of this complaint. In addition the area and facilities are not suitable for children, for example the beer garden is open to the main road which is always busy with traffic, the premises do not serve food so family style dinning is not an option and the style of premises is not really suitable. With the evidence of disorder and the serving of drunken people children in such an environment children could also be at risk and the consideration of a short suspension to deter such practices in line with Paragraph 11.23 of the Section 182 Guidance should be considered.

I would like to draw your attention to section 145 of the Licensing Act 2003

I am Craig Coleman and since September 2014 I have operated Peek a Booze, 72-74 Dickson Road with my partner Alex Coleman. Since opening the venue we have experienced problems with the premises next door, Casey's 68-70 Dickson Road. The problems we experience centre around noise disturbance as quite often the doors and windows are left wide open, serving drunks and allowing disorderly conduct, unsupervised children on the premises till beyond midnight and general anti-social behaviour and fighting both inside the venue and outside on the outside area which is directly next to ours. Both Alex and I have a good relationship with the owner Patrick Buckley and have on occasions raised our concerns with him but sadly the situation is becoming a threat to our staff safety and business reputation. On 12<sup>th</sup> February 2016 four customers from Casey's (2x male 2x female) entered our building at approximately 1am, at reaching the bar, the bar supervisors refused service on the basis that they appeared to be intoxicated, they were informed that they would not be served anymore alcohol, one of the couples walked off away from the bar and left the building by the front doors into the beer garden, the remaining couple were refusing to leave the premises and demanding to be served as they didn't feel they were too drunk. At which time bar supervisors requested assistance from door security, the door supervisor, aided by Alec escorted the gentleman to the door and 16 ...... Date ...... Signature

explained that he was being removed from the building for being drunk and aggressive towards the bar staff, at which time his female companion became extremely aggressive and physically assaulted both the door supervisor & Alec as they had to try and restrain her to remove her from the building. The female was taken forcibly to the front door where she continued to try to assault the staff members and was also kicking out at customers stood in the door area as they were trying to enter the bar from the beer garden. Once the female had been removed from the beer garden we rang for police assistance as she refused to leave the front of the property and continually shouted abuse and foul language toward the door staff and Alec, once she knew the police were en-route she walked off in the direction of Abi's corner shop where the rest of her party were waiting. Sometime later the police arrived and asked to view footage of CCTV of the woman assaulting the door supervisor inside the venue, the police were shown footage and they informed us that she had been arrested on Cocker Square or verbally abusing a police officer and threading behaviour.

for at the very least for the customer to be barred and refused further service. Some further specific incidents relate to the unsupervised children and disorderly conduct, on the 19th June 2016 after 11pm there were 6 children aged between 6 and 10 years of age climbing the boundary fence and jumping in and out of our beer garden, they were shouted away by Alex but the situation continued. After a period of time Alex when round to speak to Patrick, after all our security resource was having to deal with issues that were over spilling from his premises. Patrick stated that he couldn't really do anything about the situation and said it was the parents responsibility, the beer garden at both our premises and Casey's are adult environments and not appropriate for children and whilst we have a security presence to monitor and modify customer's behaviour the same cannot be said for Casey's bar. Alex passed comments to one of the mothers of these children and was met with an abusive response stating that her son was autistic and he was lucky her son didn't stab him. On the 26th June 2016, I saw the bar manager and bar man squaring up with each other in the beer garden, the premises was open for business at the time and later an assault occurred on one of these men. One of the men was later arrested for the assault, if this is the behaviour of staff it is little wonder that the customers are allowed to behave in a disorderly manner. On the 2nd July, just after midnight again I was alarmed to see young children sat in the beer garden at Casey's, there was 3 of them aged between 10 years and 14 years old, we later saw them leave with their parents but just to reiterate that the environment is inappropriate for I saw a fight break out whilst these children were looking on between 3 women, the fight was loud and boisterous with swearing and lot of stumbling and people being pulled around, again no door staff were employed at Casey's to intervene. At or around this time I decided enough was enough and made a complaint to the Council. On Tuesday 5th July 2016, I was visited by Mark Marshall and asked to make a formal complaint about the situation, we were advised to pull together any Date 25/0 Signature ...

incident records, specific example and if possible any CCTV and a subsequent appointment was made to give further details. On Wednesday the 20th July 2016, Alex and I attended the Council Offices where we provided some up to date information, the noise nuisance had been a constant theme since opening and this issues persist to the current day, the specific incidents since our initial complaint on the 5th July 2016 are as follows; 16th July 2016, I saw at least one child of the age of 10-12 years old sat on the beer garden at 12.15am at this time all the doors and windows were wide open with the karaoke blasting out causing a major disturbance. On Sunday 17th July 2016 at 11.55 hours a drunk male approached our door, he was visibly injured with dried blood and his t shirt and on his face and what appeared to be an injury to his eye. He was also clearly very drunk. He was refused entry into our premises so instead decided to go to Casey's where he was permitted access and served with alcohol. Later the same day Room 7 in our hotel which is directly above Peek a Booze was broken into and an expensive watch was stolen. The male with the blooded clothing was later arrested the same day inside Casey's Bar with the watch found in his possession. Later the same night Alex refused entry to more drunken males, again they gained entry straight into Casey's and some hours later tried to vent their anger on Alex by stepping round onto our premises and offering Alex to fight them. On Monday 18th July 2016 another example of them serving drunks was that

formally known as \_\_\_\_\_\_\_ who used to manage the Empress Hotel on Exchange Street tried to get in our venue, on this evening we were having a private function celebrating the renewal of our wedding vows, she was refused entry on the basis of her being mindless drunk and we did not want our function spoiling, again she went straight back to Casey's and consumed more alcohol. Our Premises is well run and has appropriate conditions that are designed to safe guard the Licensing Objectives, for example Door Supervisors to be on duty at key times, doors and windows to be closed during the hours of regulated entertainment and no children permitted on the premises, if these simple measures could be adopted by the Casey's we feel that would go some way to resolving the issues.

Lancashire Constabulary support the review application by The Local Authority submitted by Mark Marshall on the grounds of crime and disorder and the protection of children from harm.

A brief summary of incidents recorded by The Police from 25/04/2015 - 28/07/2016:

LC-20160728-1300/ LC-20160728-1302: 20-30 customers reported to be fighting outside. Police attend and landlord says it was an argument between two drunken females. No further Police action.

WA1610762, WA1610716: Burglary, watch and money from jeans pocket stolen from hotel room. Offender arrested and charged.

LC-20160627-0040: Casey's staff called police stating a male was kicking off outside Peekabooze, A male was arrested for drunk & disorderly due to his aggressive behaviour.

LC-20160225-1426: A Male was assaulted the in bar by a glass being thrown at him then he was punched. A table was also smashed in the disturbance. The Male needed stiches and the victim was very drunk and had been drinking beer all day. CCTV was provided and stills circulated but offender unknown.

LC-20160201-1487: A Male had £400 worth of camera equipment stolen from the bar, CCTV provided

but offender unidentified.

LC-20160101-0852: 6 people o/s Casey's fighting at 06:45hrs. Informant states they have gone into Casey's but when police attend it was all quiet and in darkness.

LC-20151107-0044: 00:34hrs initially reported as a domestic but was changed to a lawful ejection and police watched CCTV at the time and reported no crime.

LC-20151104-1096/ LC-20151104-1088: 17:48hrs allegation that Mr Buckley has caused him to lose £100 winnings on gaming machines in the premises and that the landlord has been drinking. Cross referred log from Mr Buckley states he wants assistance in ejecting this male.

LC-20151025-1179: Female been grabbed round the throat by male in the bar at 17:30hrs (not domestic related) victim since failed to co-operate with police and has a previous record for making false allegations.

LC-20150727-0966: Officer found male at 17:37hrs unconscious outside the bar on his face, had too much to drink and collapsed. Ambulance took male to hospital.

LC-20150425-1102: 18:01hrs 2 women causing problems, informant doesn't want to get involved but female jumped behind the bar and assaulted one of the staff. Police attend 2 females were arrested and charged with assault; they threw drinks at the barman and punched him and grabbed him round the throat.

The Police feel that the current measures in place are lacking and not going far enough to prevent crime and disorder and that disorder and assaults would appear to stem from excessive drunkenness. The Police therefore believe that the premises should employ door staff to prevent further crime and disorder. Consideration should also be made to the use of polycarbonate vessels due to the glass related assault. The Police are also concerned with the information detailed in the review that vulnerable children are present on the premises. The premises is not considered child friendly as food is not served and as shown above vertical drinking and disorder occur in and around the premises, therefore a condition to ensure no person under 18 is allowed on the premises should be considered.
