3 RENEWAL OF SEXUAL ENTERTAINMENT VENUE - EDEN ONE

At its meeting on 4 December 2018, the Sub-Committee previously considered the application by John Simon Sayers for the renewal of the Sexual Entertainment Venue (SEV) Licence for Eden One, First and Second Floor, 15-17 Queen Street Blackpool. Following the application, both the Police and Trading Standards had submitted representations detailing a number of concerns and requesting the imposition of additional conditions. At that meeting, concerns were expressed about the nature and extent of the complaints received about the over-charging of customers. The Sub-Committee noted the suggested conditions; however, they remained concerned as to their effectiveness in resolving the issues. The Sub-Committee stated that they expected to see a significant reduction in complaints and concerns.

Included with the report were a series of complaints from the previous six months which the Sub-Committee had intended to consider. However, Mr Lee Petrak, Trading Standards and Licensing Manager, who was in attendance, reported that earlier on the day of the meeting, new evidence in the form of a complaint of a very serious nature from a member of the public against Eden One had been received. Members were made aware of the precise nature of the incident and carefully considered whether it required further investigation.

5.1	On 17 June 2019, Darren Bradley made an application to licence a Cinderella Horse- Drawn Hackney Carriage.
5.2	The Sub-Committee decided at its meeting on 23 September 2010 to permit any style carriage however any carriages that were not of the traditional style were required to be produced before the Sub-Committee for approval.
5.3	Since 21 October 2010 up until 26 March 2019, the Public Protection Sub-Committee has licensed 23 non-traditional style Horse-Drawn Hackney Carriages.
5.4	This carriage has previously been licensed as a Blackpool Council Horse Drawn Hackney Carriage and was re-tested on 15 May 2019 by the Council's approved inspector and passed as fit for use.
5.5	Approval from the Sub-Committee is required as this carriage would replace a traditional carriage and increase the number of licensed non-traditional style carriages.

RENEWAL OF SEXUAL ENTERTAINMENT VENUE - EDEN ONE

1.0 Purpose of the report:

1.1 To consider an application by John Simon Sayers for the renewal of the Sexual Entertainment Venue (SEV) Licence for Eden One, First and Second Floor, 15-17 Queen Street Blackpool.

2.0 Recommendation(s):

2.1 To determine whether the licence should be renewed for a further period of six months with the previously agreed additional conditions listed in paragraph 5.4.

3.0 Reasons for recommendation(s):

- 3.1 An application for renewal needs to be determined.
- 3.2a Is the recommendation contrary to a plan or strategy adopted or approved by the Council?
- 3.2b Is the recommendation in accordance with the Council's approved Yes budget?
- 3.3 Other alternative options to be considered:

The Sub-Committee could grant the application for renewal without the additional conditions or refuse the application to renew.

4.0 Council Priority:

5.0 Background Information

- 5.1 Eden One, 15-17 Queen Street, Blackpool has been licensed as a Sexual Entertainment Venue (SEV) since October 2013. Ordinarily these licences are granted for a period of twelve months, although there is the power to grant for a shorter period if the authority thinks fit.
- 5.2 On 8 October 2018, the Licensing Service received an application from John Simon Sayers for the renewal of the SEV licence. The Police and Trading Standards submitted representations detailing a number of concerns, requesting the imposition of additional conditions.
- 5.3 At its meeting on 4 December 2018, the Sub-Committee considered the application. At that meeting, concerns were expressed about the nature and extent of the complaints received about the over-charging of customers. The Sub-Committee noted the suggested conditions; however, they remained concerned as to their effectiveness in resolving the issues. The Sub-Committee stated that they expected to see a significant reduction In complaints and concerns.
- The Sub-Committee resolved to renew the licence for a period of six months and impose the following conditions:
 - All management, bar staff and dancers working on the premises will
 receive documented training, which will be signed and dated. This
 training should include appropriate sales techniques and policies in
 place to prevent misleading or illegal sales of services. This should also
 make reference to drunkenness/ capacity of customers.
 - 2. All electronic/ card payments will be recorded in a consecutively numbered carbonated book and will include:
 - What the customer has paid for in as much detail as possible
 - All staff members involved in services/ transactions
 - The amount paid
 - The customer will be given the option to sign this record
 - The customer will be given a copy of this
 - These records will be clear and legible
 - This book will be made available to an authorised Officer on request.
 - 3. There will be sufficient measures in place to prevent dancers facilitating their own payment methods i.e. card terminals, internet banking.
 - 4. Dancers will not be allowed mobile phones in any performance areas.
 - 5. All card terminals will be at a fix point. There will be CCTV coverage to show the individual making the transaction.
 - 6. Interventions by a member of management will take place on all transactions above £100 to ensure that the customer has the capacity

- to pay for services.
- 7. A member of management should conduct random checks to ensure customers are not served when drunk.
- 8. Dancers price lists will be prominently displayed so that customers know how much services cost without ambiguity.
- 9. Members of staff/dancers must not assist customers in using cash machines.
- 10. Receipts of any card payments will be kept on the premises for at least one calendar month and be made available to an authorised Officer upon request.
- 5.5 The venue has now been operating with the revised conditions for a period of six months and the Sub-Committee is asked to consider renewing this licence until 30 October 2019, a year after the previous twelve-month licence expired.
- 5.6 Trading Standards has confirmed that they have received no further reports of overcharging. The police comments can be found at Appendix 6(a).
- 5.7 On 2 July 2019, the Licensing Authority received notification of a complaint lodged by a member of the public alleging that they had received second degree burns following a performance that took place at Eden One the previous weekend. This email can be found at Appendix 6(c). Due to the seriousness of the complaint, urgent enquiries were carried out and a meeting was held at Eden One where officers of the Licensing Authority, the Health and Safety Team and the Police Licensing Team met with the operators. At this meeting, a document entitled 'Performance Agreement' was obtained from the operators. This document can be found at Appendix 6(d). In addition, a Prohibition Notice was served on the operators. A copy of this can be found at Appendix 6(e). A request for CCTV footage was also made during this meeting.
- 5.8 At the Sub-Committee meeting on 2 July 2019, Members took the decision to defer the hearing of this application to allow sufficient time to investigate the complaint referred to at 5.7.
- 5.9 CCTV footage has subsequently been provided to the Licensing Authority for the date range 21-23 June and 28-30 June 2019. The purpose of obtaining CCTV footage was not only to examine evidence in relation to the complaint referred to above, but also to establish whether or not these events were common practice. The CCTV footage has been examined by officers of the Licensing Authority and a number of Licence conditions breaches have been established. Details of these breaches along with still images evidencing the same are contained within Appendix 6(f) labelled EDEN 1-21. Still images labelled EDEN 2-13 relate to the complaint referred to at paragraph 5.7. The CCTV recordings represented by images EDEN 1-21 provide evidence of breaches of standard conditions 16, 19, 20 and 23 as well as condition four of the additional

conditions. Footage of the alleged breaches can be shown at the meeting required.

- 6.1 Schedule 3 Local Government (Miscellaneous Provisions) Act 1982 (the Act), governs the issue of SEV licences.
- 6.2 The Act provides a number of grounds on which an application may be refused –

 (a) that the applicant is unsuitable to hold the licence by reason of having been convicted of an offence or for any other reason;
 - (b) that if the licence were to be granted, renewed or transferred the business to which it relates would be managed by or carried on for the benefit of a person, other than the applicant, who would be refused the grant, renewal or transfer of such a licence if he made the application himself;
 - (c) that the number of sex establishments in the relevant locality at the time the application is made is equal to or exceeds the number which the authority consider is appropriate for that locality;
 - (d) that the grant or renewal of the licence would be inappropriate, having regard
 - to the character of the relevant locality; or
 - to the use to which any premises in the vicinity are put; or

to the layout, character or condition of the premises, vehicle, vessel or stall in respect of which the application is made.
