APPLICATIONS TO LICENSE CINDERELLA HORSE-DRAWN HACKNEY CARRIAGES

1.0 Purpose of the report:

1.1 To consider four applications to license modified Horse-Drawn Hackney Carriages.

- 5.2 On the 25 March 2016, Paul Savage made an application to license a Cinderella Horse-Drawn Hackney Carriage.
- 5.3 On the 11 April 2016, Mr Gary Edwards made an application to license a Cinderella Horse-Drawn Hackney Carriage.
- 5.4 On the 14 April 2016, Joseph Davidson made an application to license a Cinderella Horse-Drawn Hackney Carriage.
- 5.5 On the 16 May 2016, Kristopher Simmons made an application to license a Cinderella Horse-Drawn Hackney Carriage.
- 5.6 The Sub-Committee decided at its meeting on the 23 September 2010 to permit any style carriage however any carriages that were not of the traditional style were required to be produced before the Sub-Committee for approval.
- 5.7 Since the 21 October 2010 up until the 21 July 2015 the Public Protection Sub-Committee has licensed 17 non-traditional style Horse-Drawn Hackney Carriages.
- 5.8 At the time of writing this report the carriages have not been inspected but are due to be inspected by the Council's approved inspector prior to the meeting. A verbal update on the results of the inspection will be provided to the Sub-Committee.
