# **New Off Street Parking Places**

The Borough of Blackpool (Off Street Parking Places) and (Revocations) Order 2020

### **1.0** Purpose of report:

1.1 To seek approval for officers to proceed with the statutory consultation, advertisement and making of a proposed Traffic Regulation Order to introduce a new off street parking place order to cover the new way to pay for the car park tickets as detailed within this report.

### 2.0 Recommendations(s):

- 2.1 To authorise the statutory consultation and advertisement of notice of the intention of the Council to make a Traffic Regulation Order under the Road Traffic Regulation Act 1984, the effect of which will be to implement a new payment system for all the council owned off street parking places and to revoke existing details relating to off street parking places as contained in The Borough of Blackpool (Off Street Parking Places) and (Revocations) order 2017. And to make a new order for off street parking that allows customers of the car parks to pay for their ticket either by phone, through an app, or by standard card payments. Tickets will be issued virtually through the app and by phone. Payments made by card will still receive a printed pay and display tickets which has to be displayed in the vehicle. All business and council staff who pay to park in the council owned car parks will now have virtual tickets, no tickets need to be displayed in the vehicle as the vehicle registration numbers will be held on a new parking system.
- 2.2 If no objections are received in relation to the proposals or if any objections are received and are subsequently withdrawn, to authorise the Head of Legal to make the Traffic Regulation Order.

### 5.0 Background Information

5.1 Parking services have decided to implement cashless parking. This means that on parking machines in council owned car parks there will now be a notice giving customers a telephone number to ring to pay for their car park ticket. There is also an app that people can download to pay for their car parking. The app is free for either IPhone or Android and just requires the person, once the app is downloaded, to register through the app. The ticket is payed for through this app. The app also keeps you informed of how much time you have left on your tickets and give customers the option of extending their stay by extending the current ticket at the relevant charges.

No physical ticket will be issued but the customers car registration plate will be added to the computer system, so as any Civil Enforcement Officer (CEO) patrolling the car park, can scan the cars registration plate with their hand held devices and it will display whether a ticket has been bought or not. The pay and display machines will still be able to issue physical tickets as well, but payment for these will be restricted to a debit or credit card. As well as virtual tickets for the general public, there will also be virtual permits for all business and staff who pay for a permit to park in the Council owned car parks. From now on no paper permit will be issued to display in a vehicle. Instead the cars registration plates will be held on a database and again as above the CEO's can scan registration plates to see if a virtual permit has been obtained. Car Parks Effected

### 6.0 Legal considerations:

6.1 Under Section 32 and 35 of the Road Traffic Regulation Act 1984, the Council in its capacity as traffic authority may make a traffic regulation order where it appears to the authority making the order that it is expedient to make it-

(a) may provide off-street parking places (whether above or below ground and whether or not consisting of or including buildings) together with means of entrance to and egress from them, or

(b) may by order authorise the use as a parking place of any part of a road within their area, not being a road the whole or part of the width of which is within Greater London.

As respects any parking place-

- (a) provided by a local authority under section 32 of this Act, or
- (b) provided under any letting or arrangements made by a local authority under section 33(4) of this Act,

the local authority, subject to Parts I to III of Schedule 9 to this Act, may by order make provision as to—

- (i) the use of the parking place, and in particular the vehicles or class of vehicles which may be entitled to use it,
- (ii) the conditions on which it may be used,
- (iii) the charges to be paid in connection with its use (where it is an offstreet one), and
- (iv) the removal from it of a vehicle left there in contravention of the order and the safe custody of the vehicle

And the power under paragraph (iii) to make provision as to the payment of charges shall include power to make provision requiring those charges, or any part of them, to be paid by means of the hire or purchase in advance, or the use, of parking devices in accordance with the order.

- 6.2 Under Section 122 of the Road Traffic Regulation Act 1984 the Council has a duty to exercise the functions conferred on it by the Road Traffic Regulation Act 1984 to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway.

consultation in accordance with the Road Traffic Regulation Act 1984 and the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996. As amended by The Traffic Orders Procedure (Coronavirus) (Amendment) (England) Regulations 2020
