**2020-30 EDUCATION VISION**

**1.0 Purpose of the report:**

1.1 To outline and present the 2020-30 Education Vision for Blackpool, a school lead strategy for improvement.

**2.0 Recommendation(s):**

2.1 That the 2020-30 Education Vision and the general direction of travel is accepted and adopted for a period until 30 September 2030 with an initial review after a period of two years, where the vision will be reviewed and re-presented.

**3.0 Reasons for recommendation(s):**

3.1 By accepting and supporting this vision, the Executive will be seeking to ensure improved outcomes for the children and young people of Blackpool and to ensure that the education system in Blackpool grows and adapts to be responsive to the changing needs of the children and communities that it serves.

The delivery of the vision will be through the existing Council services, reporting to existing boards such as the Children and Families Strategic Partnership Board and the Blackpool Education Improvement Board (previously Blackpool School Improvement Board).

#### **4.0** Other alternative options to be considered:

- 4.1 There are no other options to consider, other than focusing on continuing with the current systems and not recommending any change.

This paper is the result of a closed consultation exercise with stakeholders, who were asked to express opinions about the suggested plans and direction. This resulted in the final paper, presented here.

#### **5.0 Council priority:**

- 5.1 The relevant Council priority is: “Communities: Creating stronger communities and increasing resilience”.

#### **6.0 Background information**

- 6.1 Blackpool is an outlier in the North West and England in relation to outcomes at GCSE level. Blackpool has always had a very large Pupil Referral Unit and a very large percentage of pupils who are permanently excluded. Additionally, Blackpool has a high percentage of pupils educated in special schools (in Blackpool and out of borough.) Blackpool has a statistically higher than average percentage of children who have become NEET (not in employment, education or training). This vision results from a number of years of discussions about these educational trends, after listening carefully to all stakeholders and consulting upon the proposed changes.
- 6.2 Blackpool School Improvement Board (now Blackpool Education Improvement Board) has worked in partnership with Blackpool Opportunity Area Board to improve school standards and levels of attainment and progress in Blackpool. A significant plan to improve these outcomes and to boost social mobility is in place, funded by the Department for Education’s Opportunity Area programme. Those programmes are incorporated into this vision.
- 6.3 This strategy is, therefore, the next stage of an ambitious plan to ensure that Blackpool children and families have access to an outstanding education provision in Blackpool. The vision has been presented to Councillors of the Children’s and Young People’s Scrutiny Committee for questions and comments on 24 September 2020. That meeting suggested a number of changes notably a requirement to include reference to how the strategy would address the needs of children identified as gifted and talented, how targets relating to Early Help and Place Based Working would be measured and monitored, and the more general need to ensure that the strategy was

understandable to the public. In general, Members were very positive about the aspirational nature of the Strategy and subject to the above amendments supported the vision of the strategy. Work is already being undertaken to address these concerns and an updated strategy will be presented to the Executive. The Chairman of the Children and Young People's Scrutiny Committee, Councillor Jane Hugo, has been invited to the Executive meeting and will address the meeting.

- 6.4 The vision will be monitored internally with Children's services through the existing governance structure, reporting to the Children and Families Partnership and Blackpool Education Improvement Board and also through review by the relevant Scrutiny Committee.
- 6.5 The success of this vision will be measured through increased outcomes for children, at all stages of their education, incorporating attendance, exclusions, GCSE and A-Level equivalent outcomes and the numbers of children who are not in education, employment or training (NEET).
- 6.6 Consideration has been applied to possible re-structures of staff who work in existing provisions in the Primary SERF (Special Education Resource Facilities) and in the Council inclusions teams (within SEND and Educational Diversity (PRU)). Staff have been made aware of the possibilities and key HR staff are involved and have been fully briefed. The strategy at Appendix 2a, to the Executive report, includes the broad principles of rationalising the existing offer and that Council officers will consult with all stakeholders about any possible changes and impact. Any changes to service will be undertaken after further decisions (Published Officer, Cabinet Member or Executive) are made.

## **8.0 Financial considerations:**

- 8.1 A key aim of the vision and strategy is to reduce the forecast deficit position of the High Needs Block of the Dedicated Schools Grant. This will be reduced to a negligible level of deficit by 2025-6 financial year. It is considered this action, the deficit position will be well-over £5 million pound by 2025-6.
- 8.2 The financial position will continue to be monitored through the Schools Forum and the monthly Financial Performance Monitoring report presented to the Executive

**10.0 Risk management considerations**

10.1 If the vision and the resultant plans are not implemented, the stability of the school funding system and the future outcomes of children in Blackpool will be at risk. Blackpool would remain static as a town in terms of educational performance and provision. The High Needs Block element of the Dedicated Schools Grant would remain over-spent, reducing the available budget for all schools.

**11.0 Equalities considerations:**

11.1 Equalities Act 2010 applies in relation to the fair and effective provision of education for all and breaking down barriers to education in Blackpool schools.
