<u>Re: Parking concerns on Bryan Road, Whitley Avenue, Myrtle Avenue, Maple Avenue, Poplar Avenue,</u> <u>Elm Avenue, Olive Grove, Hazel Grove, Forest Gate, and Mere Road</u>

Last year we contacted you and asked for your opinion on a proposal to incorporate Olive Grove, Hazel Grove, Forest Gate, and Mere Road into the existing Bryan Road permit parking scheme. Analysis of the consultation results revealed that, the majority of respondents were in favour of the proposal. However councillors representing the area received a number of complaints from local businesses that the proposed scheme would have a detrimental effect on the shops, and the area as a whole as their customers would not be able to park for short periods of time.

The councillors have therefore asked us to look at a solution that is more favourable for everyone in the area.

Amended Permit Parking Scheme: In view of these concerns we have amended the scheme to include limited waiting. This means that the residents and their visitors displaying a valid permit will be able to park in the scheme for an unlimited period of time, however the customers of the local shops and business will only be permitted to park for a maximum of 3 hours between the hours of 9am to 5pm Monday to Saturday. For the avoidance of doubt the permit parking scheme will include Bryan Road, Whitley Avenue, Myrtle Avenue, Maple Avenue, Poplar Avenue, Elm Avenue, Olive Grove, Hazel Grove, Forest Gate, and Mere Road.

As part of the scheme we will review existing double yellow lines and where possible maximise the number of on street parking places.

Permits: As before, if the scheme is implemented, then all eligible applicants will have the opportunity to apply for 1 parking permit and 1 visitors permit, unless you have a driveway in which case you will only be able to apply for a visitors permit. The administration cost of each permit is currently £12.50 per year. With the purchase of a permit you will be able to park on any of the roads mentioned at the start of this letter.

Please Note. The possession of a parking permit does not guarantee a parking space.
