


Alley gate public spaces protection order (PSPO)

Review 2020 Summary Report

1. Executive Summary

Households associated with alley gate schemes in Blackpool were asked whether they wish to retain their current alley gate scheme as part of an alley gate public spaces protection order (PSPO) 2020 review of existing alley gates orders in Blackpool. This report contains responses from households, including responses where a review has been asked for or inferred and any general issues around alley gates.

Key findings:

- 47 respondents (14.7% of total responses) across 31 different schemes identified they would like a review of their alley gate scheme or inferred they might want a review to take place
- The wards in which the highest number of reviews were called or inferred for was Claremont (eight reviews), Squires Gate (five reviews) and Warbreck (five reviews)
- Bournemouth Road (five households ‘requesting’ a review), Back Lord Street 1 (four households ‘requesting’ a review) and Stanmore Avenue 1 (three households ‘requesting’ a review) were the schemes with the most requests for a review

2. Background

A letter and a questionnaire was hand delivered to over 17,000 households identified as being adjacent to an alley gate scheme, with an easy-read link to the questionnaire contained within the letter in order to submit online responses. A separate online link was available via the council's consultation and engagement page, for anyone who wished to respond to the consultation, although this led to eight duplicate submissions which were removed from the analysis.

The consultation ran for over six weeks from October to December 2020. **320 responses** were submitted across the consultation window.

Households were encouraged to consult with other households within their scheme if they wished to have their alley gate reviewed. However, consultation between households may have been limited, as Covid-19 restrictions on household mixing was re-introduced as the consultation began. Respondents were also asked to tick a box if they wished to have their alley gate scheme reviewed and asked to submit details of why they would like their scheme to be reviewed. However, many respondents ticked the box indicating they would like the scheme to be reviewed but then went on to make positive comments about the alley gate scheme in their area. Therefore, responses where a review has been judged to have been requested are through comments rather than the use of the tick box.

The following table outlines the number of responses made that could be identified by ward and the unique number of responses made by households by alley gate scheme.

3. Results


47 households (14.7% of total responses) were assessed to have called for a review or inferred that their household would like to see a review of their alley gate scheme which also includes the repositioning of their gates. Comments that indicate responses where a household would like a review and comments overall by scheme are shown in the supporting documents accompanying this report. A list of the number of responses that have called for a review or inferred that they would like to see a review of their alley gate scheme by scheme name is shown in Appendix 1.

Of the 47 responses where a review has been called for or inferred:

- 31 different schemes were identified across 16 wards
- The schemes where there were multiple households requesting a review were; Bournemouth Road (five households ‘requesting’ a review), Back Lord Street 1 (four households ‘requesting’ a review), Stanmore Avenue 1 (three households ‘requesting’ a review) and across Bromley Close 1 &2, Knowle Avenue 5 and St Anthony’s Place, two households apiece requested or inferred they wanted a review of their alley gate scheme
- Around half of households who requested or inferred they would like a review (23 households) had lived at their property for more than 10 years. Eight respondents had lived at their property between five to 10 years, seven respondents for three to five years and a further seven respondents who had lived at their property from one to three years. Two households requesting a review had lived at their property for less than 12 months

The following table highlights number of households requesting or inferring they would like a review of their alley gate scheme by ward:

Other issues highlighted

218 comments highlighted several different issues/themes from household respondents:

- 78 responses mentioned fly tipping and cleaning maintenance issues associated with their alley gate scheme
- 63 responses mentioned keys as part of their response. Either they didn't have one, people who not authorised to have a key had one and that they unhappy to have to pay for one
- 55 responses detailed a wide range of anti-social behaviour incidents occurring in their alley way
- 28 responses stated that the gates were constantly left open and being misused by other residents
- 26 responses highlighted that the alley gates were often obstructed, including people parking in front of them
- 10 responses specifically highlighted drug use/drug dealing occurring in the alley way
- Other responses highlighted issues with; the noise of the gates bouncing against their properties, damage to the walls where the gates were attached and access issues for residents with a disability

B00052	Acton Road	More than 10 years	<p>As a resident which shares the alley, I feel the gated alley has caused nothing but anti-social behaviour in the time I've lived here. A resident from Rectory Road was using my garden as a way to cut through the alley to get home. Another resident was using it as their own personal private kennel for a particularly aggressive dog. And of recent one of the residents has claimed the alley as their own personal back garden by clocking it off from all who live here by putting up a fence from the centre and the front. They have built a child's play area with a high climbing frame and fence that overlooks my own fences. This is causing friction and I have contacted the council and was told nothing could be done. It is for this reason I would like a review of the gated alley scheme in my area.</p>
B00421	Argyll Road	More than 10 years	<p>Two of the three gates at the rear of my property are almost always left open. It is therefore pointless to keep them. I objected to their installation when they were first proposed.</p>
B00957	Back Lord Street 1	More than 10 years	<p>The alley gate at the back Lord St is situated halfway along the alley, affording no protection whatsoever to the properties between the gate and the end of the alley. This encourages fly tipping, drug dealing and various unsavoury, unsocial behaviours. The gate should be resituated to the end of the alley - see below [drawing of the roads and alley way indicating where the gate is and where it should be moved to] This gate should be moved to here.</p>
B00964	Back Lord Street 1	More than 10 years	<p>The place between the existing gates at the back of Lord St and Bank St is a haven for fly tipping, drug dealing, urinating etc. Generally a quiet cove to commit crime. There are 6 residential houses on one side of the alley and 2 hotels on the other side. We could all benefit and feel safer by extending the original gates to the end of the alley. I don't have to comment that street crime, I am sure, will increase during our COVID 19 experience. [Redaction]</p>
B00962	Back Lord Street 1	More than 10 years	<p>To have the alley gates cover the whole alley - Cocker Street to Bond Street. The whole of back lord street needs gating not stopping half way like it does the un gated is fly tip hotspot</p>

B00956	Back Lord Street 1	More than 10 years	The present alley gate at the rear of our property do not extend to the entire length of the alley. Because of this the alley at the rear of our and our neighbours has become an area that encourages fly tipping and anti-social behaviour. We often have to clear away from our back gate drug paraphernalia and human waste. These problems that we and our neighbours encounter weekly if not daily, would be eradicated if the gates were moved from the present position (halfway along the alley) to the end of the alley. Can you please keep us informed as to any decisions made. With thanks.
B02108	Bournemouth Road	Between 3 years and 5 years	We believe an alley gate would make our properties more secure. We often see people hanging around the alley that just shouldn't be there, doing goodness knows what! Broken glass, rubbish etc. left behind. My family would feel better protected for sure if we had an alley gate that only residential people could access.
B02097	Bournemouth Road	Between 5 years and 10 years	"There is one end of the alley still without a gate. I would like this gated to keep the alley more secure (Eastbourne Road end). We have experienced fly tipping at our back gate and also in our grey bin, after it has been emptied. Recently hired a skip, this was used by a fly tipper. Young people congregating smoking cannabis Dog walkers leaving dog mess, also bags getting disposed of in my bin, when emptied on bin day. If the alley was fully gated, I would feel more secure in my home at night. The alley would then be kept better and looked after by myself and neighbours. Presently, it is an eyesore. The alley is only gated at one end, we would like to request a gate to be fitted (Eastbourne Road end) to keep the alley more secure. Current problems are: fly tipping, dog mess, youths congregating smoking cannabis, we are also concerned that we are vulnerable to break ins from the alley. If the alley was fully secured, the local residents, like ourselves, would be encouraged to make the alley a nicer place, keep it clean and tidy, maybe plant some flowers. Presently, it is an eyesore."
B02078	Bournemouth Road	Between 5 years and 10 years	My query is around the Bournemouth Road scheme and limitations of the current solution. The two gates at the tip of the street from Bournemouth Road and Harrowside nearest Lytham Road end are useful but would be better if they were actually closed when they should be. My issue is the lack of a gate on the intersection with Eastbourne Road. You sent a letter out in August 2018 asking for opinions in adding a gate there but failed to advise of the outcome. I had provided evidence at the time how frequently this rear alleyway is used as a fly tipping area but never heard back despite requests. So in short, yes to the gates

B02072	Bournemouth Road	Between 5 years and 10 years	The alley in question is the one which sits behind the houses on Bournemouth rd and Harrowside. The gates were installed at the East end of the alley but never at the West end of the alley. I believe there was a company by a resident at that end and has never been resolved. I have spoken with many of the Bournemouth residents and all support putting the gates up and finishing the job. Councillors have failed to update or address the situation. The alley is used on a weekly basis to dump waste. Most nights groups of youngsters smoking cannabis. Seems such a waste to see gates put at one end and then not the other completely defeats the object.
B02082	Bournemouth Road	More than 10 years	[Scan of attached document shared via email] 11.11.20 Please see attached copy of my previous correspondence. I believe Mr [Redaction] is referring to the same person as I did only he called it a "medical issue" where as we were told it was one of safety when the woman brought home the takings of her business. I am sure your records already show how many residents wanted this gating, crime seems to be outweighed by "other - medical or not" issues. It seems to me that the residents are being made to wait and have been for over 5 years. Surely there is a limit to the time given to one resident to try to remedy their problems - whatever that is. I understand the gates are already made and know for a fact that Mrs [Redaction] have repeatedly followed up on this but nothing is ever done.
B02390	Bromley Close 1&2	Between 5 years and 10 years	Firstly I would like to point out that although I have owned number [Redaction] s, I previously lived at number 23 Bromley Close for 20 years whilst growing up- this giving me a large insight of what the street was like before the gate was installed at the top end. What was once a quiet, secluded and safe enclosed street is now a hazardous cut through. There are several negative implications as to why the scheme needs to be reviewed, these are as follows: Increased footfall at the front of the property which impacts on the following areas- Littering- There is a constant flow of litter so much so I have invested in litter pickers- lately there are discarded face masks which are a serious Covid health risk. Dog fouling- Currently there are two piles of dog waste on the footpath outside the front of my home and one pile at the back-this is a constant health risk. My neighbour installed signs to pick it up which are ignored. Some dog walkers allow their dogs to be off the lead and rampage

			through the gardens without fences and this sends my dogs hysterical. Disturbances- Constant steady flow of commuters that have caught the train or buses and cutting through, youths being loud which can go on till late at night. Drunks cutting through being loud and argumentative late at night. Passers-by purposely provoking my dogs to bark- they literally stop outside my house and shout at them to make them bark. Cyclists- They speed so fast up and down whilst cutting through and have frequently been a hazard to children playing out and then abusive when asked to slow down. Anti-social behaviour/Vandalism- Of flowers, bird feeders, stolen outdoor toys such as scooters and balls. Trespassing- People walking across my lawn as I do not have a fence. That is my property. Fast food delivery mopeds driving up and down as a shortcut on the front footpath- this is illegal and lethal!! I can no longer walk around 'the block'. I do not have a gate key and believe it a cheek to have to purchase one to walk down my own street.
B02388	Bromley Close 1&2	More than 10 years	These gates have actually led to an increase in crime at the other end of the street as people walk the long way around. Motorbikes have been seen on the pavement and cars have had their windows broke without good reason by passers-by. Drunks often make excessive noise when walking around - though less so because of the pandemic. These gates may have improved the lives of a few but they've made life worse for many. Take them down.
B03942	Collingwood Place	More than 10 years	The main reason is that these don't seem to be responsible for the alley since the gates were installed. Being disabled, I cannot clear it up (the weeds etc.) They alley is not clear if any workmen need to get to my house. I am unable to open the gate as it is chained. If the scheme was reviewed a lot of things like this will come to light.
B05023	Dean Street 1	More than 10 years	They were unwanted in the first place. You kept asking and asking until enough people got sick of saying no so ignored it. You then installed them and refused to give us even 1 free key. Toxic money making scheme is what this was. Please remove them.
B06422	Ferndale Avenue	Between 5 years and 10 years	Our old alley gate was stolen a few years ago. I contacted the council but was told we never had one which isn't true! There have been thefts from back gardens including washing and children's bikes

I have spoken to the neighbours whose back gardens back onto the alley way and they have said they would like an alley gate as one of them had their shed broken into and a bike taken. B06583	Francis Street	Between 5 years and 10 years	[in response to Q3 - both "less than 12 months" and "between 5 years and 10 years" were ticked] The alley gates are useful for the reasons given in your letter. The only suggestion is: the larger gate on Francis Street needs to be moved forward so there would be an inlet where people often urinate late at night and leave rubbish there.
B08369	Highfield Road	More than 10 years	To whom it may concern I would like to bring to your attention that I am an 82 year old stroke victim with paralysis to the right hand side of my body as a result of my condition. I enter and exit my house via the alley gate, if the gate is closed it can cause me great difficulty. The gate has been the source of great hardship at times for me, leaving me at the mercy of the kindness of other to accommodate my situation. I would like the gates removed. [signature]
B08551	Holmfield Road 4	Less than 12 months	2 alley gates fitted. But access can still be granted as no gates on the other 2 entrances - Cliffs Hotel - both sides. Please fit.
B08655	Howard Street	Between 1 year and 3 years	Since moving to this address: the neighbours never close the gate. The gated area does not stop access to my back gate as the alley gate was fitted to the far edge of the back of my house. So it does not stop rubbish being dumped. I have contacted the Council several times regarding fly tipping. None of my neighbours have, as it is normally one of them that has fly tipped. There are 3 alley gates, none of which are used as cars are parked in the alley which are used day and night. The gates may as well go and save the cost of maintenance. Also there are workshops and the tenants/owners do not close the gates.
B09405	Knowle Avenue 5	More than 10 years	The alley gates have been a problem since they were installed. The lock has been broken on numerous occasions & it is usually 6 weeks until is fixed. Whilst there is another alley gate to use, this is not always possible to use as it can be blocked by cars parked in the alley (neither the police or the council seem to be able to help

In your letter you have requested we go round to our neighbours to discuss. However, due to the lockdown you will understand that has been impossible to do.</p>
B09406	Knowle Avenue 5	More than 10 years	<p>This scheme was implemented against mine and my neighbours' wishes. I invested thousands of pounds having a new garage built complete with automatic doors, having checked with the Council that Alley gates would not be fitted, to be presented a short time later with the then local councillors scheme to reintroduce the scheme and fit gates against our wishes. The gates were fitted to prevent anti-social behaviour, mainly fly tipping, and obstruction. They have not prevented this. As we highlighted at the time most of the issues were from the numerous flats on Warbreck Drive, with the contents of vacant flats being dumped in the alley, this continues, as does the constant parking of vehicles in the alley, blocking the same. The alley gate lock suffers regular faults which take up to weeks to fix, this effectively bars the use of our garages (yes there is another gate but that is no use if a vehicle has been left in the alley) When we were informed the gates would be fitted despite our objections the Council did have a meeting with us, at which I requested the gate at the rear of my property be fitted to the East side of the alley way to avoid restrictions on my entry/exit to my garage, this was agreed too, however when fitted it was to the west side. Apart from the obstruction to my access this has led to another problem, the prevailing wind and/or the children playing in the school yard dislodge the gate when in the open position allowing the gate to swing across the alley. These issues are a heightened issue with my neighbour who has limited mobility. I have not canvassed other residents as requested in the Council letter due to the Covid 19 restrictions. The alley gates restricts my free access to my property and I would like them removed.</p>
B09831	Leeds Road 3	More than 10 years	<p>The alley gates are placed well inside the alley in front of our back gate. The car park for Ethos hairdressers is opposite with a low wall between the car park and the small alley to the back entrance to the post office and our upstairs flat. They alley gates so deter vehicles from access but we regularly have people jumping over the wall. We have spoken to the proprietors of</p>

b11730	Norcliffe Road 1	More than 10 years	We wish our alley gating scheme to be reviewed, we have spoken to our neighbour as the present positioning of the gates does not tackle crime and anti-social behaviour. Our caravan was broken into and we have rung the council to remove numerous fly tipping. We would like the alley gates to be repositioned at the entrance to the alley which would then protect the rear of 4 businesses and 2 residential properties.
B11791	Northumberland Avenue	More than 10 years	These gates are a waste of time, they are constantly vandalised with locks broken off rendering the gates useless. They have not made any difference to the security of our properties and in our opinions are a total waste of money.
B12546	Pennystone Road	Between 1 year and 3 years	I own a block of 10 holiday flats and have 10 car parks and 1 garage in the back yard. For my business the gates are a big problem. When my neighbours close the gates at night, my holiday guests are locked in with their cars and wake me up at night or early in the morning. They often leave me bad reviews when they are locked in and it is not easy to communicate to them where the key can be found because 70% of my guests stay only for one or two nights and sometimes [illegible] at night. they can always self-check in with my smart locks but then the gates are closed they leave no [illegible] I would be pleased to remove the gates then I would have no more sleepless nights and no more bad reviews. The only alternative for me could be to fit smart locks at the gates. I have a safe backyard with 3 CCTV cameras and [illegible]
B12585	Penrose Avenue 3	More than 10 years	I am sorry but I still have to question the logic of only having a gate at one end of the alleys behind our properties when the other access entrance remains open to all. Of the eleven or so proprieties who have lawful access to these alleyways, access to

B13871	Rosedale Avenue	More than 10 years	[Redaction] Please could you move alley gate back to protect: 5 Sunningdale Ave, 3 Sunningdale Ave, 7 Sunningdale Ave. Gates were incorrectly installed due to a fence collapse on first property on Ryldon Place, which has now been replaced. The gate currently only protects No.1 Sunningdale Ave, leaving the remaining properties vulnerable. [Signature]
B14002	Rydal Avenue	Between 1 year and 3 years	I would like the alley gate scheme to be reviewed as it is not tackling crime and anti-social behaviour in this area. The gates are always left open by the council for example when the bins/bags are taken every week. They should close the gates as there is a sign on the gate. The gates are constantly being vandalised by people in the area and the gates (lock) needs to be fixed. The council does not care and should not be encouraging people to get away with it. They need to put CCTV near the alley gates to deter crime and constant fly tipping at the back of the houses. I live near to these gates and I can hear the whole house shake when someone is playing or forcing the gate open. I feel for the people are crazy and don't care in this area. I have paid for the key to open the gates and feel it is a waste of my money if all the time the gates are damaged and someone is in/out and leaves them on purpose open. Most of the people are walking their dogs in/out and people coming in with a car/van and putting their furniture etc. at the back or near the alley gates. B14505	Seymour Road	More than 10 years	Gates have been erected at Maudland Road through to Seymour Road, South Shore, Blackpool, it is understood the gates were for the security of the rear of St Heliers Road. The placement of the gates has restricted access to and from Bancroft park and the South Shore area as well as easier access to bus routes on Lytham Road and the main gate of Blackpool Gateway Academy. Repositioning of the gates to ensure continued security for St Heliers Road and static bollards on the easement between Seymour and St Heliers would allow access to shops and bus routes for our elderly and disabled residents.

B14779	Somerset Avenue 1	Between 1 year and 3 years	The alley gate next to [Redaction] Somerset is too far back. I believe the owners requested this because they have a garage (with garage doors) down that alley. My issue is that [Redaction] park their extra cars in the alley NOT in their garage. This is a fire hazard and also restricts access to all of the same block, half owned by No 16 (as in split down the middle) according to the land registry. Yet the alley is blocked every day by cars without parking permits. I would like the gate brought forward in line with the gate at No 1 Somerset. Many thanks. Not only this but anybody can walk down this alley and get into any back garden by "wall hopping", thus making the current gate position by No 16 useless.
B14915	St Albans Road 1	Between 1 year and 3 years	The alley gate scheme There is still problems with access to the alley due to overgrown vegetation. Also old cars which are left, abandoned in the alley for over 18 months now. But yes, the scheme needs a review.
B14997	St Anthony's Place	Between 3 years and 5 years	One gate needs returning. Non-residents are taking most of parking places, has become a meeting place for anti-social behaviour and is now an unsafe area to be in. One way driving system is not being acknowledged. Cars speeding in all directions - accident waiting to happen.
B14981	St Anthony's Place	Between 3 years and 5 years	The gate between 8 and 10 Cecil Street was removed and the gate that allows access to the same are from St Anthony's Place is also locked open. Nobody is sure why this is the case but it is thought to be because of the car parking for [Redaction] However, the levelled of anti-social behaviour and crime that takes place as a result of days access to this are should far outweigh the minor inconvenience of a small number of car owners that use the parking area. Some residents are hesitant to bring back the gates but this seems to be more about how the scheme is administered rather than a reluctance to have it in place. For example people have cited the difficult in accusing and the cost of purchasing keys.

The other thing we had a big problem with was the back of the ONE STOP shop. They always used to leave their gate open and men used to come after midnight at about 2am to go through their bins to take any food that had been put out that was short date. They used to arrive on bikes with lights on a headband so they could see into the bags, load up their bikes with food and then leave. They used to rip open bags in the alleyway and packaging and papers were all over the alley and had to be cleared daily. After several complaints to One Stop, they started donating most of their short dated food to food banks and it is now collected in the evening and has stopped this although we still get the odd visitor after midnight checking the bins.
