# THE BLACKPOOL BOROUGH COUNCIL, SQUIRES GATE WARD (RESTRICTED ACCESS) PUBLIC SPACE PROTECTION ORDER 2021

#### **1.0** Purpose of the report:

1.1 To agree the Blackpool Borough Council, Squires Gate Ward (Restricted Access) Public Space Protection Order 2021 (PSPO) for a period of three years from 22 December 2021.

#### 2.0 Recommendation(s):

- 2.1 To approve the PSPO attached at Appendix 1a.
- 2.2 To delegate to the Head of Corporate Legal, authority to seal and advertise the order.

#### 3.0 Reasons for recommendation(s):

- 3.1 Historically, Gating Orders authorised the installation of alley gates. The Anti-social Behaviour, Crime and Policing Act 2014 repealed the alley gate legislation. Alley gates must now be authorised by a PSPO or removed.
- 3.2a Is the recommendation contrary to a plan or strategy adopted or No approved by the Council?
- 3.2b Is the recommendation in accordance with the Council's approved Yes budget?
- 3.3 Other alternative options to be considered:

If no order is made, these alley gates must be removed.

# 4.0 Council Priority:

- 4.1 The relevant Council Priority is
  - "Communities: Creating stronger communities and increasing resilience"

### 5.0 Background Information

- 5.1 Historically Alley Gate orders under the Highways Act 1980 permitted the installation of gates used to restrict public access to alleyways where anti-social behaviour and/or crime existed.
- 5.2 The Anti-social Behaviour Crime and Policing Act 2014 converted existing alley gate orders automatically into Public Space Protection Orders. These orders are now due for renewal.
- 5.3 Due to the number of alley gates installed within the Borough, rather than creating a PSPO for each alley gate installation, every Ward will have a PSPO listing all of the alley gates in that particular area. This will make it easier for residents to search for details of alley gates near to where they live.
- 5.4 Consultation with residents took place in December 2020. There were no objections to the proposed order. The majority of the responses were positive towards retaining the gates. Some comments requested a review of the gates, for example, considering a relocation of the gate, or the installation of additional gates to provide further security. Some residents did request removal of gates but this was a minority viewpoint.
- 5.5 There are no new alley gates. All of the alley gates listed in the schedule to the order attached were installed a number of years ago under the authority of a gating order.
- 5.6 If there is a need in the future to install/remove gates, the PSPO can be varied as necessary at that time.
