# BLACKPOOL MUSEUM PROJECT- INSTRUCTION TO LEGAL SERVICES TO PREPARE NEGOTIATING DRAFTS OF LEGAL AGREEMENTS BETWEEN BLACKPOOL COUNCIL AND THE BLACKPOOL HERITAGE AND MUSEUM TRUST

#### **1.0** Purpose of report:

1.1 To formally instruct Legal Services to prepare negotiating drafts of a suite of legal agreements between Blackpool Council and the Blackpool Heritage and Museum Trust. This will ensure and provide contractual arrangements, which will articulate the relationship between the Council and the Trust, since it enables the service to be specified with appropriate professional standards.

#### 5.0 Background Information

- 5.1 As part of the Showtown museum project a new charitable company has been set up called the Blackpool Heritage and Museum Trust. It will be responsible for the operation of the Showtown museum and the Blackpool Heritage Service in the longer term.
- 5.2 In order to ensure that the relationship between the two organisations is on a secure legal basis and there is clarity on both sides in terms of what is expected in connection with services to be provided a suite of legal agreements are required. This includes amongst other documents, an under-lease, a business transfer agreement, a partnership agreement and a collections agreement. There will also be a requirement for a form of agreement(s) associated with the Trust's occupation of space within the Central Library and the continued storage of the Illumination collection of historic artefacts at Lightworks.
- 5.3 It is proposed that Blackpool Council's Legal Services begins this process by the production of initial drafts which can form the basis of negotiation between the two parties. It is proposed that this takes place from now into the autumn, with a view to getting them sign off late 2022/early 2023.
- 5.4 It is further proposed that a member of Blackpool Council's Legal Services is appointed to negotiate on behalf of the Trust. Professional conduct rules will be operated effectively with internal measure adopted to ensure that information does not leak to people in another part of the same team and to protect client confidentiality, as is done with other Council arms' length companies.
