(ii)£150 as a ward councillor funding donation to Donna's Dream House towards purchasing and planting 100 snowdrop bulbs in Stanley Park as a remembrance for families to visit.
- 6.3 Councillor Farrell of Ingthorpe Ward has requested:  
(i)£27.26 as a ward councillor funding donation to Kilmory Community Centre Lunch Club towards the purchase of food items to hold a Coronation Lunch for the group.  
(ii)£147.59 as a ward councillor funding donation to Blackpool Coastal Housing for the purchase a Boccia Set to be using exclusively at the Community Centres within Ingthorpe Ward.
