STANLEY PARK ATHLETICS ARENA

5.0 Background Information

- 5.1 Stanley Park athletics track has reached the end of its life and England Athletics have advised that it will not be able to host regional or national competitions from 2023 without significant investment, particularly in the track surface.
- 5.2 The service collaboratively developed a specification with England Athletics,
 Blackpool Wyre & Fylde Athletics Club and procurement to ensure the project met
 the needs of regular users and was suitable for hosting regional and national events.
- 5.3 A number of bids were evaluated and a successful contractor appointed.
- 5.4 The total cost of the project is £307,000. £305,000 has been secured within existing council budget and funding of £5,000 has been secured from England Atheltics.
- If approved, the work will be completed by the end of 2022 enabling the new track to be available ready for the 2023 athletics season.
