BACKGROUND CARE AND SUPPORT WITHIN EXTRA CARE HOUSING SCHEMES

1.0 Purpose of the report:

1.1 To approve the appointment of I Care (GB) Ltd as the contractor for the provision of background care and support within Elk and Tulloch extra care housing schemes, following completion of a tender exercise.

2.0 Recommendation(s):

2.1 To approve the appointment of I Care (GB) Ltd [Blackpool], as the contractor for the provision of background care and support within extra care housing schemes. The contract is for a period of five years with the option to extend for a further five (2+2+1) years subject to budget and satisfactory review.

3.0 Reasons for recommendation(s):

- 3.1 A formal tendering exercise (above the threshold for public procurement regulations) was undertaken during December 2022 – March 2023 to select a contractor to provide background care and support. The Council invited tenders through its e-tendering portal (The Chest), in a single stage process (Open Tender).
- 3.2 92 suppliers registered an interest and 9 submitted a compliant tender response. After the evaluation I Care (GB) Ltd provided the best overall tender for the requirement and it is the Council's intention to enter into a formal agreement.

- 5.1 Blackpool Council works in partnership with Great Places Housing Association to provide two Extra Care Housing Schemes in Blackpool: Tulloch Court, Cherry Tree Road and Elk View Court, Ashfield Road. Great Places is the Landlord and Blackpool Council commissions the care provision within these schemes.
- 5.2 Extra Care Housing is available for people over the age of 55 years who have a care or support need which is affecting their ability to live independently. The care element provided in these schemes is generic, and will be available to all residents within them including: frail elderly, mental health, sensory disability, substance-misuse related needs.
- 5.3 Both schemes have self-contained rental apartments and communal facilities. The contract with the current provider is coming to an end and we wish to appoint a care provider to provide background care during the day time and a nightly sleep in at each scheme.
- 5.4 Background care and support staff will be on site 24 hours a day, 7 days a week in case of an emergency and to supply ongoing background care such as welfare checks.
