PROGRESS ON OCEAN RECOVERY

1.0 Purpose of the report:

- To provide a basis for the Committee to consider the actions to date for the delivery of the Council's pledge for Ocean Recovery as set out in the report to scrutiny on 5 December 2022.
- 1.2 This report will provide a brief summary of the outline objectives (themes) to date that have been developed in Partnership and the draft action plan is appended to this report.
- 1.3 Members are asked to note that the action plan is still in its development stage (with Partners) in some areas.

5.0 Council Priority:

6.0 Background Information

- 6.1 Following the declaration for Ocean recovery in December 2022 at the the Tourism, Economy and Resources Scrutiny Committee, it was agreed that an action plan would be developed to address the challenges faced in respect of ocean recovery and to provide a report relating to progress on ocean recovery at a future Scrutiny Committee.
- 6.2 In order to achieve an action plan for ocean recovery, the Council hosted an Ocean Recovery Workshop with Partners to help inform and take ownership of actions in the plan. External Partners at the workshop included the Wildlife Trust, Liverpool and Lancaster University, United Utilities, Environment Agency, Centre for Innovation Excellence in Livestock (CIEL), Sea life Centre, Left Coast, Ocean Generation, West Lancashire County Council, Wyre Council, Fylde Council, NHS. In respect of internal participation, there was representation across all Directorates of the Council.
- 6.3 The action plan provides details of the work to date and recognises that there is more work to do with partners to achieve our objectives of ocean recovery.

6.4 **Objectives**

6.5 Following the workshop in October 2023 objectives have been identified and grouped into eight themes (described below) to enable ocean recovery.

The workshop identified that there were some challenges to achieving the objectives and as a result, the action plan is being developed in Partnership to establish if the challenges can be overcome.

Theme 1 Health and wellbeing through utilization of blue spaces, Decrease health and wellbeing vulnerability associated with seaside towns through boosting access to positive benefits provided by blue recovery.

- 6.7 Theme 2 Sustainable blue economy, tourism and coastal regeneration, increase opportunity for building blue skills, using ocean recovery to increase employment and reduce deprivation.
- Theme 3 Education and engagement to grow ocean literacy and marine citizenship in the Blackpool, including ensuring All pupils are given the opportunity to have a first-hand experience of the ocean before leaving primary school striving to include home-schooled children and promote sustainable and equitable access to the ocean through physical and digital experiences for all residents.
- 6.9 Theme 4 Coast Protection and Climate Change to increase resilience to climate change impacts caused by proximity to the ocean through innovative solutions including impact on bathing waters.
- 6.10 Theme 5 Biodiversity protection and restoration increase the health of blue habitats in and around Blackpool in relation to the green and blue infrastructure strategy.
- 6.11 Theme 6 waste and pollution reduction to decrease inland pollution and decrease single use plastics impacts
- 6.12 Theme 7 Research and development to embed ocean based solutions as part of the Councils' operations and net zero 2030 approach
- 6.13 Theme 8 Collaboration with partners locally and Across the North West increase opportunity to on habitat management and increase awareness and appreciation of our North West Coastline and its assets.
