5.0 Background Information

- 5.1 The present RE network involves all primary schools, secondary academies and special schools. Usually 13 primary schools, 3 secondary schools and two special schools attend regularly. Its remit is to collaborate on Religious Education planning and assessment, develop links across schools, liaise with NATRE, SACRE and share good practice. Notes from the sessions are shared on the Blackpool Schools Partnership website and the sessions are chaired by Rebecca Binns (Highfield School). Its main aim is to raise the standards of Religious Education across the family of schools.
- 5.2 Currently within Year 10 in Secondary Academies 93 students were entered for the AQA GCSE RE, 392 for the Edexcel GCSE Religious Education and 356 for the Welch Board Religious Education. All schools cover Religious Education in Key Stage 3 and will conduct an act of worship. In primary all schools cover an act of worship. For 2017 in Secondary schools Religious Education will be part of the 'basket' of qualifications in the third sector of Progress 8.
