5.1 The Feel Good Factory has been operating successfully within Palatine Leisure Centre for over 10 years. There are currently over 440 active members who attend on a regular basis. The new and improved equipment will make the customer journey more efficient and easier for them to monitor their progress. The Feel Good Factory is a suite of power assisted equipment which attracts members who would not attend a traditional Gym, but feel comfortable in this less 'intimidating' environment. Pre-pandemic the facility was regularly hosting over 35,000 visits per year, for both leisure centre members and exercise referral members.

The equipment is a range of power assisted machines which provides an option for low impact exercise in a sociable setting for those who are looking to improve their mobility, strength and balance, lose weight and manage their underlying health conditions. Creating an opportunity for social interactions which reduces social isolation and loneliness.

We have had Shapemaster equipment installed at Palatine for over 10 years, it is very popular and well used facility. Active Blackpool have Shapemaster equipment installed at Moor Park Health & Leisure Centre. Active Blackpool have a positive relationship with colleagues at Shapemaster. Shapemaster recently visited Blackpool to talk us through some new innovative technology they are looking to introduce to improve the member journey, they are willing to work alongside Blackpool Council to provide a service that works best for our audience. There is no other provider in the market which could offer a similar product for this target audience.

The value of the project is £114,000.
